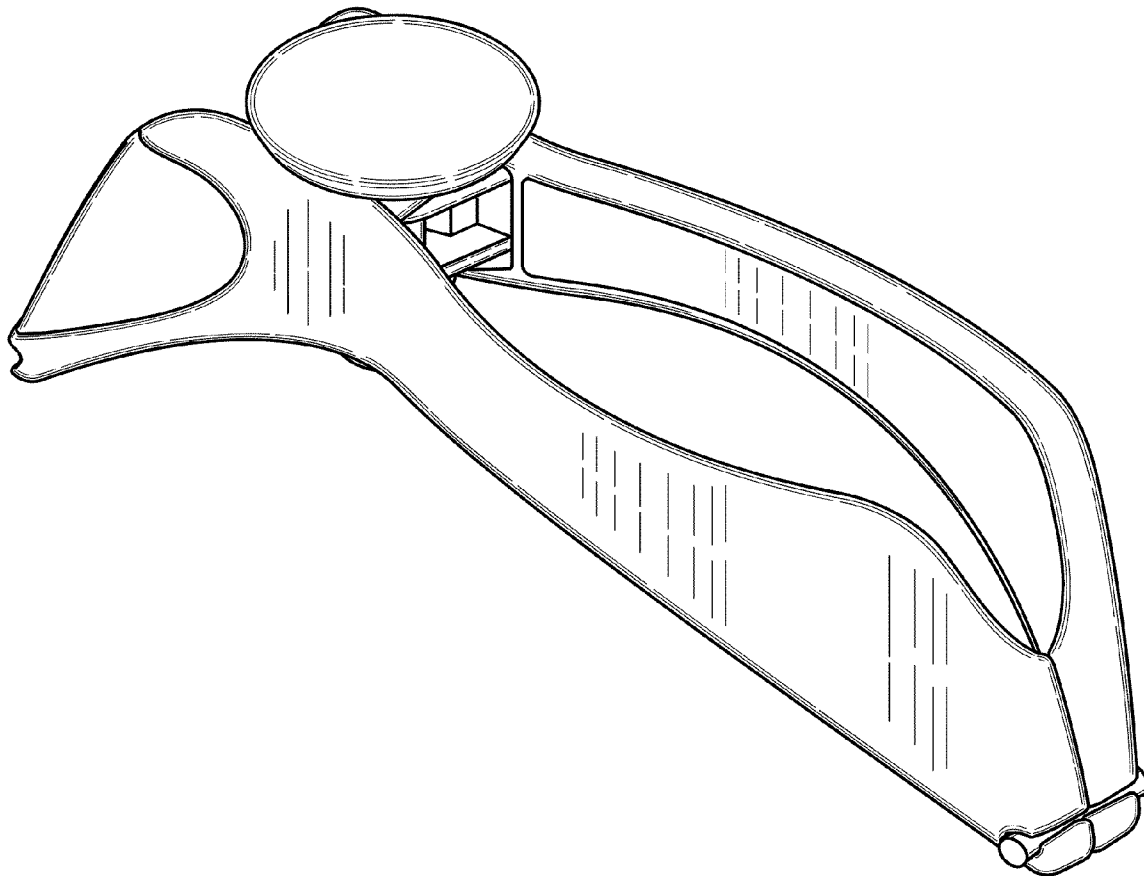
(57) **CLAIM**

I claim, the ornamental design for an appliance for hair removal, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of an appliance for hair removal, showing my new design;

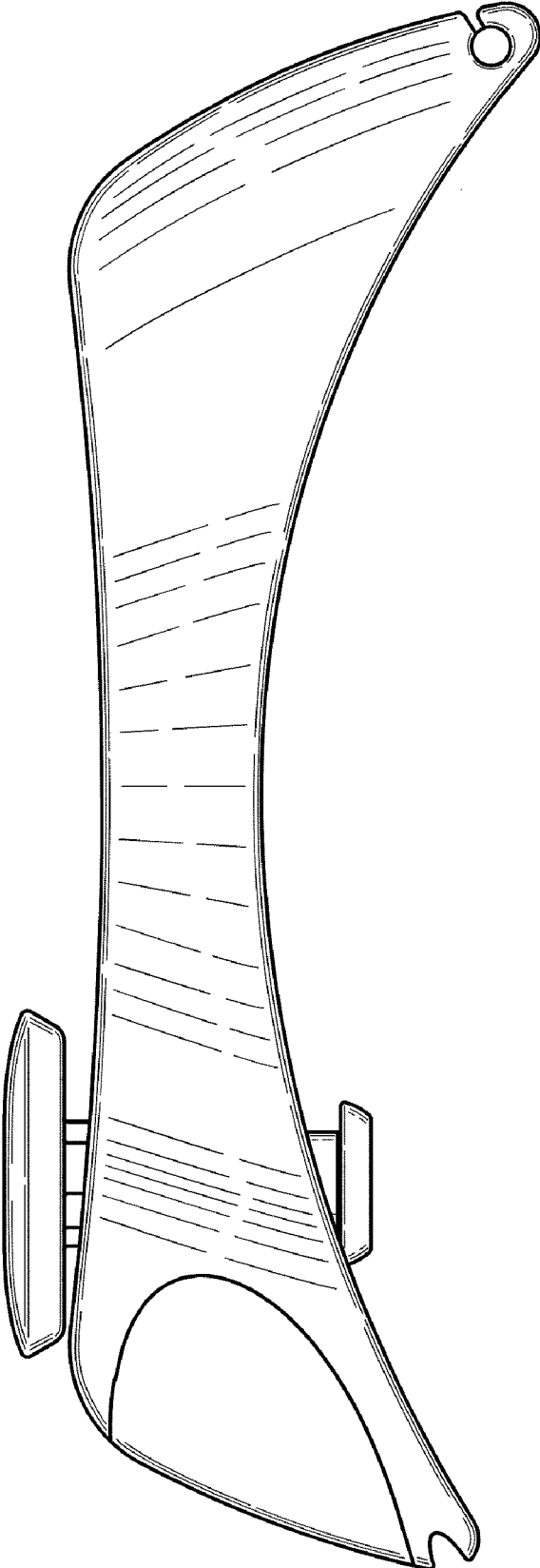

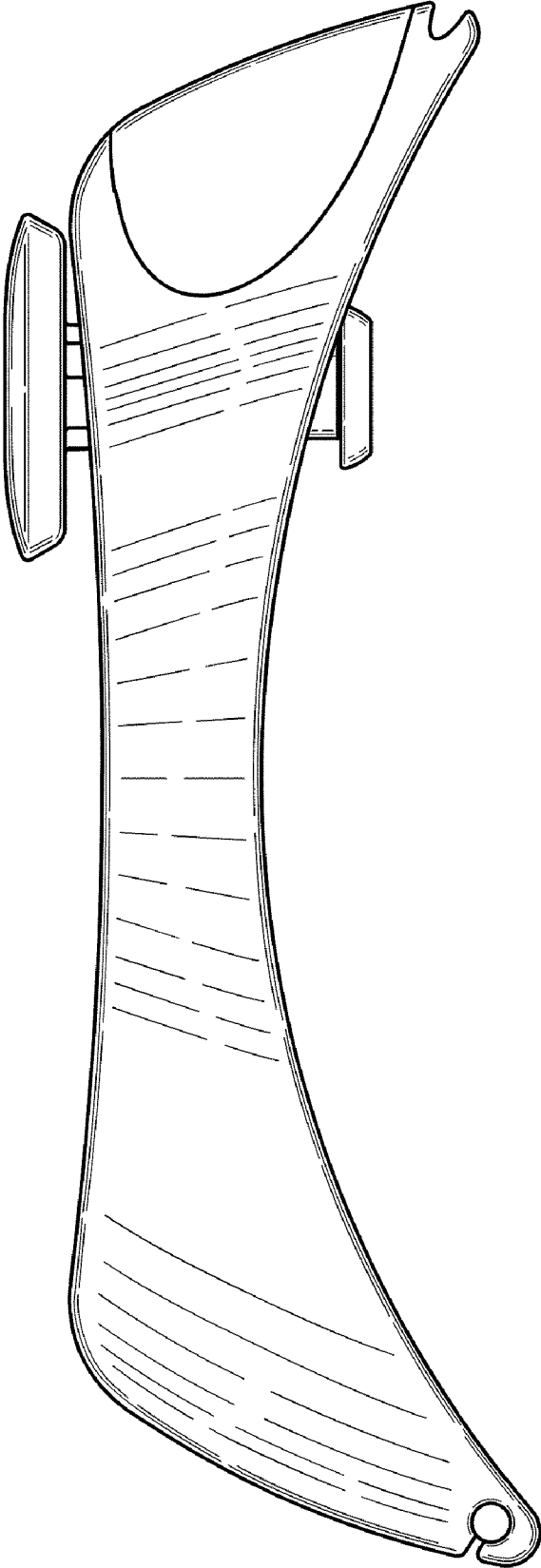

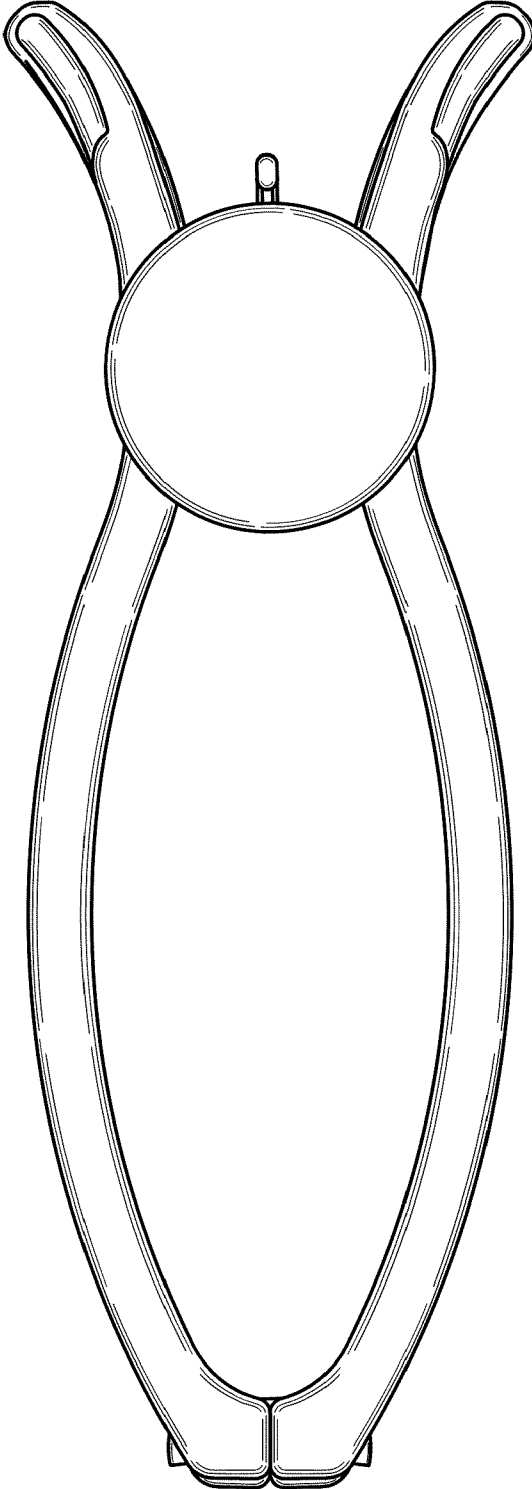

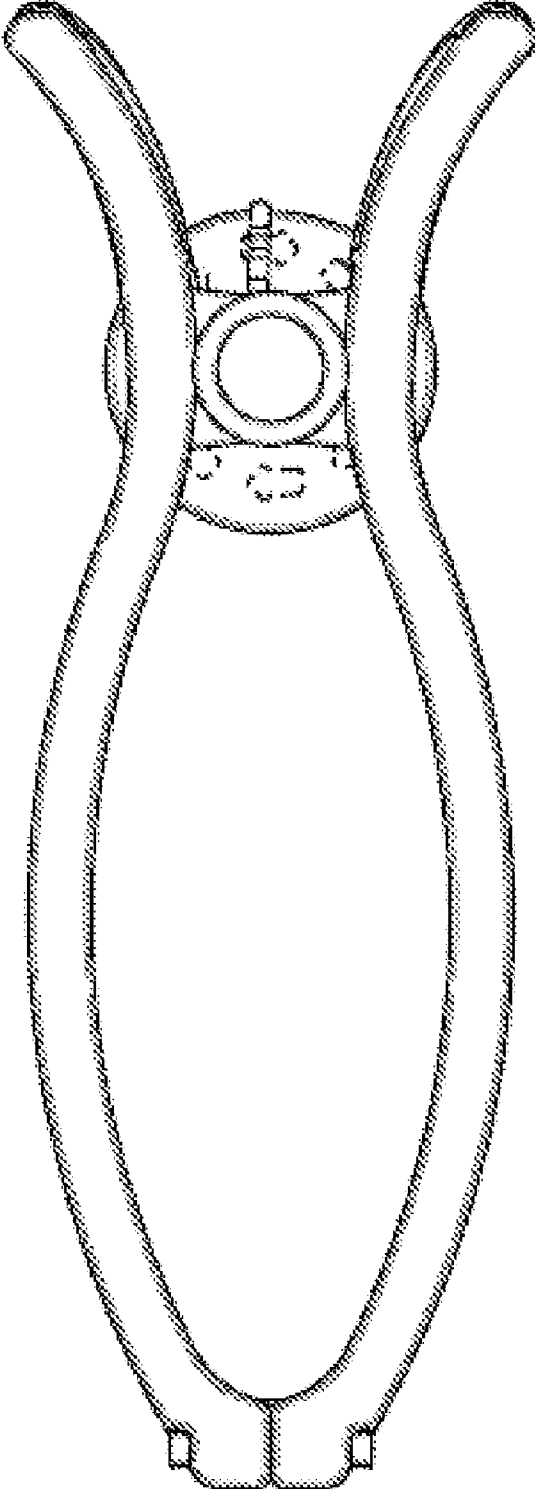

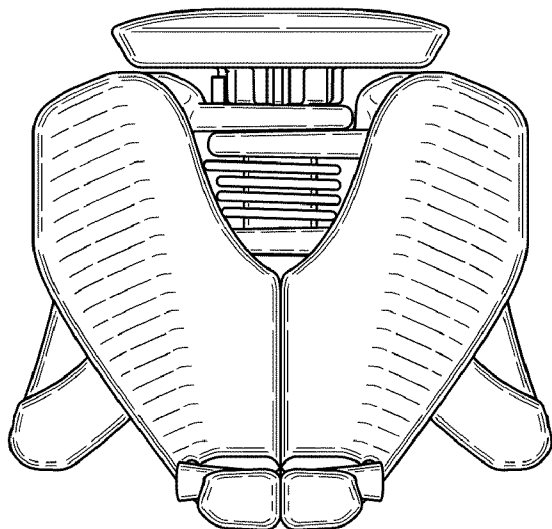

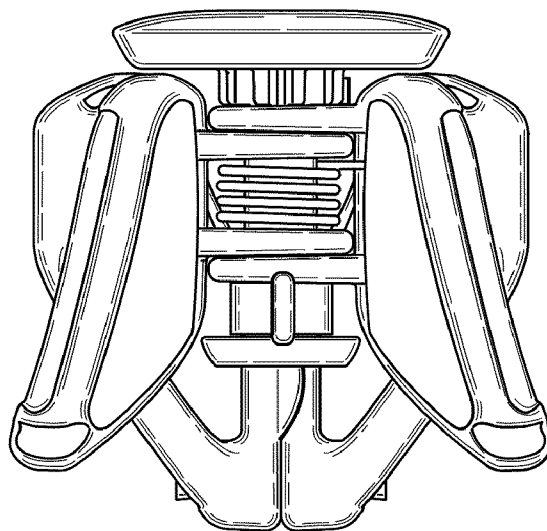

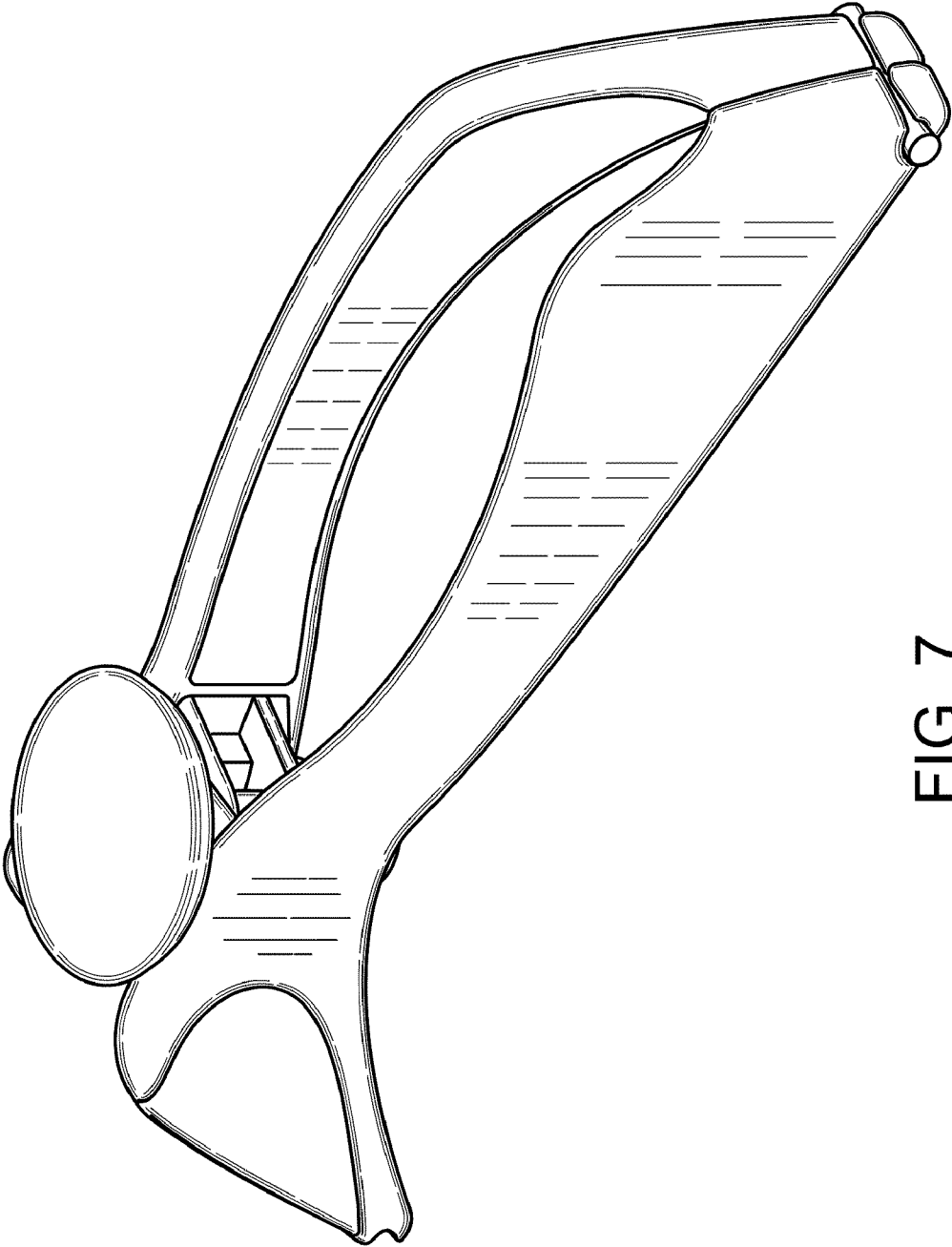

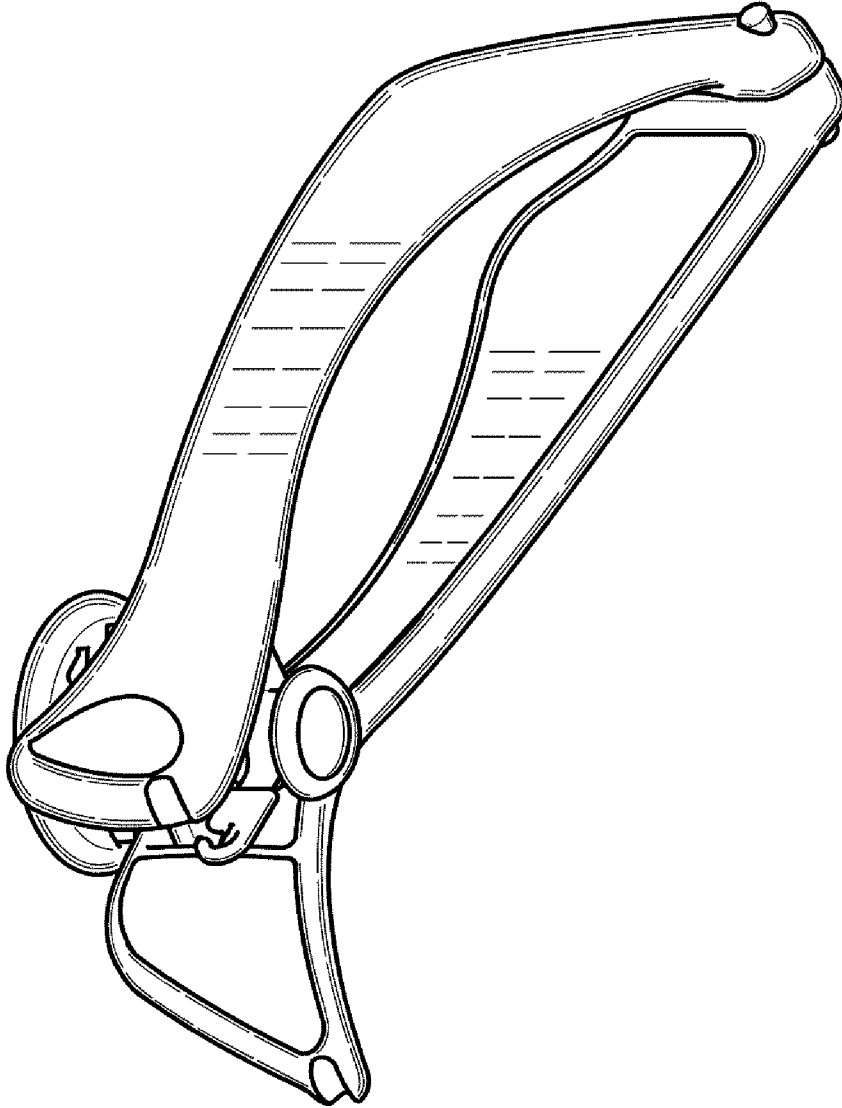
