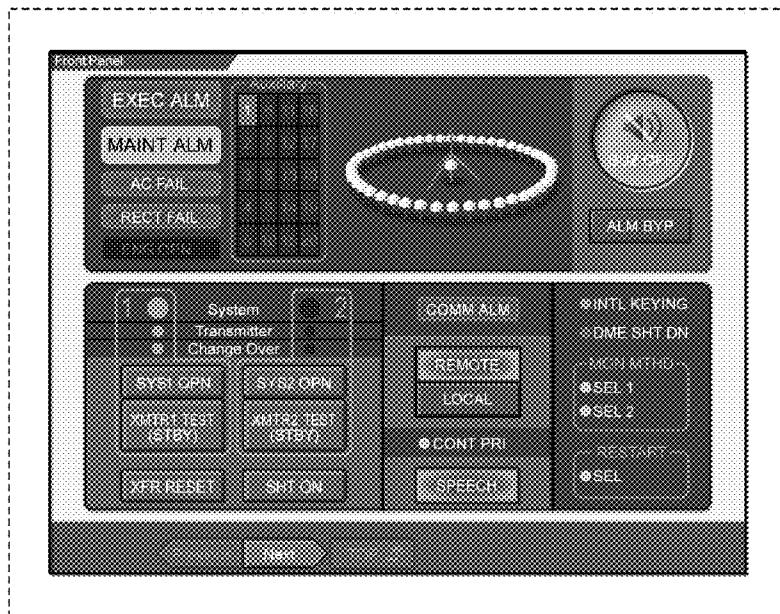
The ornamental design for a graphical use interface for a portion of a display, as shown and described.

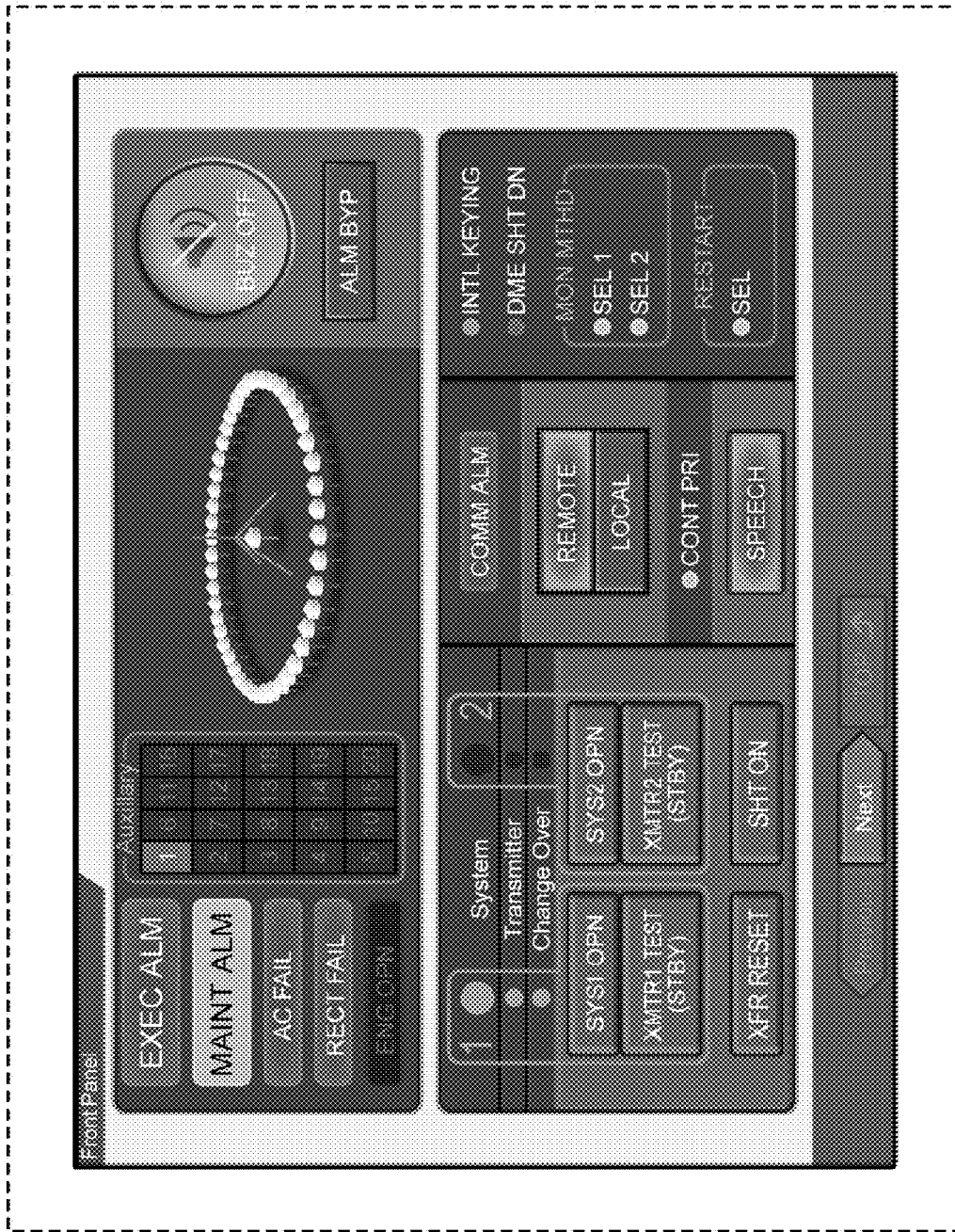
**DESCRIPTION**
