(57) **CLAIM**

The ornamental design for a docking station for tablet personal computer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a docking station for tablet personal computer showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a right-side view thereof, in which the docking station is shown in an example environment; and, FIG. 9 is another right-side view thereof, in which the docking station is shown in an example environment. The broken lines are for environmental purposes only and form no part of the claimed design. The pairs of closely spaced jagged broken lines indicate no particular length and form no part of the claimed design.



















