FIG. 7 is a perspective view showing a front, top and right side thereof;

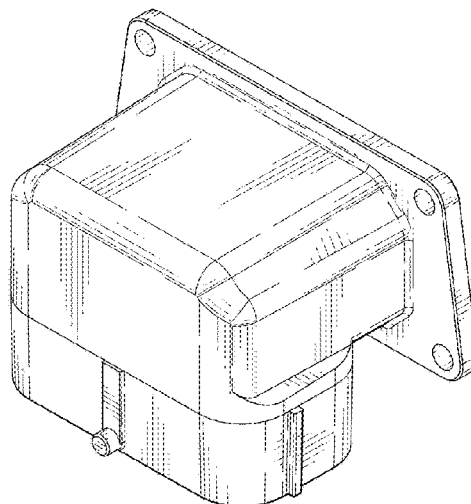
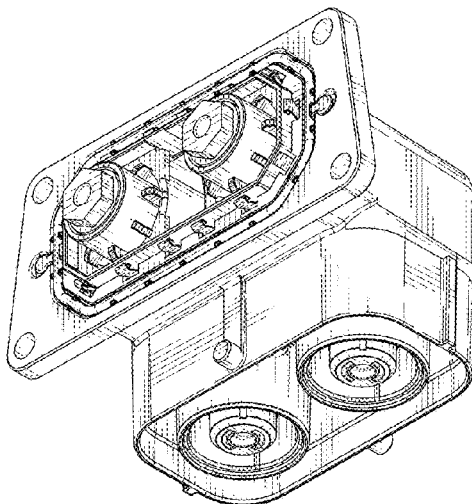
FIG. 8 is a perspective view showing a rear, bottom and left side thereof;

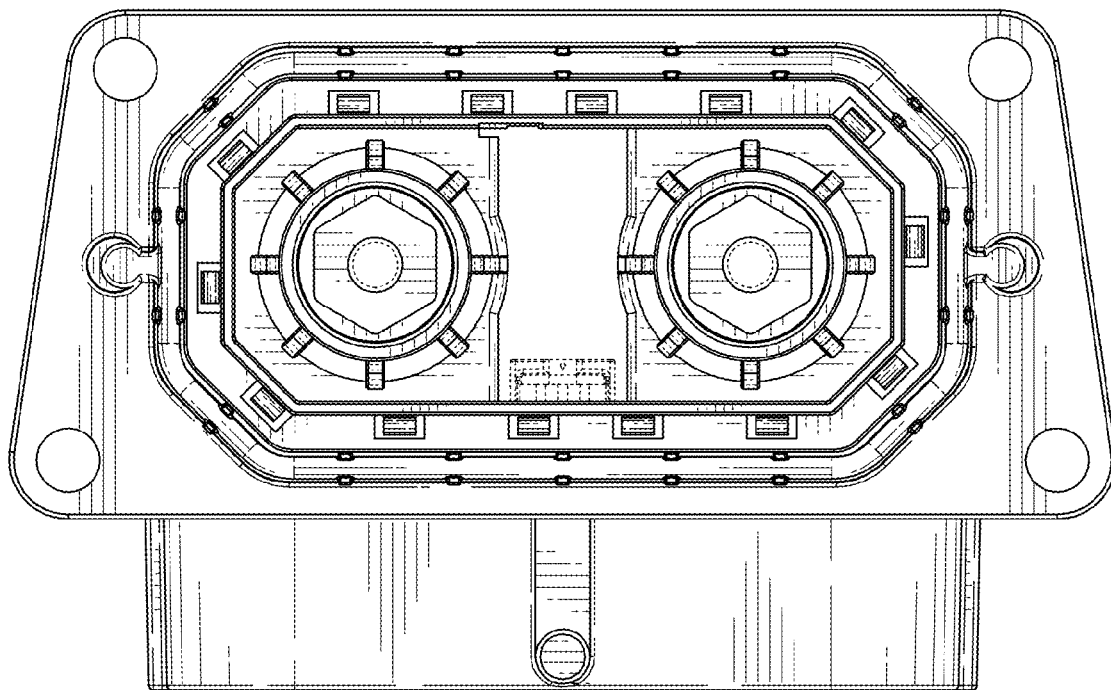

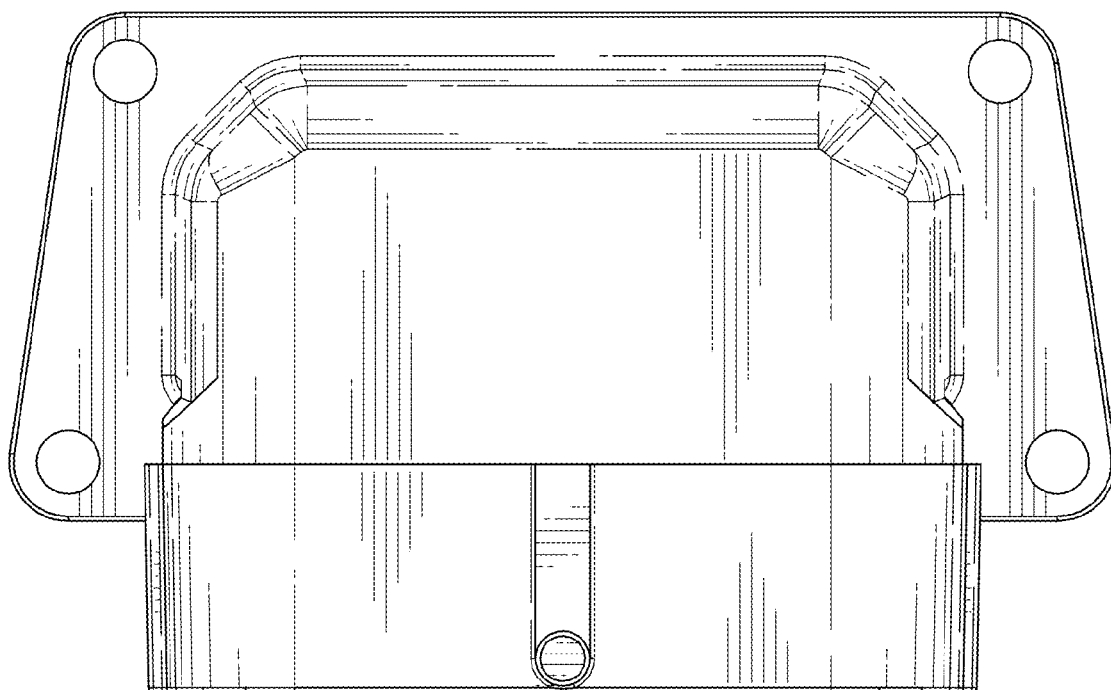

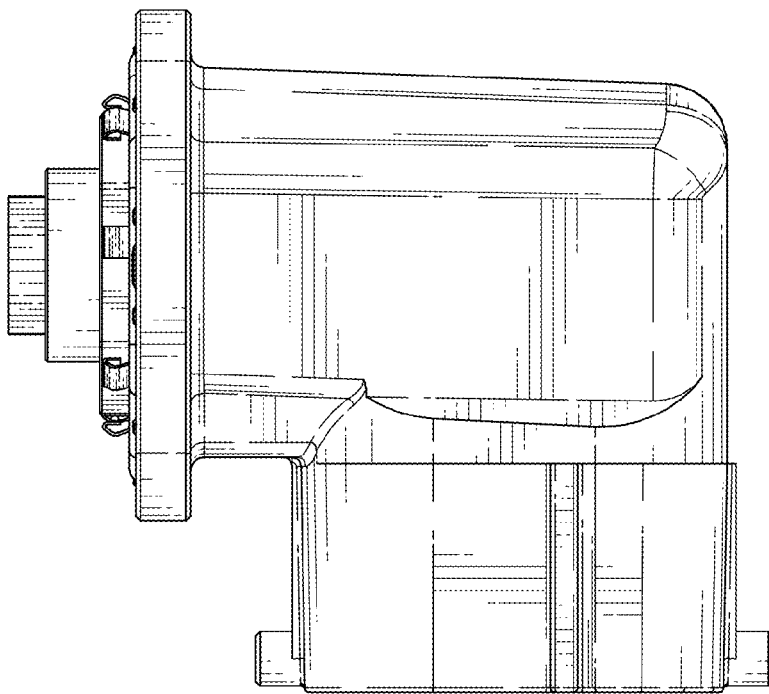

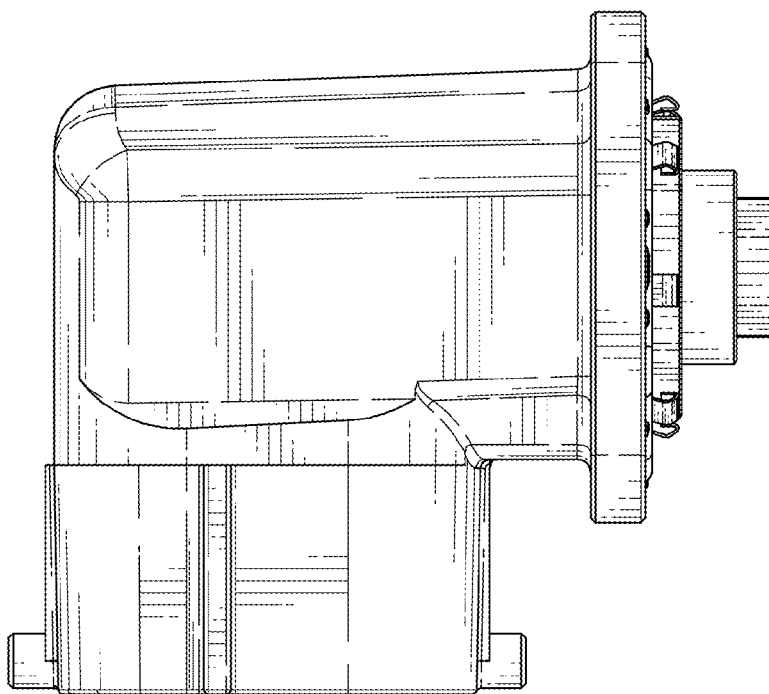

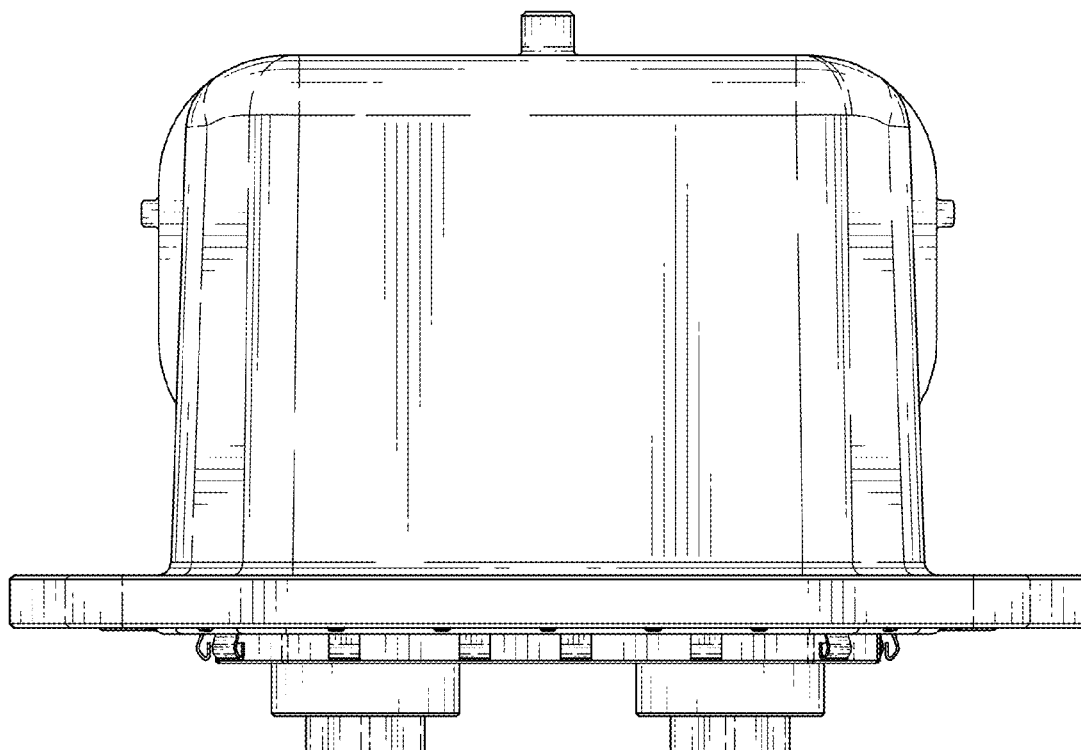

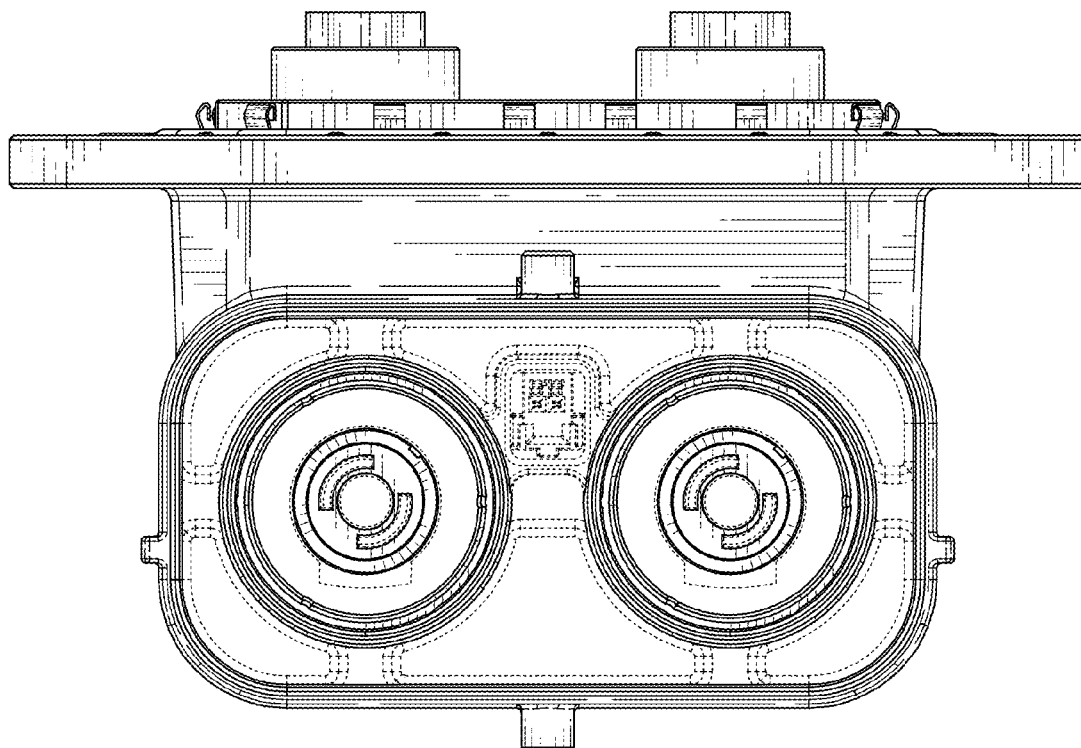

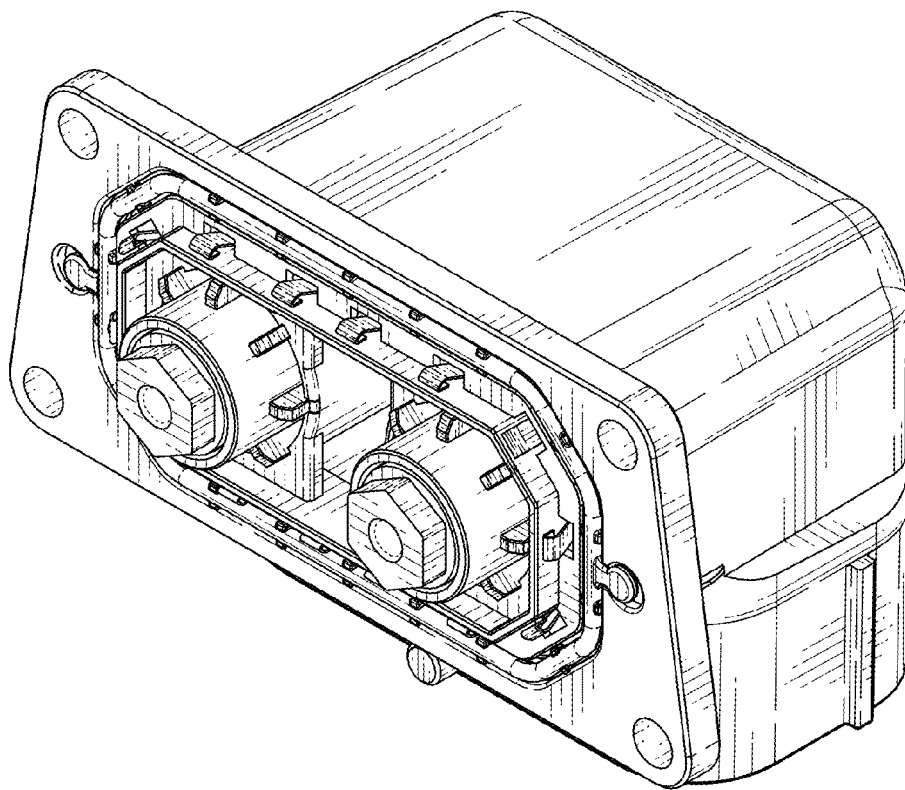

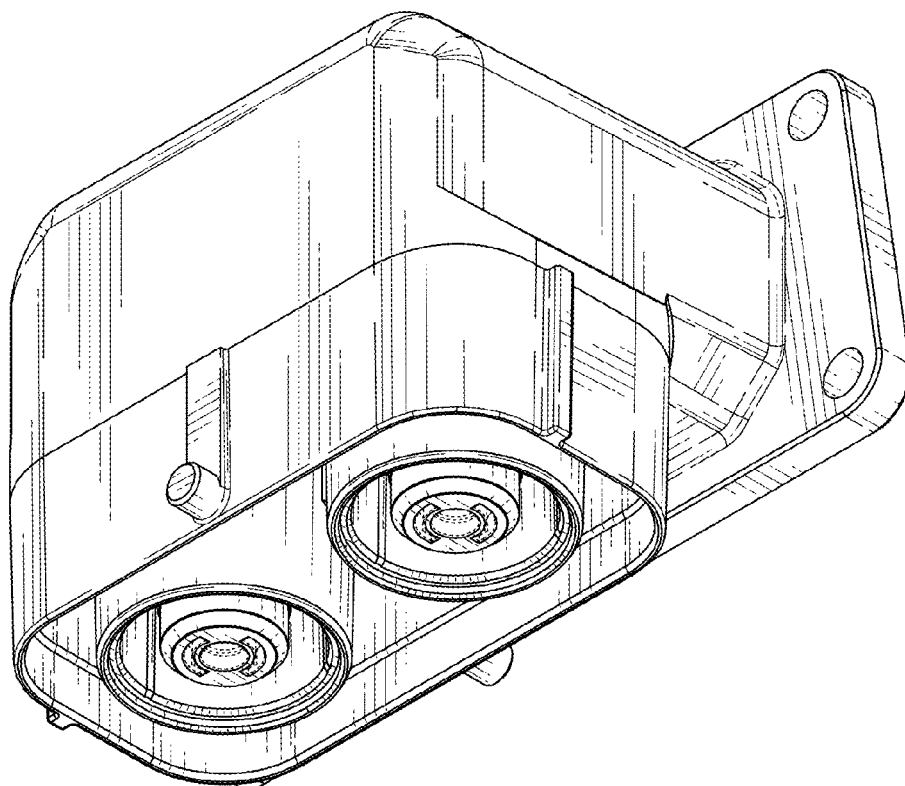

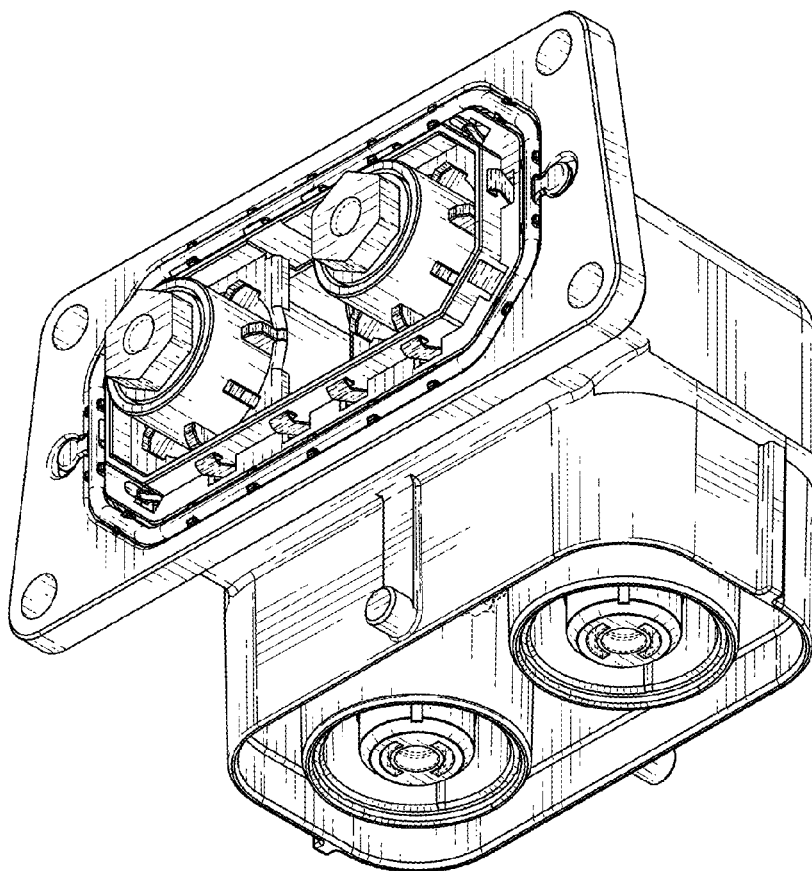

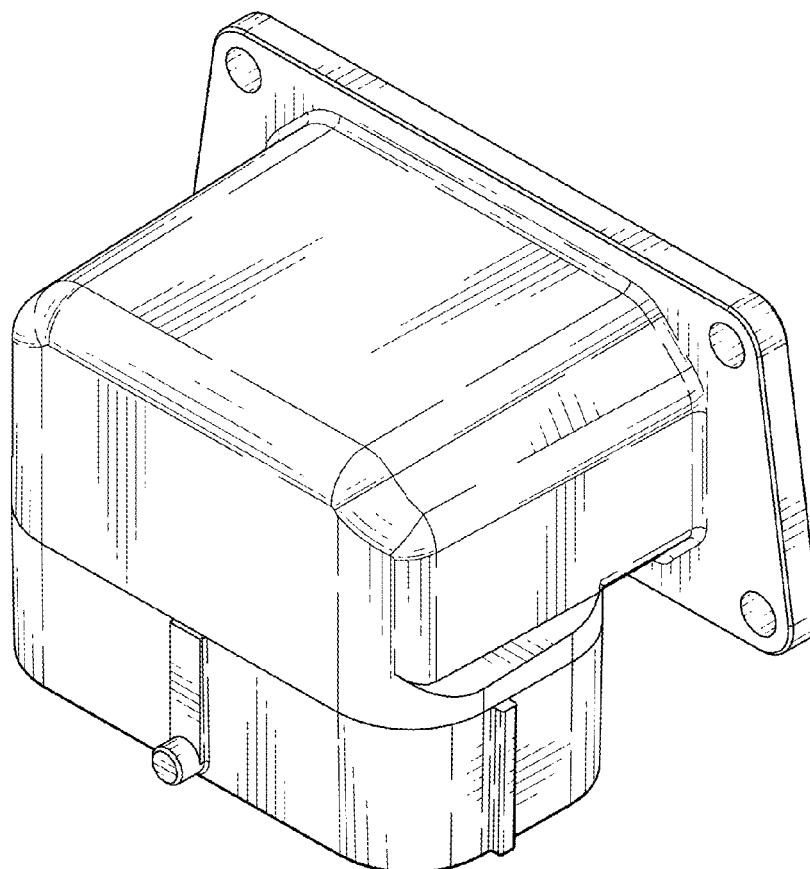
