(57) **CLAIM**

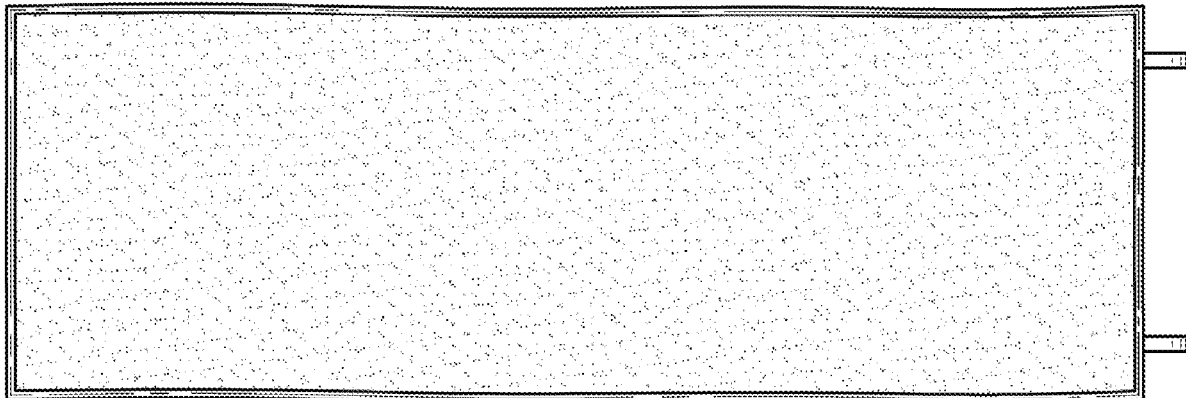
The ornamental design for a wrap for yoga mats, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a wrap for yoga mats of my new design.
FIG. 2 is a bottom view thereof;
FIG. 3 is a side view thereof, an opposite side view being a mirror image thereof;
FIG. 4 is a front view being thereof;
FIG. 5 is a rear view thereof; and
FIG. 6 is a perspective view illustrating the wrap for yoga mats in a rolled state.
The tag illustrated in broken lines in FIG. 2 depicts a portion of the wrap for yoga mats that forms no part of the claimed design.

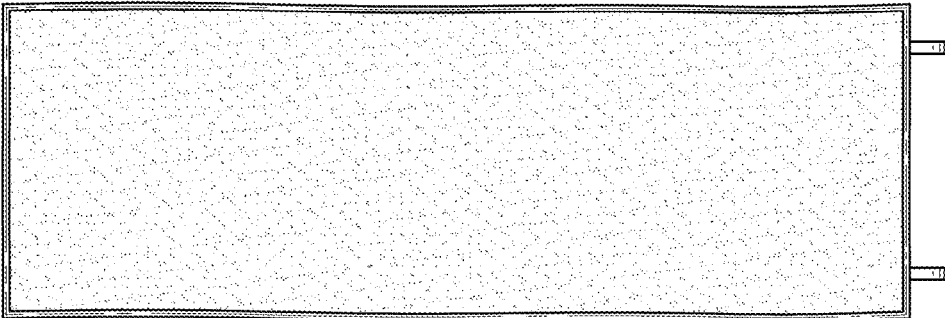

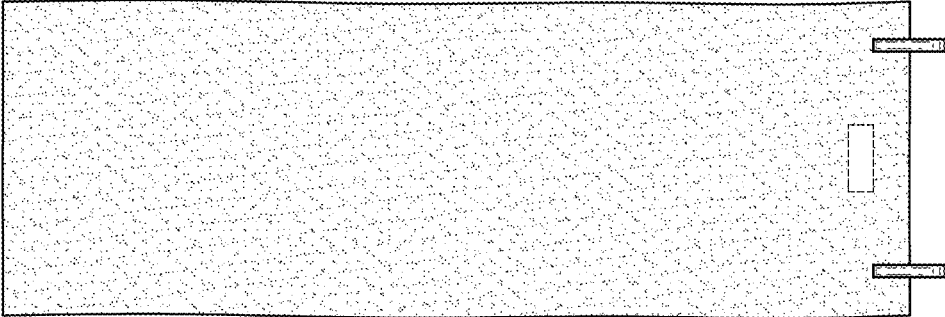

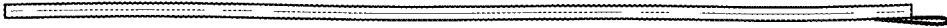

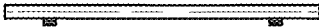

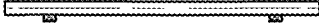

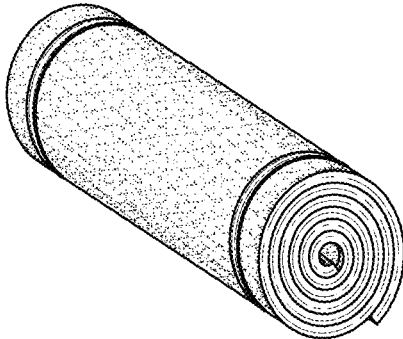
