(54) Title: ANODE FOR OXYGEN GENERATION AND MANUFACTURING METHOD FOR THE SAME

(57) Abstract: The present invention aims to provide an anode for oxygen generation and a manufacturing method for the same used for industrial electrolyses including manufacturing of electrolytic metal foils such as electrolytic copper foil, aluminum liquid contact and continuously electrogalvanized steel plate, and metal extraction. The present invention features an anode for oxygen generation and a manufacturing method for the same comprising a conductive metal substrate and a catalyst layer containing iridium oxide formed on the conductive metal substrate wherein the coating is baked in a low temperature region of 370°C - 400°C in an oxidation atmosphere to form the catalyst layer containing amorphous iridium oxide and the catalyst layer containing amorphous iridium oxide is post-baked in a further high temperature region of 520°C - 600°C in an oxidation atmosphere to crystallize almost all amount of iridium oxide in the catalyst layer.
