The broken lines depict portions of the hand bag in which the design is embodied that are not considered part of the claimed design.






FIG. 1 (Amended)




FIG. 2 (Amended)




FIG. 3 (Amended)








FIG. 6 (Amended)




FIG. 7 (Amended)
