(57) **CLAIM**

We claim the ornamental design for a portable electronic device display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a portable electronic device display screen with graphical user interface showing our new design;

FIG. 2 is a second embodiment thereof;

FIG. 3 is an enlarged detail view of the embodiment shown FIG. 1, shown for clarity of illustration; and,

FIG. 4 is an enlarged detail view of the embodiment shown in FIG. 2 thereof.

The broken lines shown in the drawings illustrate environmental subject matter that forms no part of the claimed design.

The appearance of the image sequentially transitions between the images shown in FIGS. 1-2.

The process or period in which one image transitions into the other image forms no part of the claimed design.








