
(57) **CLAIM**

The ornamental design for a microphone, as shown and described in the accompanying drawings.


**DESCRIPTION**

FIG. 1 is a perspective view of a microphone in accordance with the invention;  
FIG. 2 is a front view of the microphone depicted in FIG. 1, the back view being a mirror image thereof;  
FIG. 3 is a left side view of the microphone depicted in FIG. 1;  
FIG. 4 is a right side view of the microphone depicted in FIG. 1;  
FIG. 5 is a top view of the microphone depicted in FIG. 1;  
FIG. 6 is a bottom view of the microphone depicted in FIG. 1; and,  
FIG. 7 is a perspective view of the microphone depicted in FIG. 1 in an alternate position.  
The broken lines depict environment and portions of the microphone that form no part of the claimed design.










