(57) **CLAIM**

The ornamental design for a container and blank for forming same, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a container and blank for forming the same showing our new design in its blank, unassembled condition;

FIG. 2 is a perspective view thereof in a partially assembled condition;

FIG. 3 is a perspective view thereof in a fully assembled condition;

FIG. 4 is a top perspective view thereof from one end of the carton;

FIG. 5 is a top perspective view thereof from the opposite end;

FIG. 6 is a bottom perspective view thereof;

FIG. 7 is a top plan view thereof;



FIG. 8 is a bottom plan view thereof;
















