(57) **CLAIM**

The ornamental design for a shaving razor cartridge, as shown and described.

DESCRIPTION






FIG. 3***FIG. 4***






FIG. 6***FIG. 7***

FIG. 1 is a top perspective view of the shaving razor cartridge; FIG. 2 is a right elevation view of the shaving razor cartridge; FIG. 3 is a front elevation view of the shaving razor cartridge; FIG. 4 is a rear elevation view of the shaving razor cartridge. FIG. 5 is a left elevation view of the shaving razor cartridge; FIG. 6 is a top plan view of the shaving razor cartridge; and, FIG. 7 is a bottom plan view of the shaving razor cartridge. 


