The ornamental design for a hose mounting, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a hose mounting incorporating the design features of the invention;

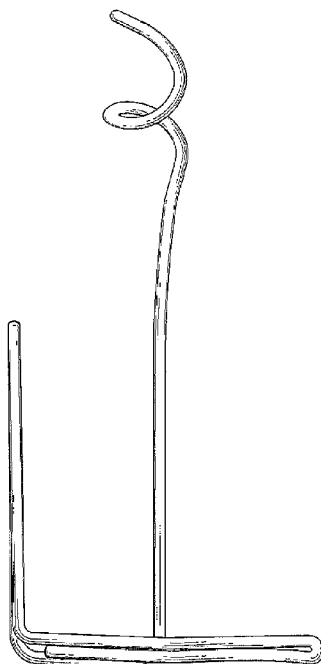
FIG. 2 is a rear elevational view thereof;

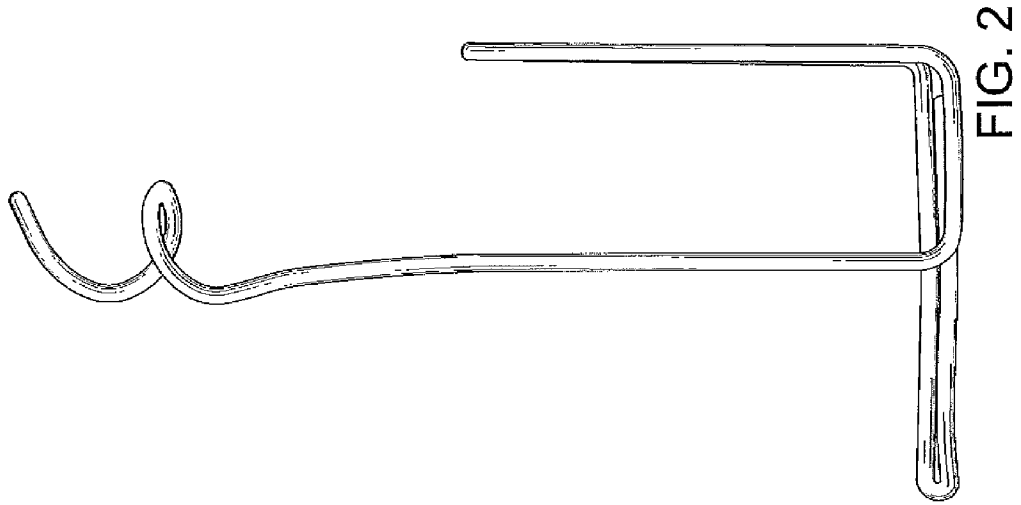

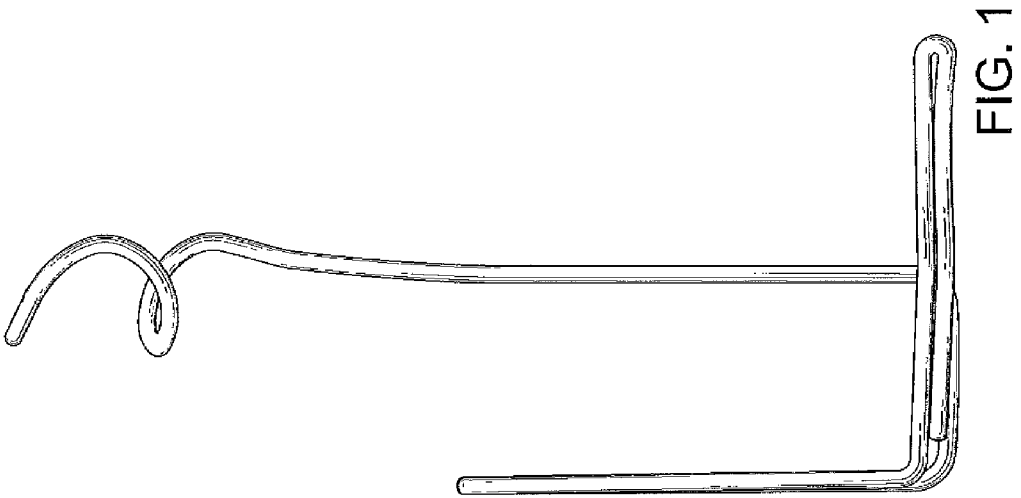

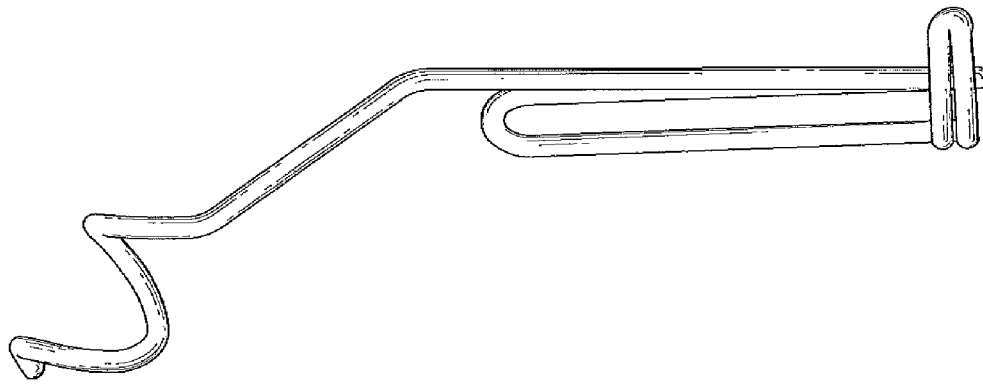

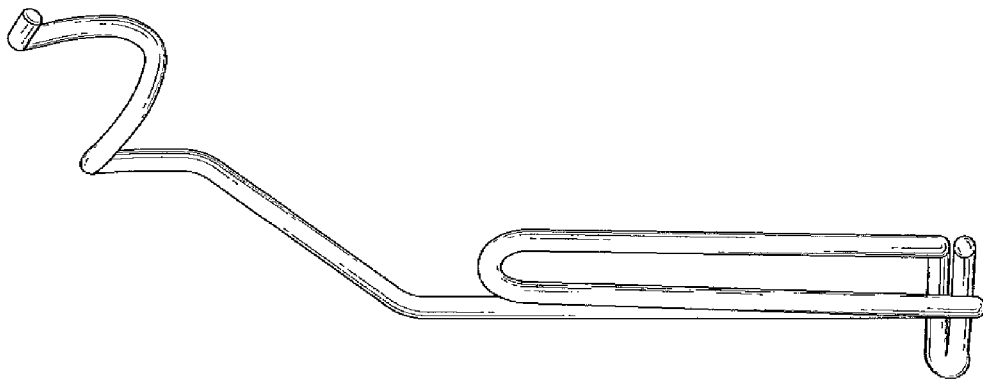

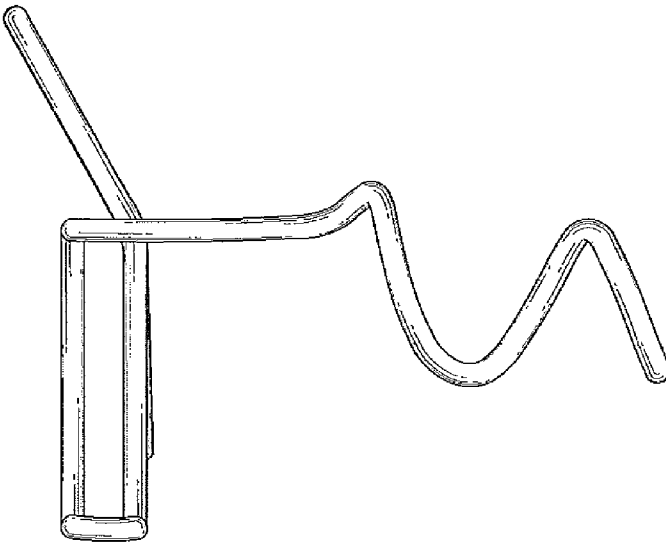
