
(57) **CLAIM**

The ornamental design for a sun protection garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sun protection garment; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; the right side elevation view being a mirror image thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.










