(57) **CLAIM**

The ornamental design for a beverage stave, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view from a first, side perspective of a beverage stave;
FIG. 2 is a first side view of the beverage stave shown in FIG. 1;
FIG. 3 is a second side view of the beverage stave shown in FIG. 1;
FIG. 4 is a third side view of the beverage stave shown in FIG. 1;
FIG. 5 is a fourth side view of the beverage stave shown in FIG. 1;
FIG. 6 is a top plan view of the beverage stave shown in FIG. 1; and,
FIG. 7 is a bottom plan view of the beverage stave shown in FIG. 1.

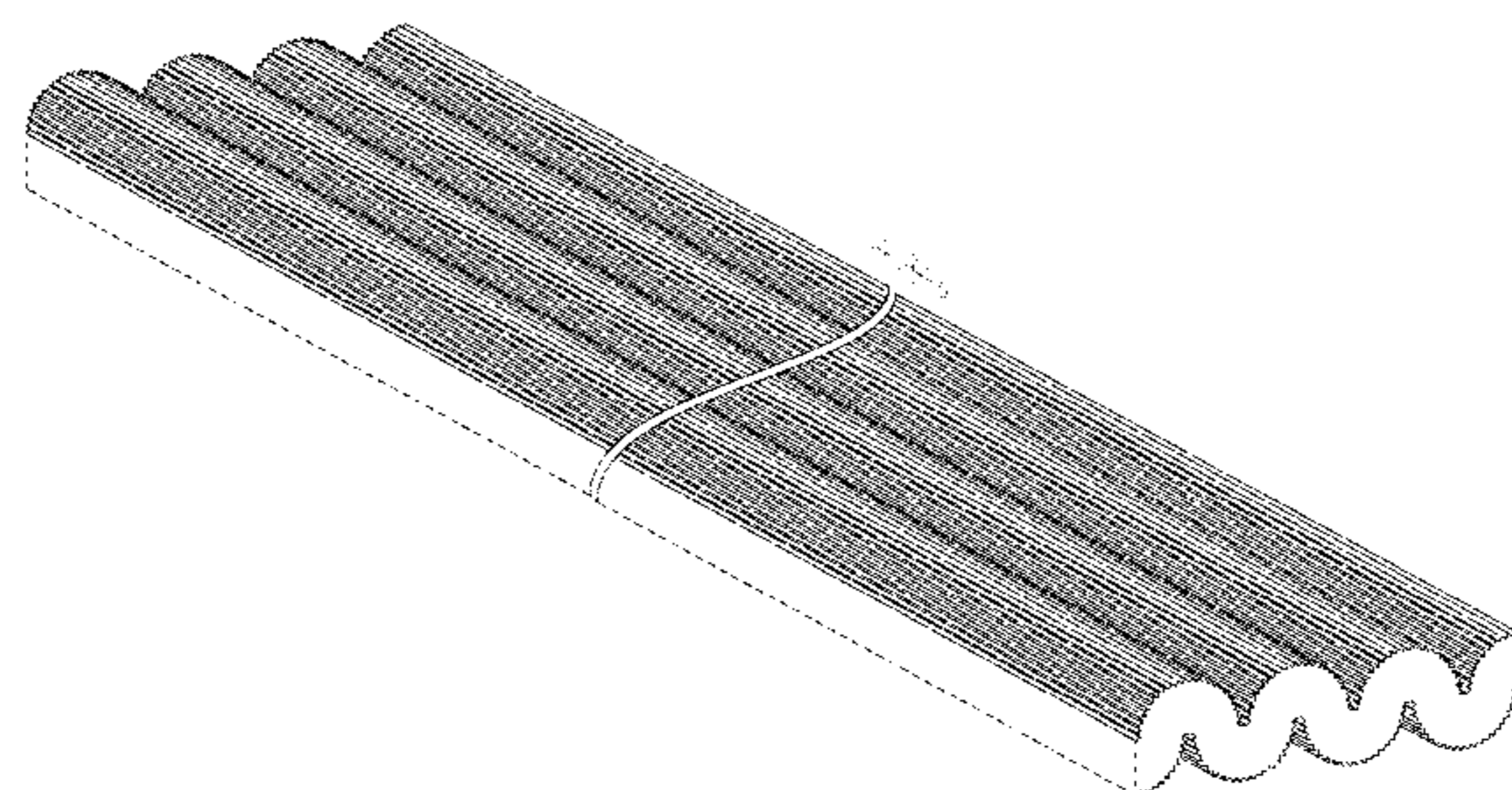

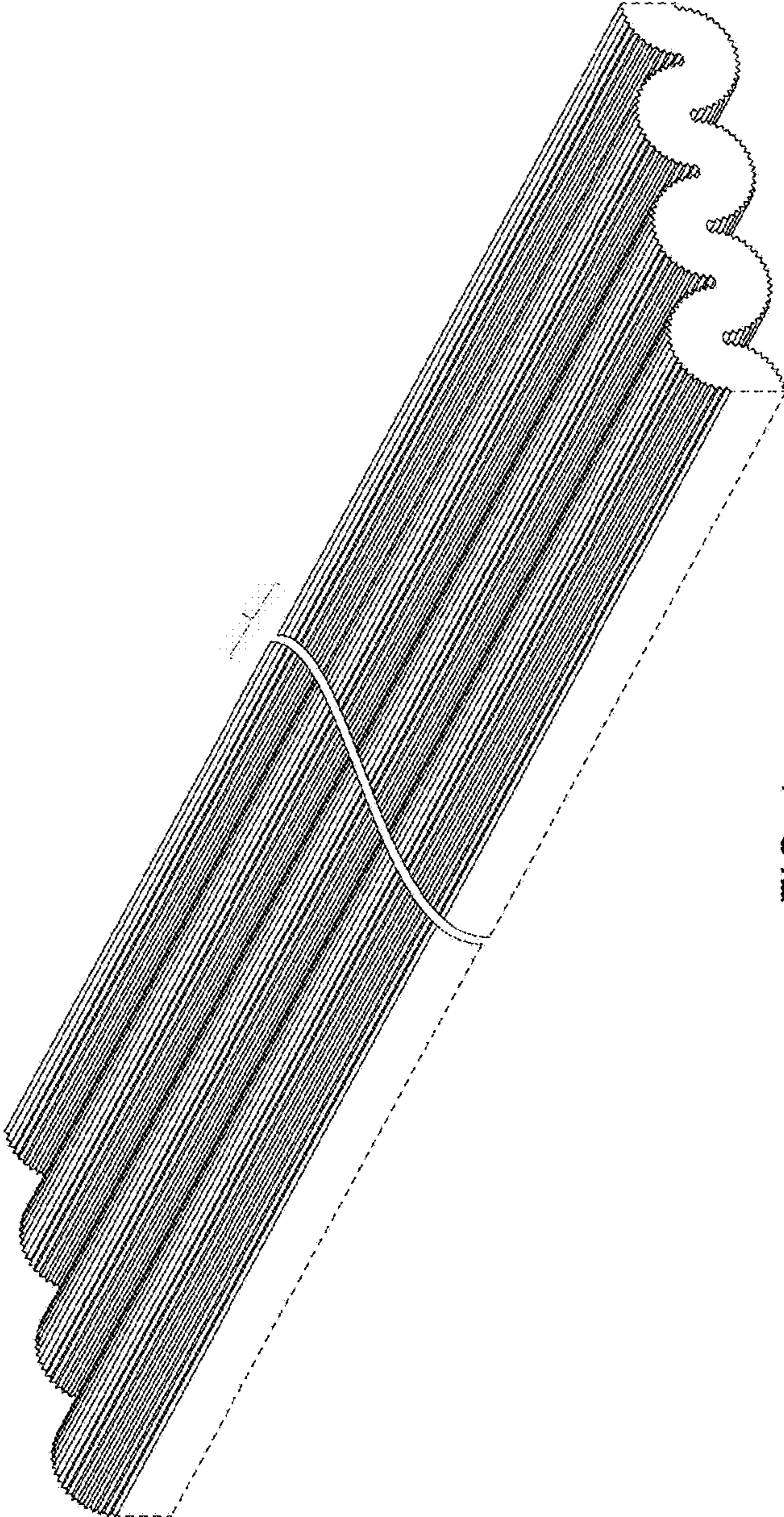

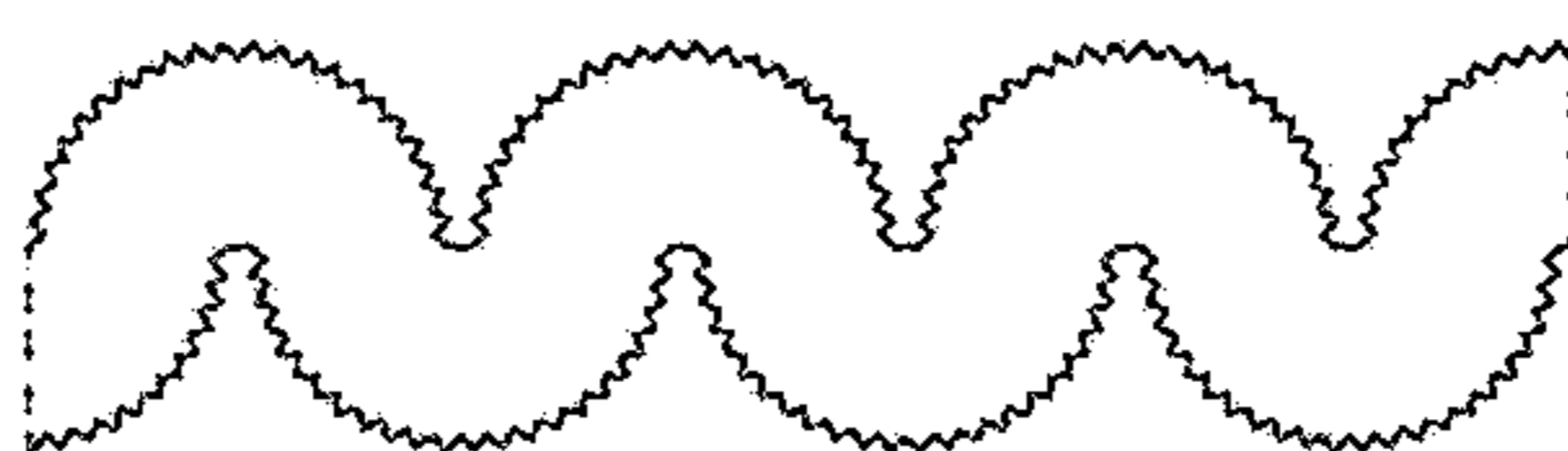

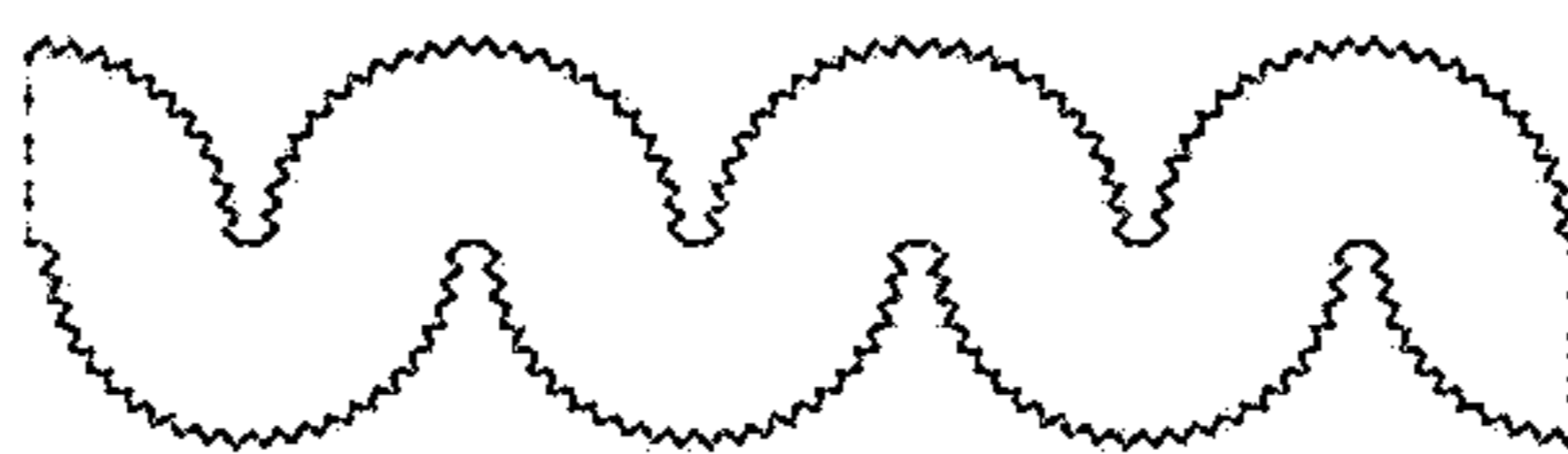

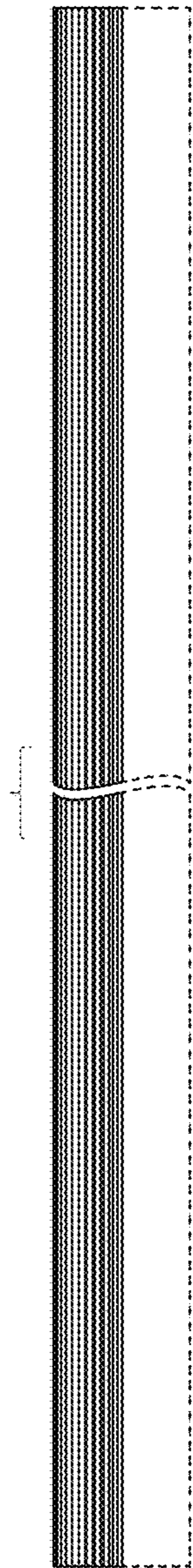

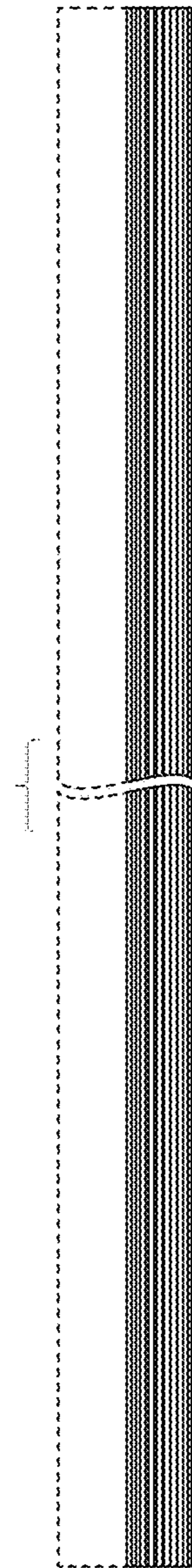

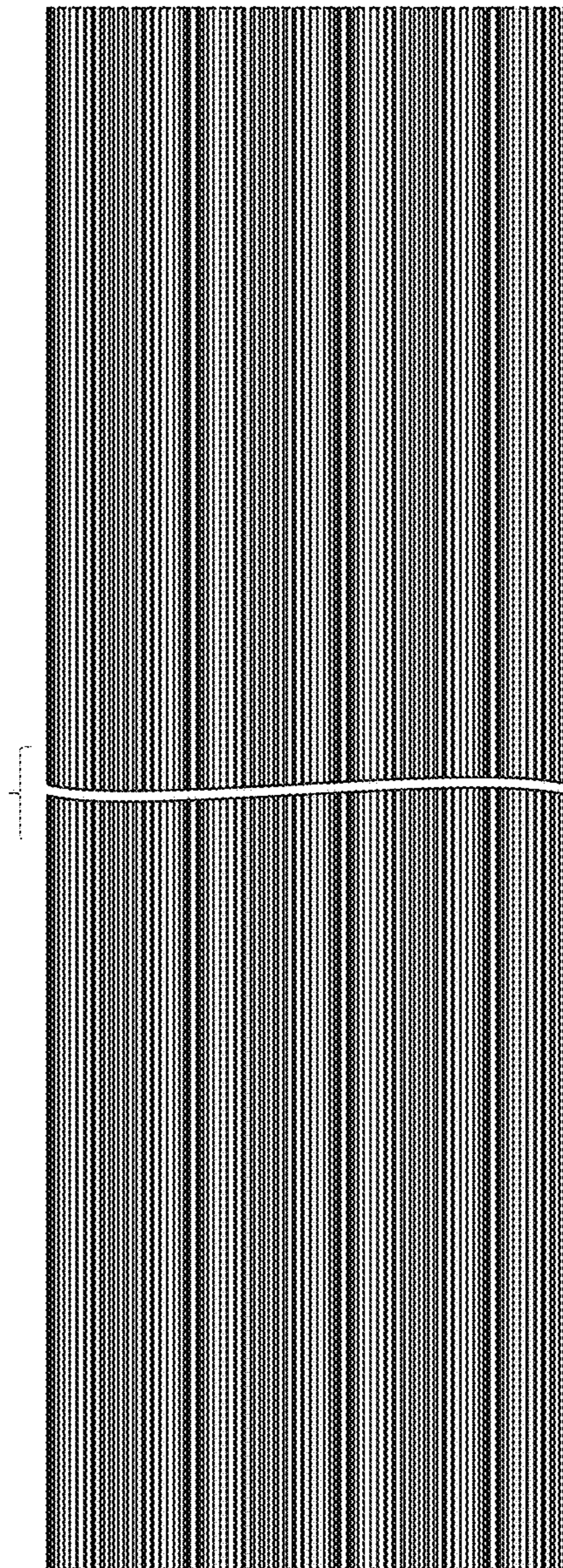

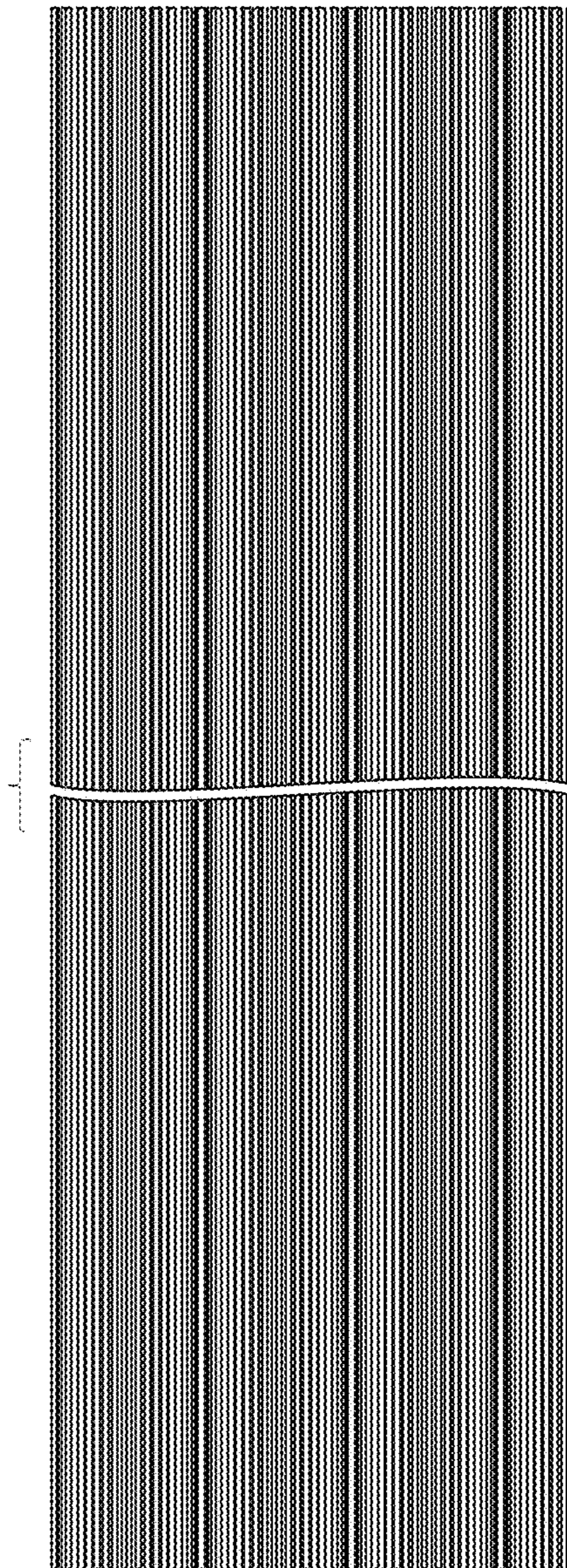
