FIG. 20 is a top view of the lock bumpers shown in FIG. 15; and,

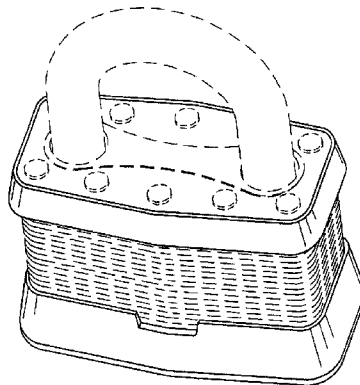
FIG. 21 is a bottom view of the lock bumpers shown in FIG. 15.

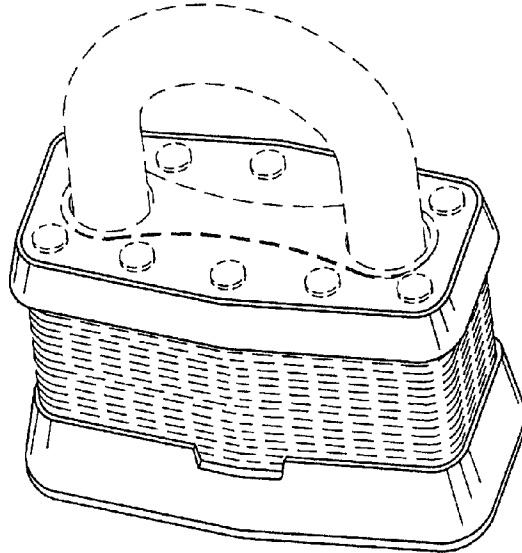

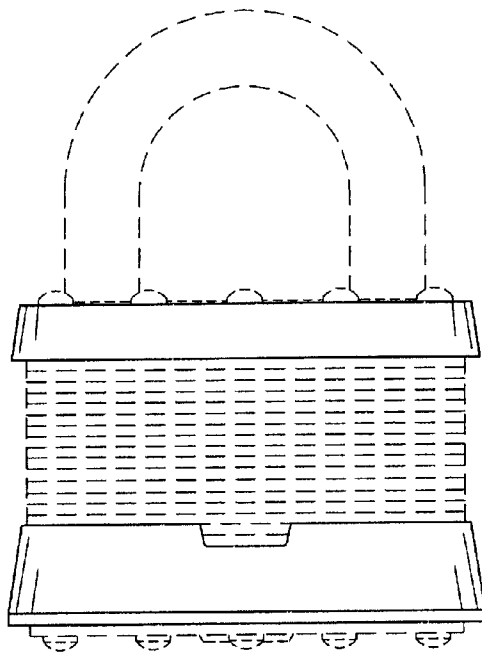

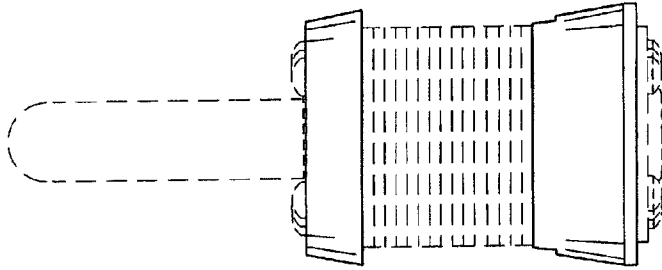

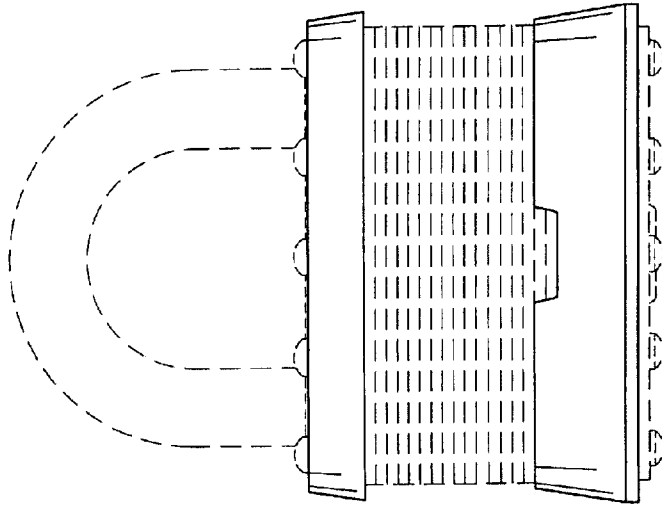

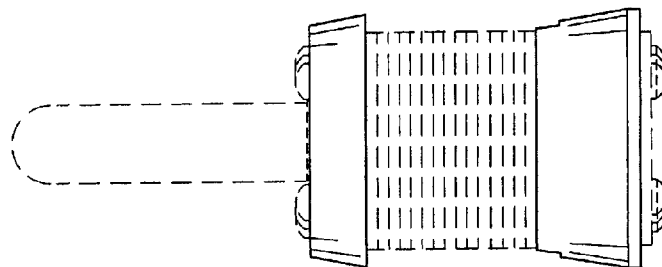

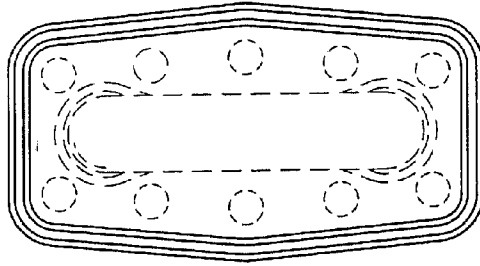

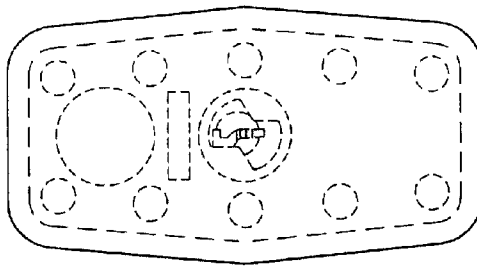

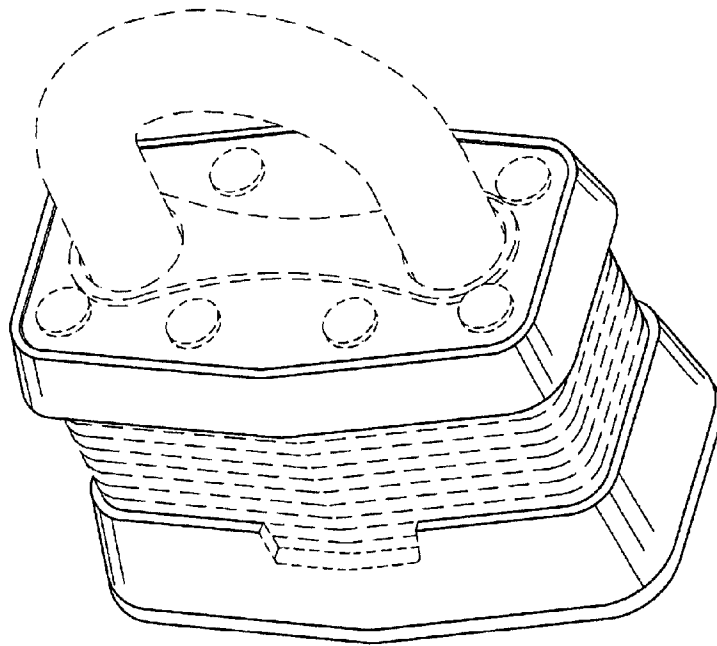
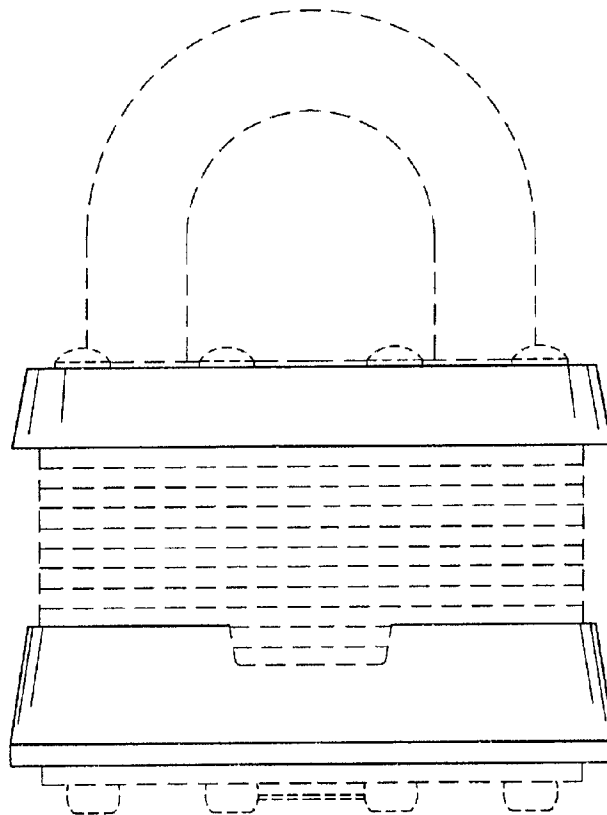

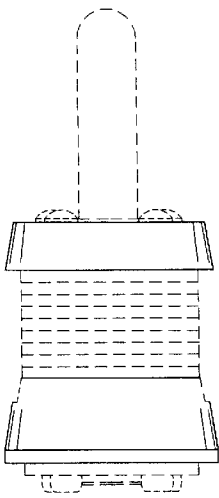

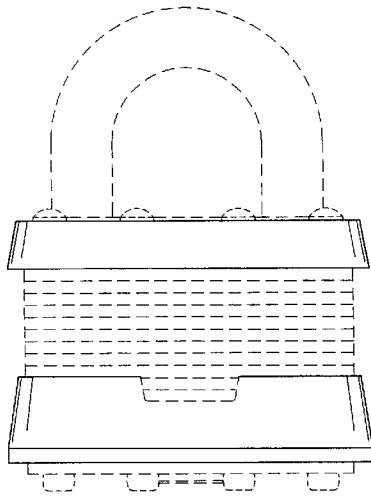

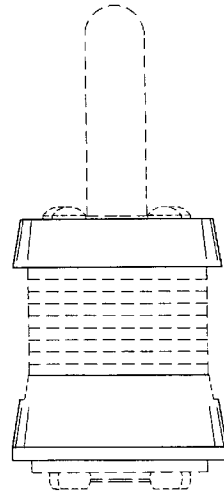

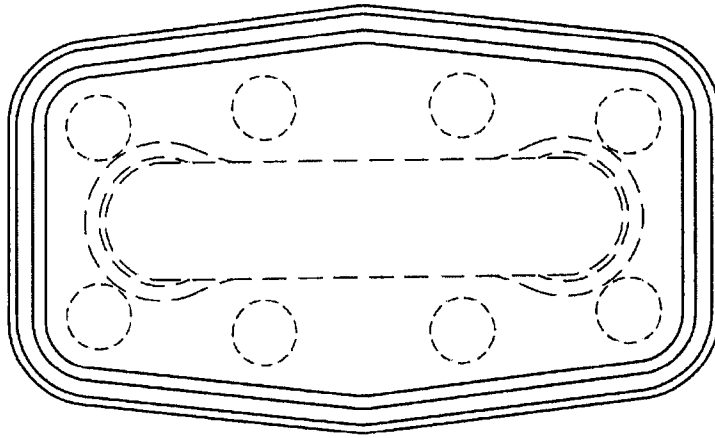

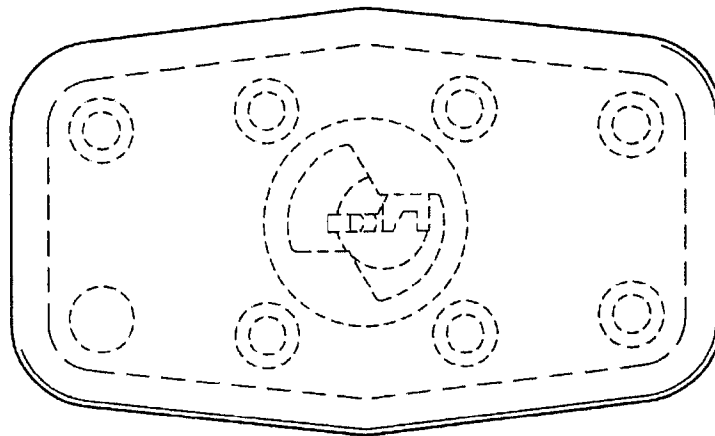

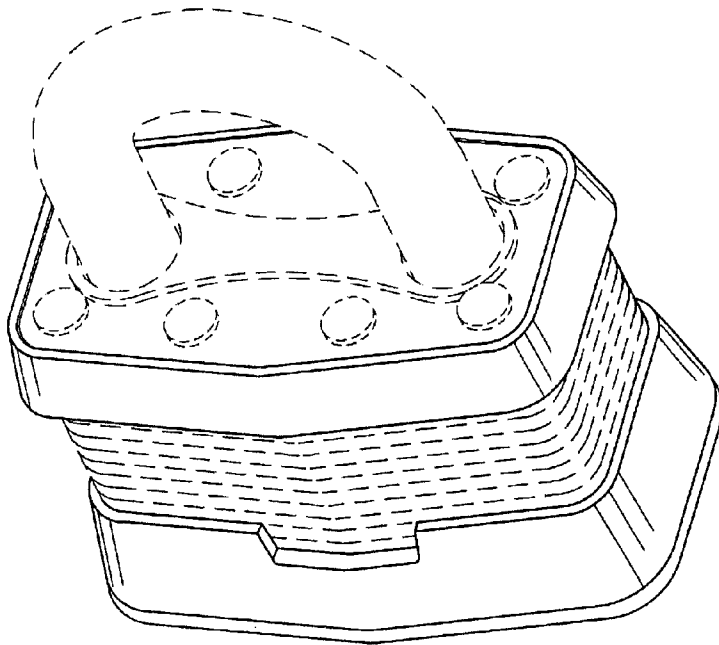

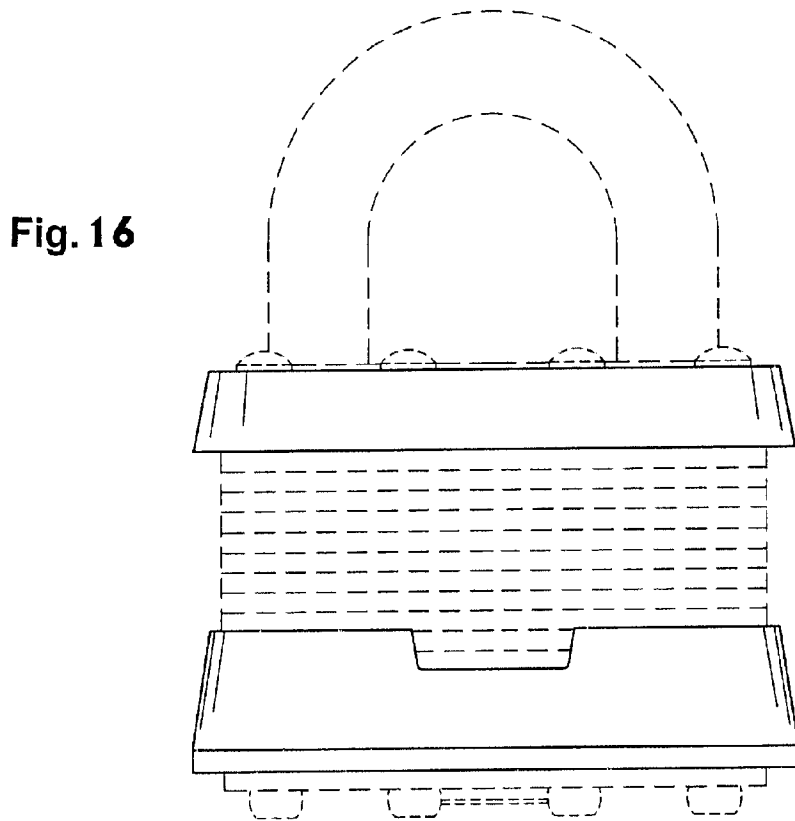

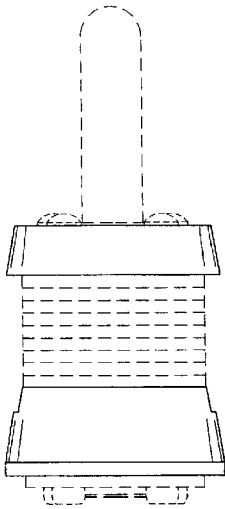

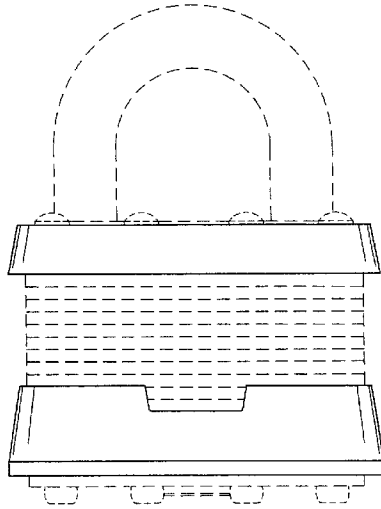

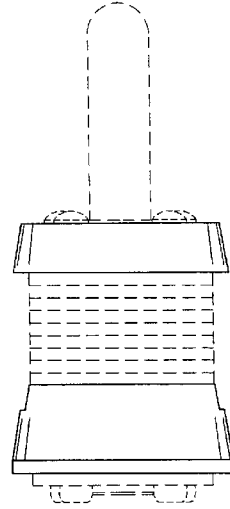

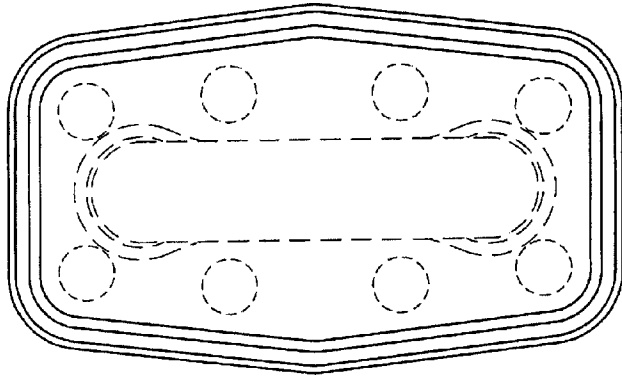

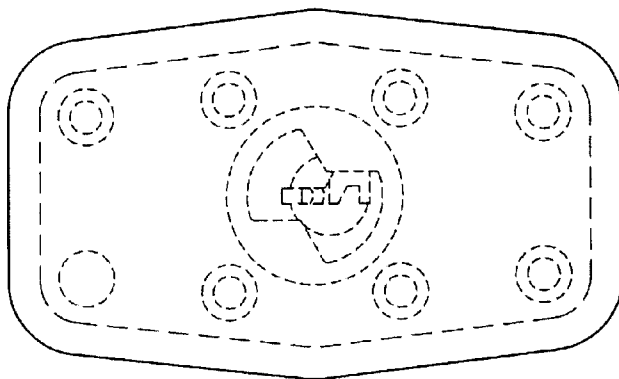
