DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a bottle showing my new design;

FIG. 11 is a right side view thereof;

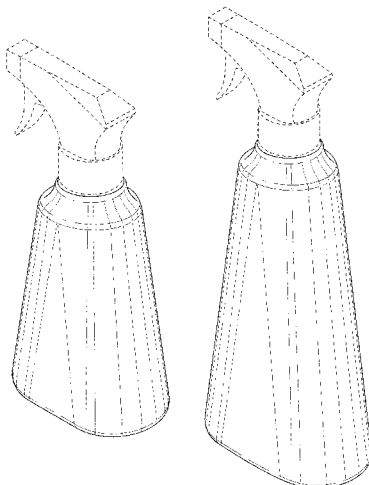
FIG. 12 is a top plan view thereof;

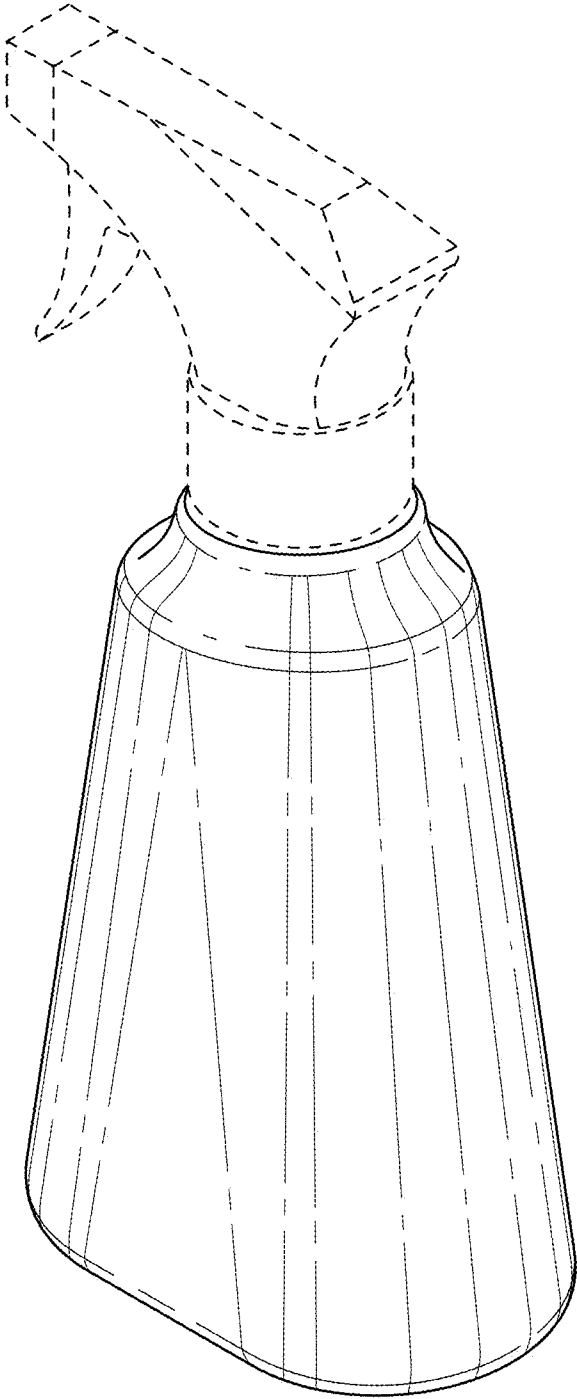

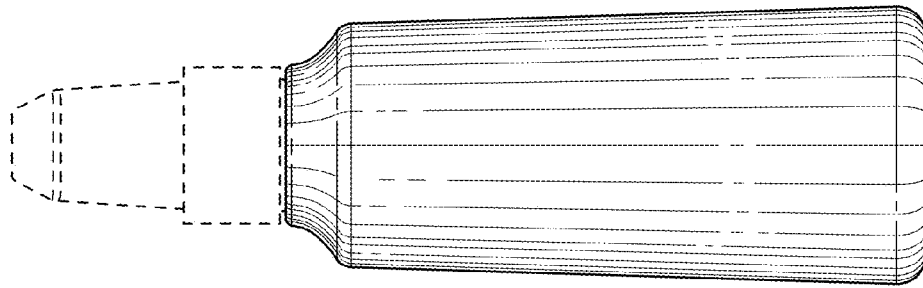

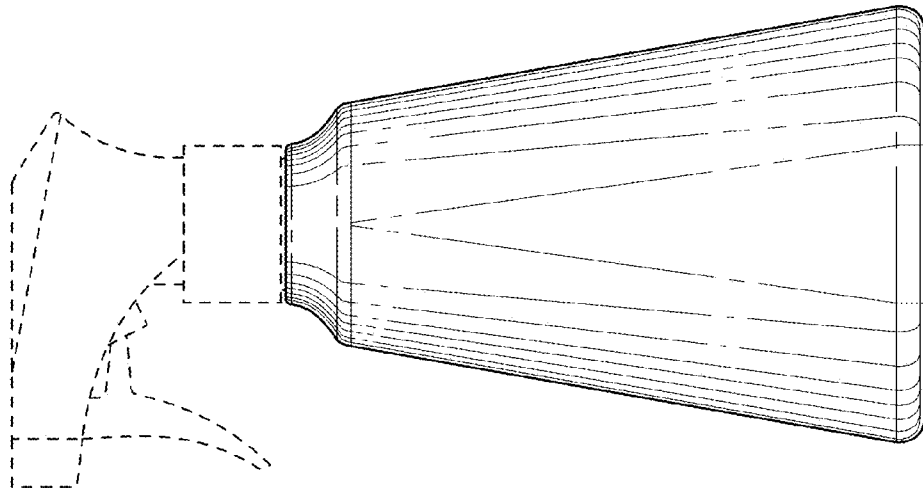

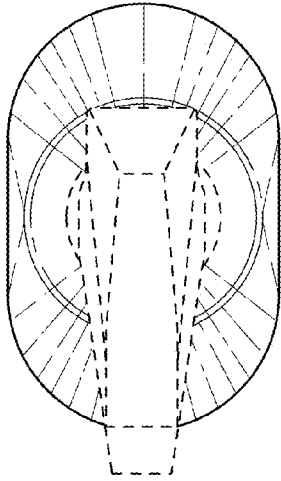

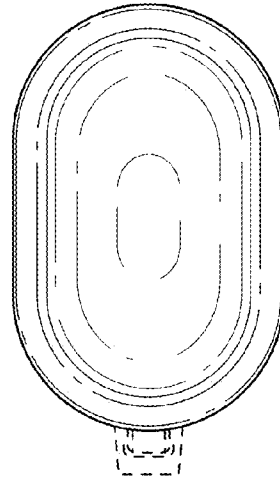

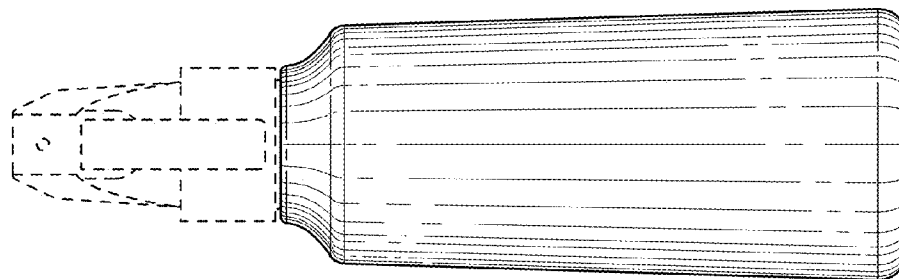

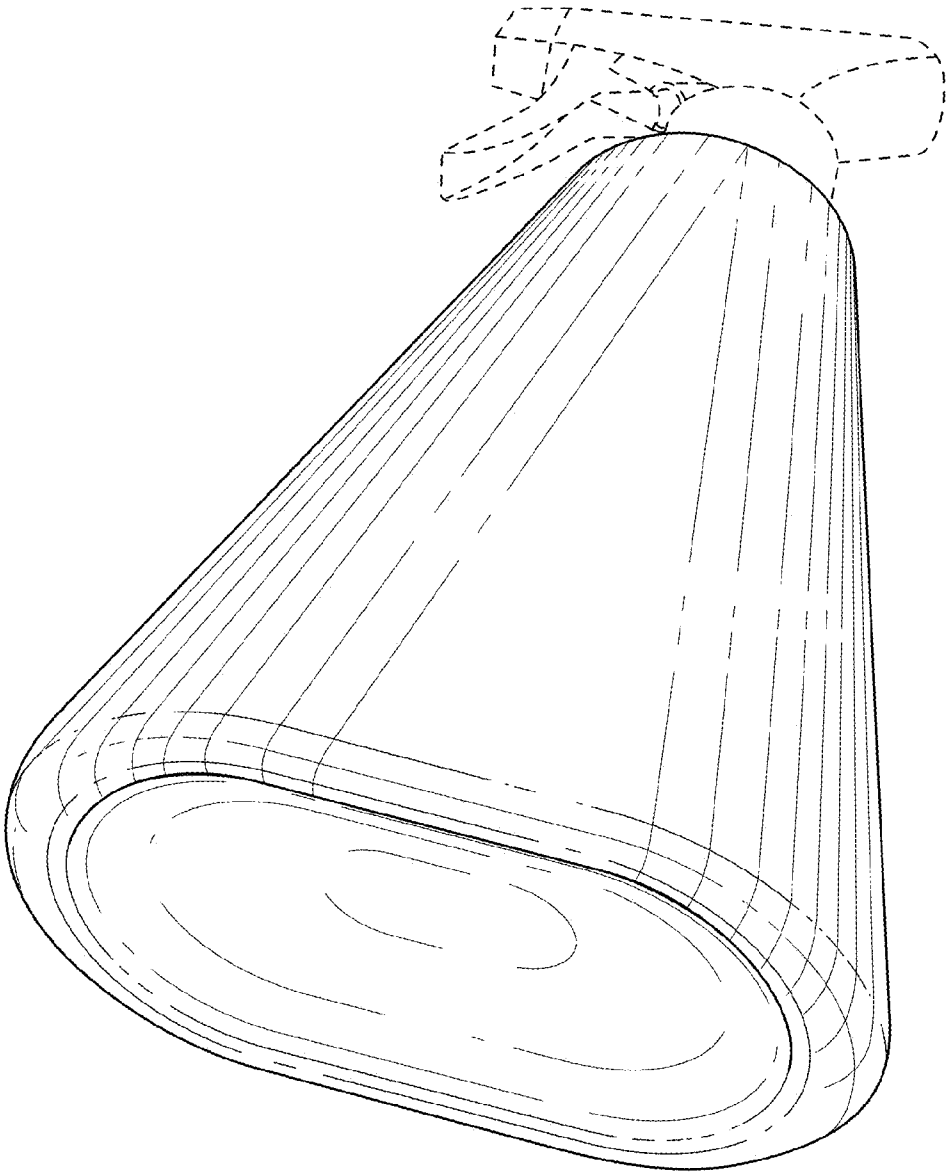

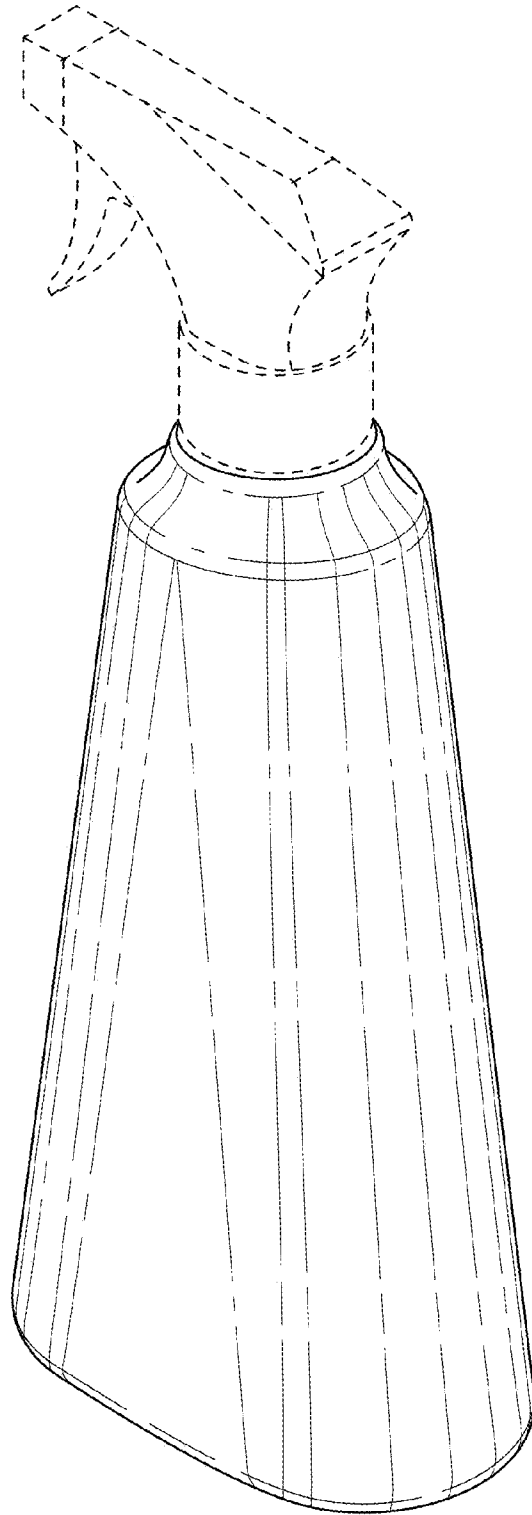

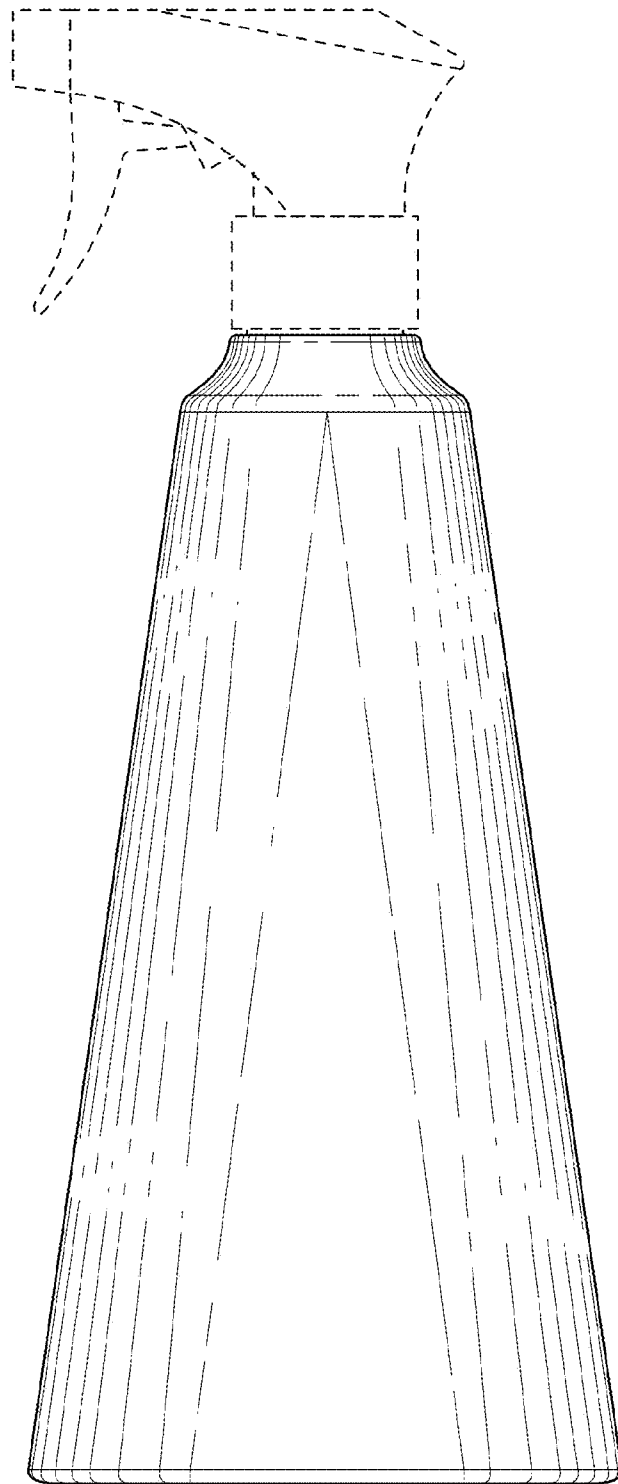

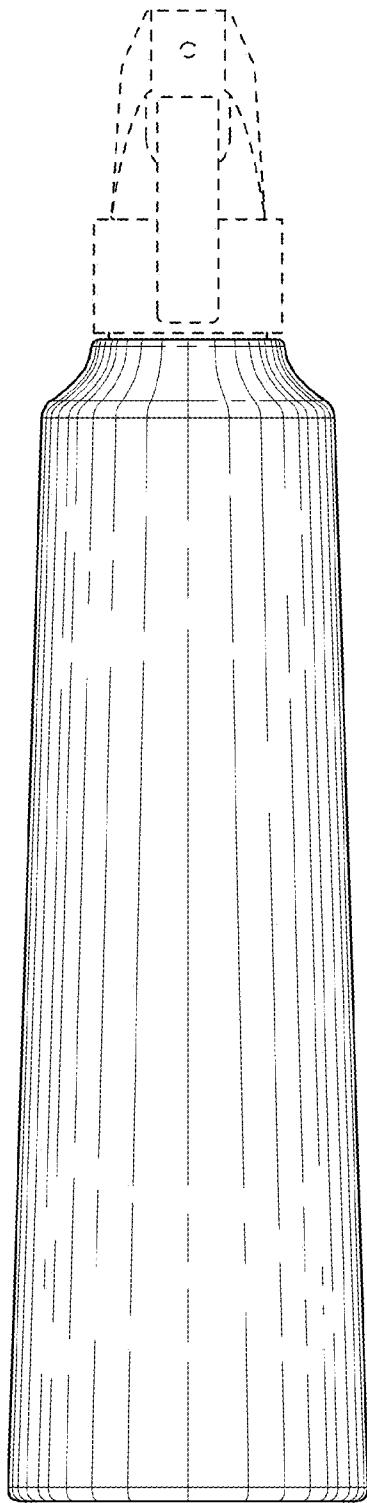

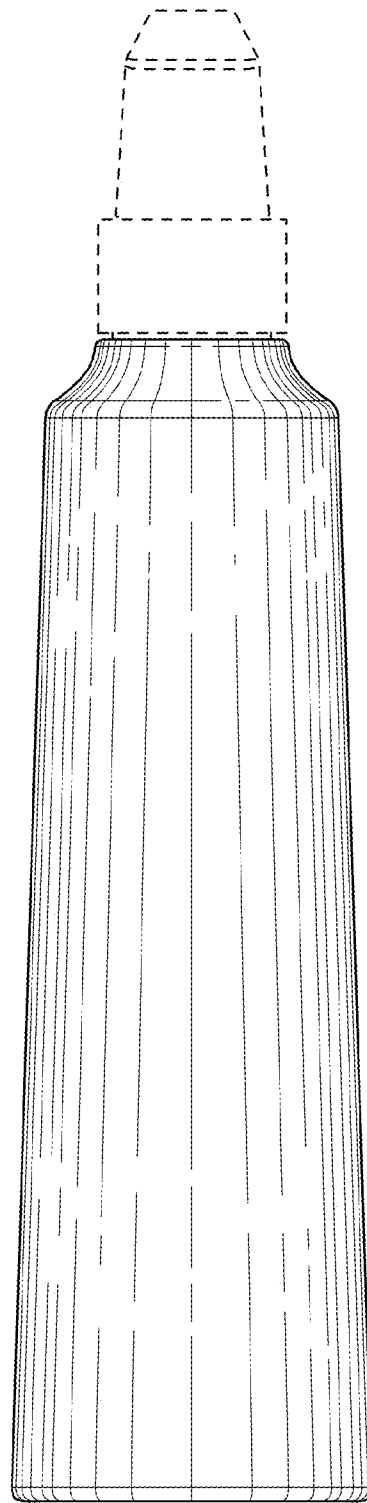

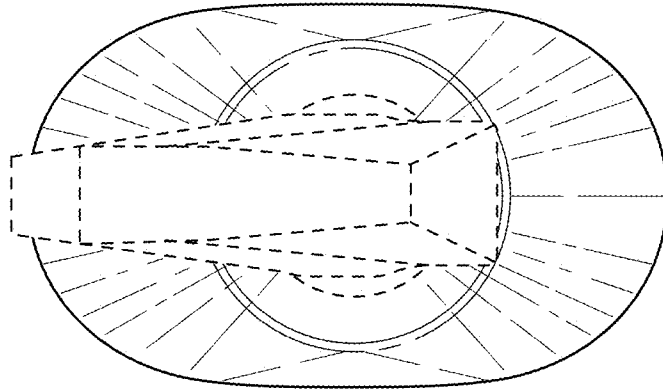

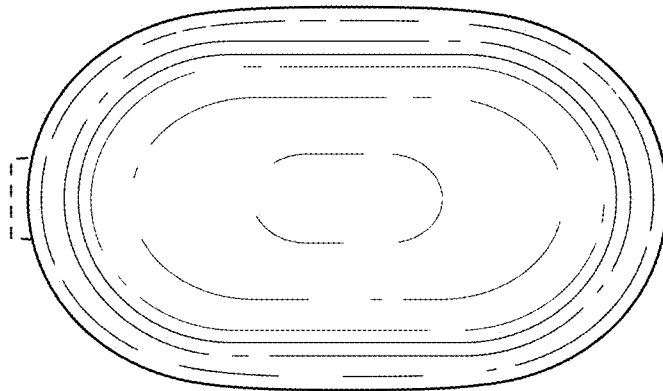

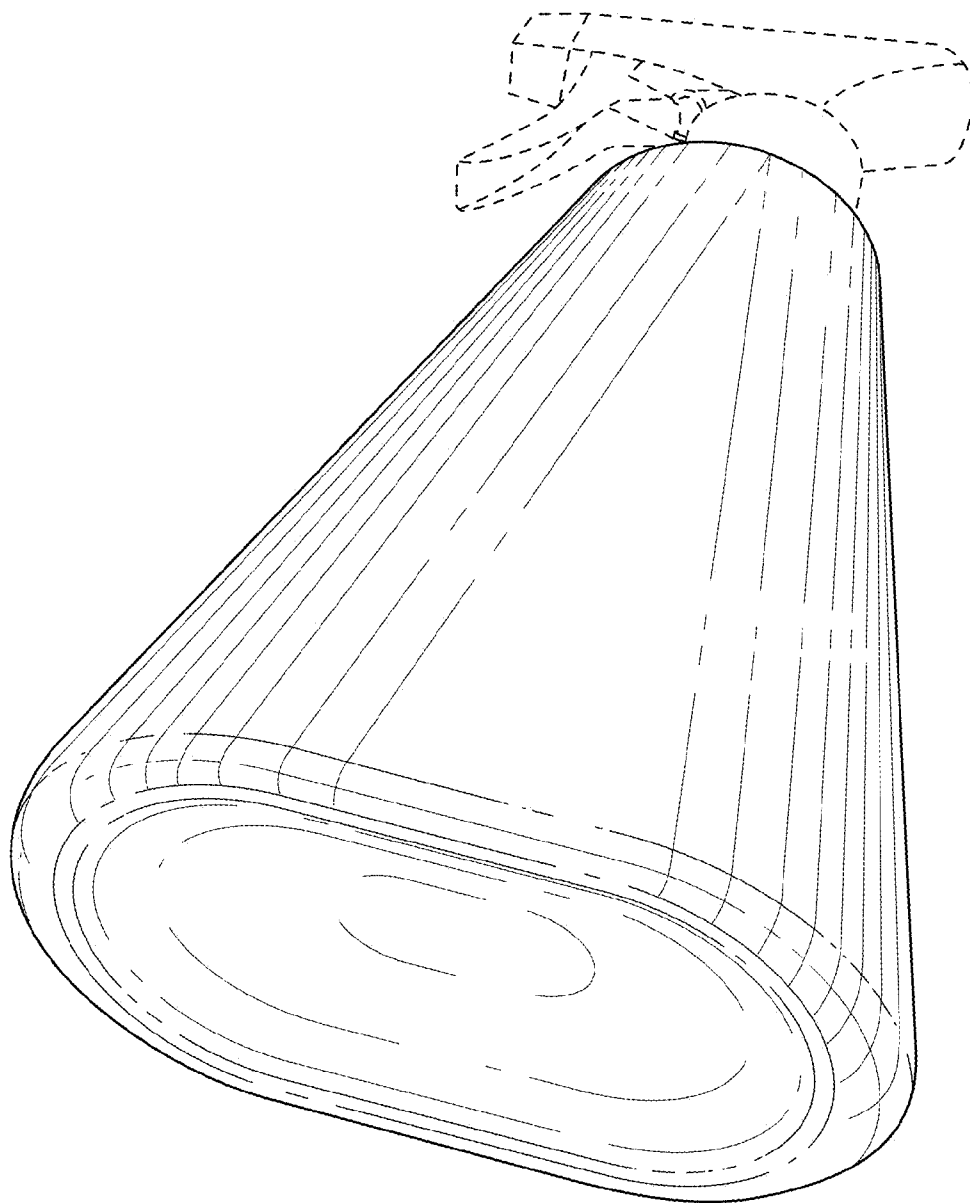
