
(57) **CLAIM**

The ornamental design for the cooker, as shown and described in the accompanying figures.

DESCRIPTION

FIG. 1 is a front view of a cooker in accordance with a preferred embodiment of the present invention; FIG. 2 is side view of the cooker, rotated ninety degrees from the front view of FIG. 1, the opposite side being symmetric thereto; FIG. 3 is a rear view of the cooker, opposite the front view of FIG. 1; FIG. 4 is a top view of the cooker of FIG. 1; and, FIG. 5 is a front perspective view of the cooker of FIG. 1. The broken lines identify objects that form no part of the claimed design.










