

(57) Abstract: Pin probes (102) and pin probe arrays (102) are provided the allow electric contact to be made with selected electronic circuit components. Some embodiments include one or more compliant pin elements (202) located within a sheath (204). Some embodiments include pin probes (402) that include locking or latching elements (414) that may be used to fix pin portions of probes (402) into sheaths (406). Some embodiments provide for fabrication of probes using multi-layer electrochemical fabrication methods.
