
(57) **CLAIM**

The ornamental design for a patient interface, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a patient interface showing a first embodiment of our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; FIG. 8 is an enlarged perspective view; FIG. 9 is a front perspective view of a patient interface showing a second embodiment of our new design; FIG. 10 is a front view thereof; FIG. 11 is a rear view thereof; FIG. 12 is a top view thereof; FIG. 13 is a bottom view thereof; FIG. 14 is a left side view thereof; FIG. 15 is a right side view thereof; and, FIG. 16 is an enlarged perspective view. The combination of line shading and stippling is intended to convey a contrast in appearance/materials. The broken lines represent portions of the patient interface that form no part of the claimed design.




























