
The ornamental design for a remote control, as shown and described.

DESCRIPTION

FIG. 1 is a front, upper, right perspective view of a remote control of our new design;
FIG. 2 is a rear, lower, left perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right view thereof;
FIG. 6 is a left view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a top view thereof.

Broken lines of equal length (e.g., dash-dash) represent unclaimed portions of the remote control and form no part of the claimed design. The remote control is shown with broken line symbolic breaks in its height and width. The appearance of any portion of the article between these broken lines, including the broken lines themselves, forms no part of the claimed design.
















