The ornamental design for a vehicle headlight, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vehicle headlight according to the novel design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a back side view thereof;  
FIG. 6 an alternative perspective view thereof; and,  
FIG. 7 a top view thereof.

The drawings and descriptions represent the right side embodiment. The claim is also for a mirror image of a left side embodiment that is not shown.


The broken lines shown in the drawings represent portions of the vehicle headlight that form no part of the claimed design.














