

#### (54) Title: METHODS AND APPARATUS FOR EXCHANGING METALS



(57) Abstract: Methods and apparatus for facilitating an exchange of ferrous, non-ferrous and platinum group metals via an electronic network. An authorized metal seller uploads information about the physical lots of metal derivative contracts, and preexisting credit relationships on an exchange server (104). Subsequently, an authorized metal buyer downloads the information (1218). The metal buyer may access other information (1208) and services such as price indices (512), hedging (516), and financing. If the metal buyer purchases a metal lot and/or a derivative contract, the appropriate accounts are updated and the parties are informed. The buyer and/or seller may also receive portfolio valuations and mark to market analysis (522). The process provides complete price transparency and allows for the exchange of metal derivative contracts which are cash settled and fully compliant with FAS133 (526).
