(57) **CLAIM**

The ornamental design for a skate board carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a skate board carrier of the present invention shown in use by a user. The user and exemplary skateboard are shown in phantom for illustrative purposes only, and are not a part of the claimed design.

FIG. 2 is a front elevational view of the skate board carrier shown in an in-use configuration.

FIG. 3 is a right side elevational view of the skate board carrier shown in an in-use configuration.

FIG. 4 is a rear elevational view of the skate board carrier shown in an in-use configuration.

FIG. 5 is a left side elevational view of the skate board carrier shown in an in-use configuration.

FIG. 6 is a top plan view of the skate board carrier shown in an in-use configuration.

FIG. 7 is a bottom plan view of the skate board carrier shown in an in-use configuration.

FIG. 8 is a front elevational view of the skate board carrier shown in an unfolded configuration; and,

FIG. 9 is a rear elevational view of the skate board carrier shown in an unfolded configuration.

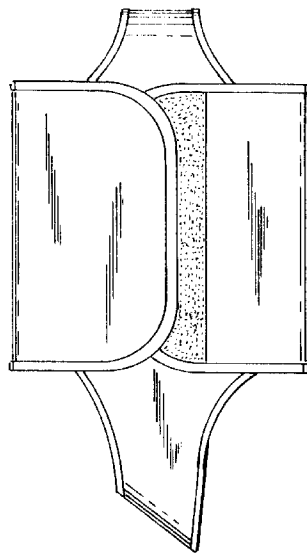
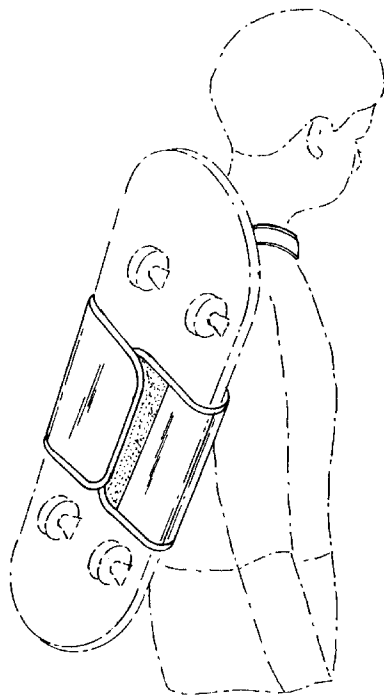

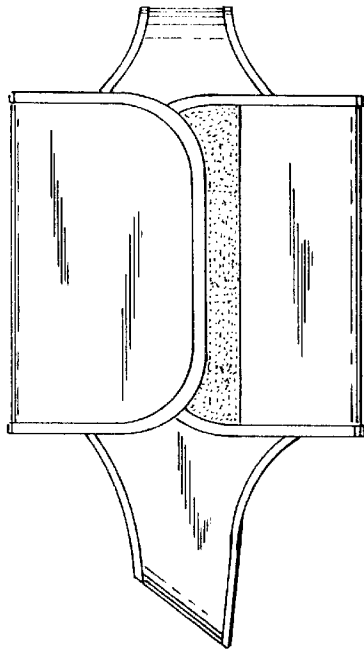

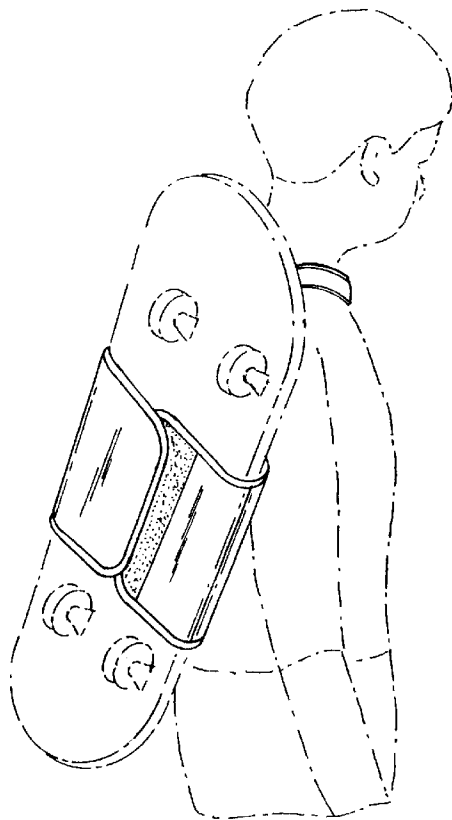
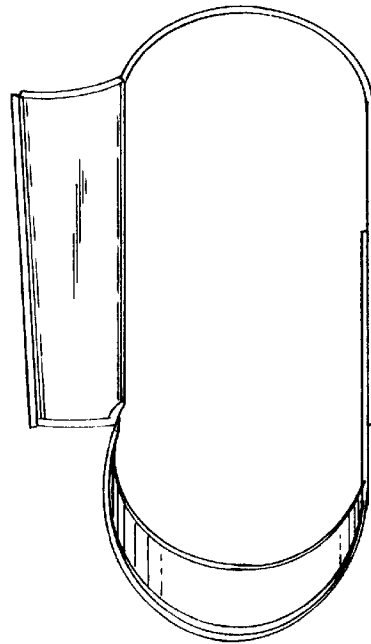

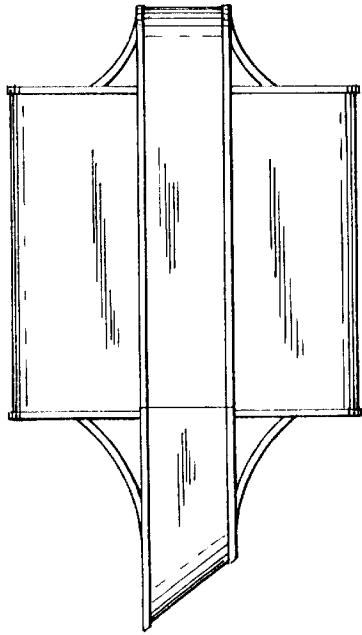

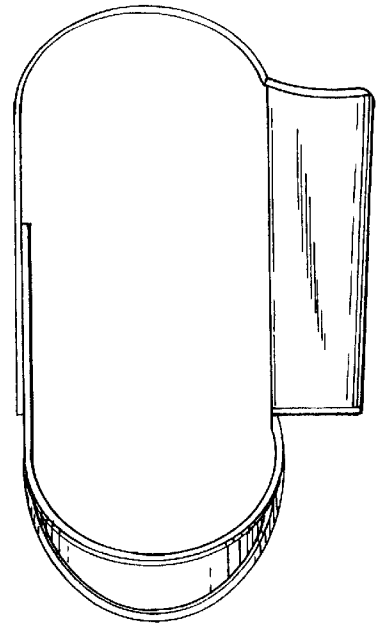

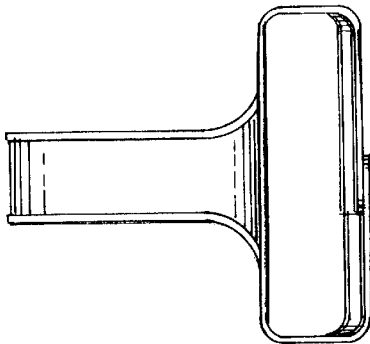

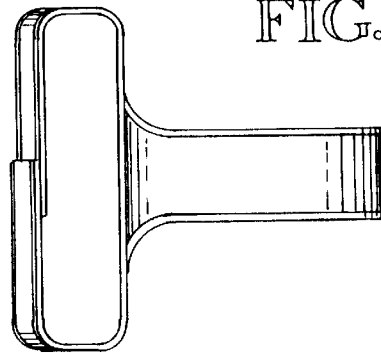
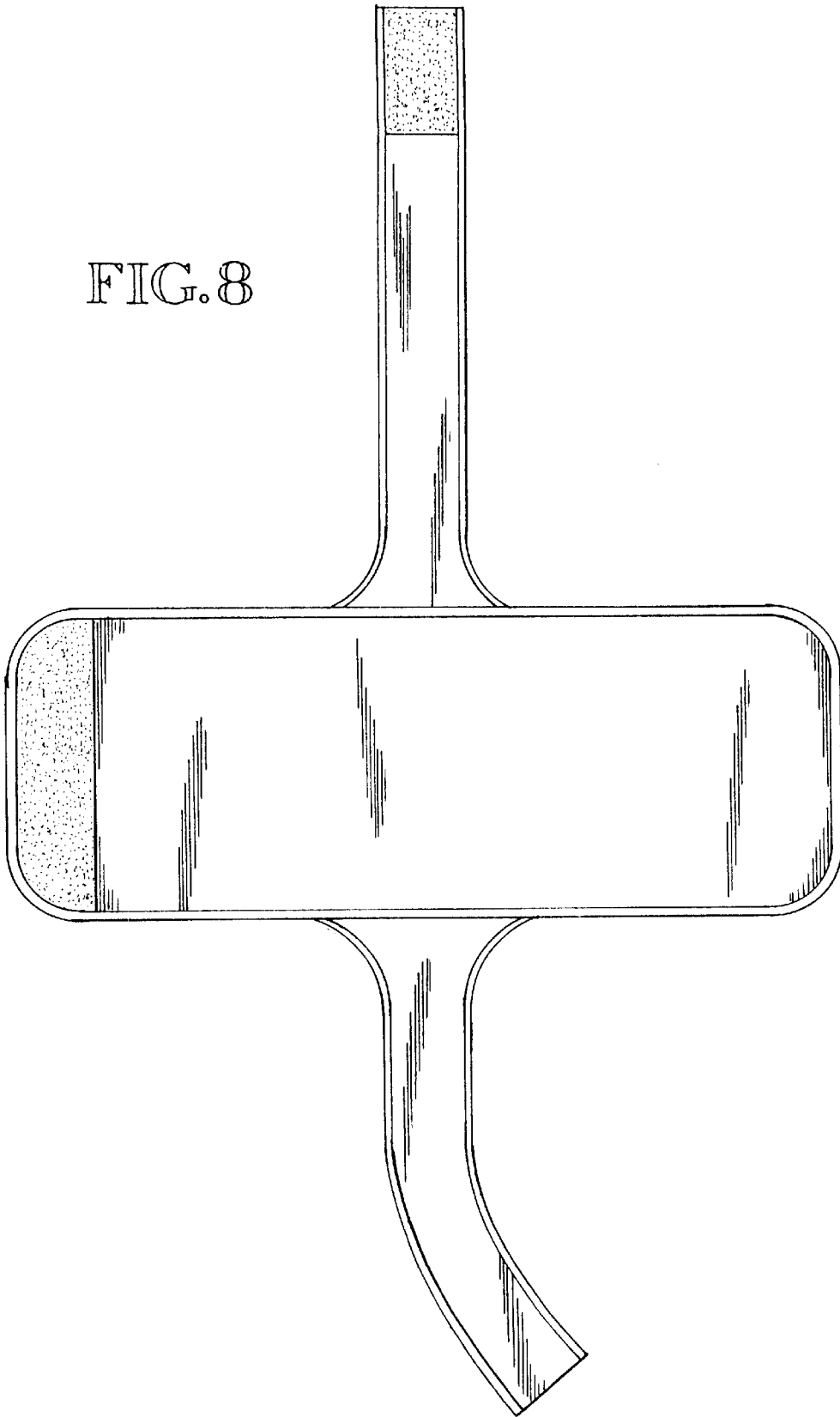

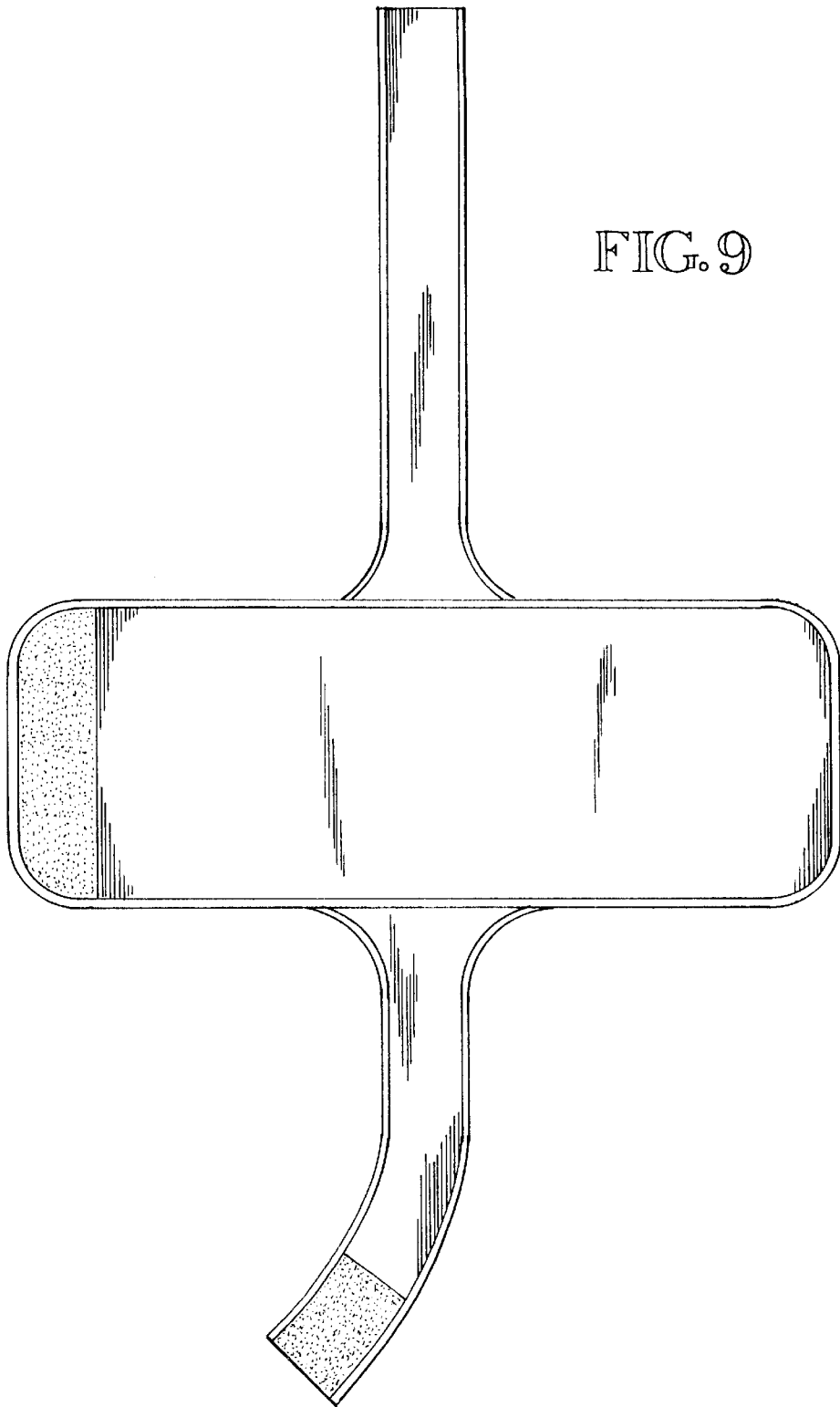
