(57) **CLAIM**

The ornamental design for a display screen or portion thereof with icon, as substantially shown and described.

**DESCRIPTION**

The single FIGURE is a front view of a display screen or portion thereof with icon showing our new design.

The broken line rectangle represents the bounds of the claimed design while all other broken lines are directed to portions of the icon; the broken lines form no part of the claimed design.

The bounds of the icon and the portion of the display screen upon which the design appears on are the same.
