(54) Title: VIRAL PROTEINS AS IMMUNOMODULATORY AGENTS AND VACCINE COMPONENTS

(57) Abstract: The invention provides compositions and methods involving viral envelope polypeptides and peptides for use in modulating immune responses, including inhibition inflammation related to pathogenic T-cell activation. In addition, modification of the viral sequences responsible for modulating immune response provides for improved vaccine formulations.
