**DESCRIPTION**

FIG. 2 is a longitudinal and elevational front view of a new design;

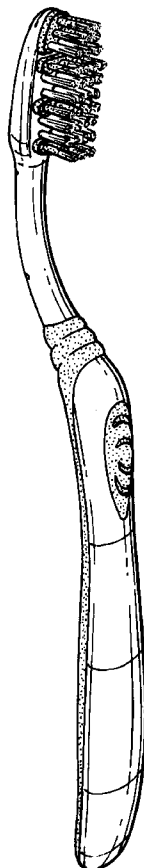
FIG. 3 is a longitudinal and elevational back view of a new design;

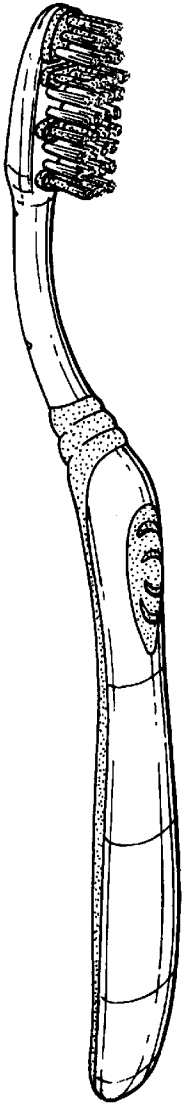

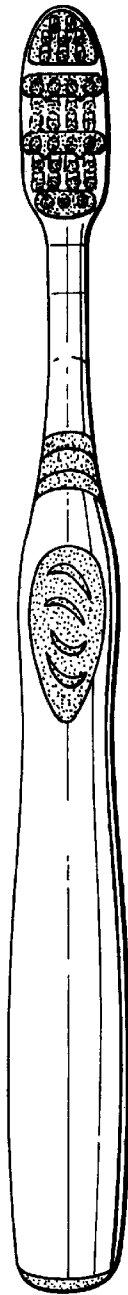

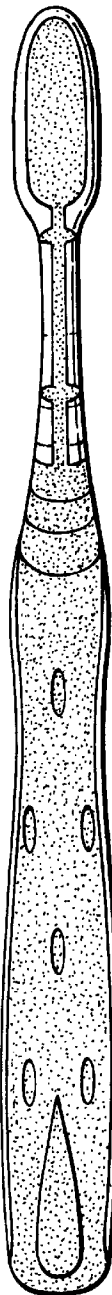

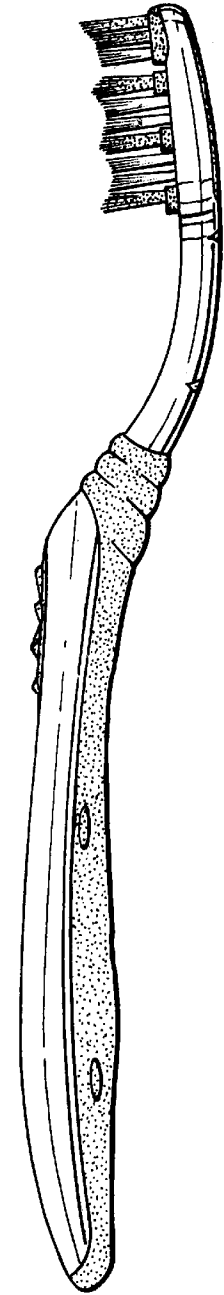

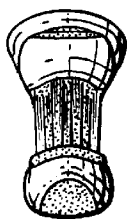

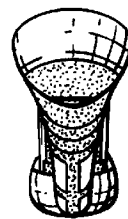
