DESCRIPTION

FIG. 1 is a general perspective view of a left shoe sole showing our new design, the right shoe sole (not shown), being a minor image thereof;

FIG. 2 is a front view thereof;

FIG. 3 is rear view thereof;

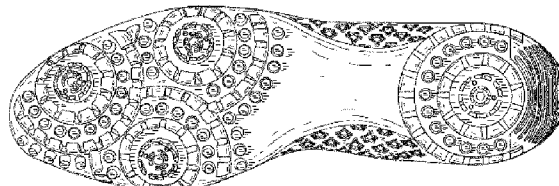
FIG. 4 is an outer side elevational view thereof;

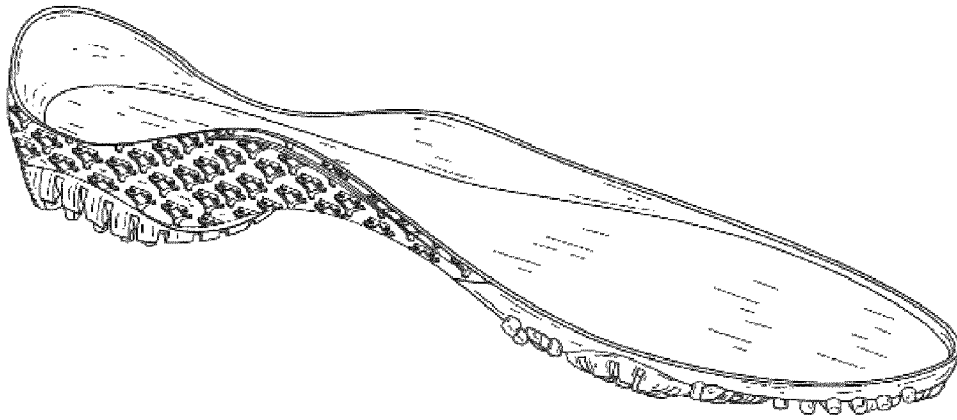

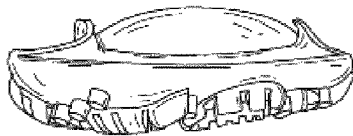

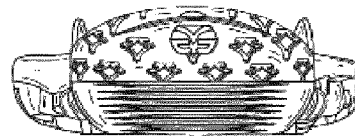

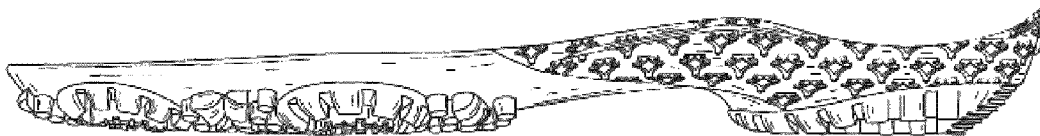

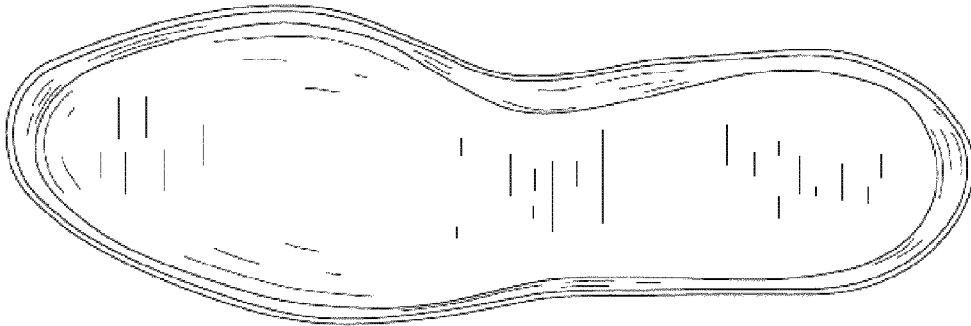

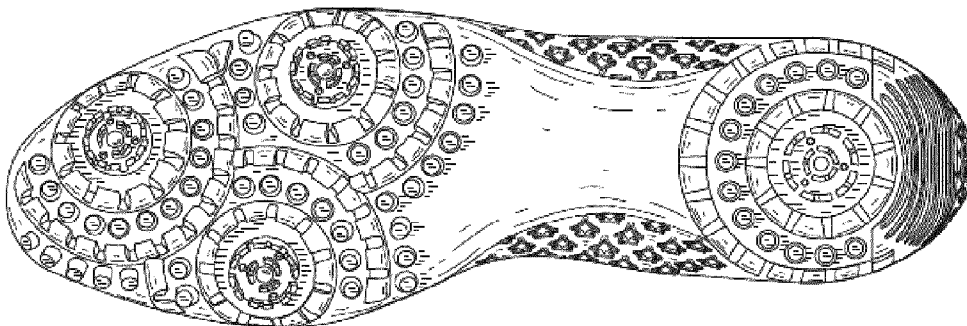
