

(57) **CLAIM**

We claim, the ornamental design for a telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a telephone showing our new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a side view thereof;  
 FIG. 5 is another side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is another side view thereof, in which the telephone is shown in another position;  
 FIG. 9 is another side view thereof, in which the telephone is shown in another position showing the base portion detached, rotated 180 degrees, and reattached to the opposite inclined surface; and,  
 FIG. 10 is another front view thereof, in which the telephone is shown in a module inclusive environment.  
 The broken lines illustrating portions of the telephone are for environmental purposes only and form no part of the claimed design.


















