The ornamental design of a wearable towel, as shown and described.

**DESCRIPTION**

FIG. 2 is a side view along the length of the wearable towel of the present invention; and,

FIG. 3 is a side view along the width of the wearable towel of the present invention.

In the drawings, the broken lines represent stitching.

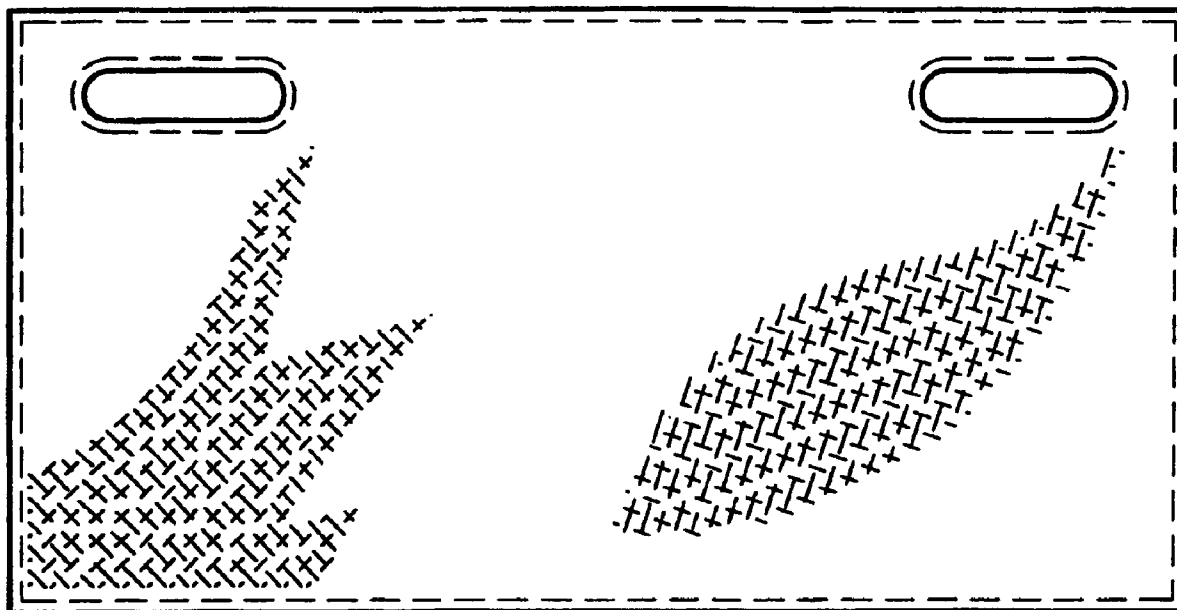

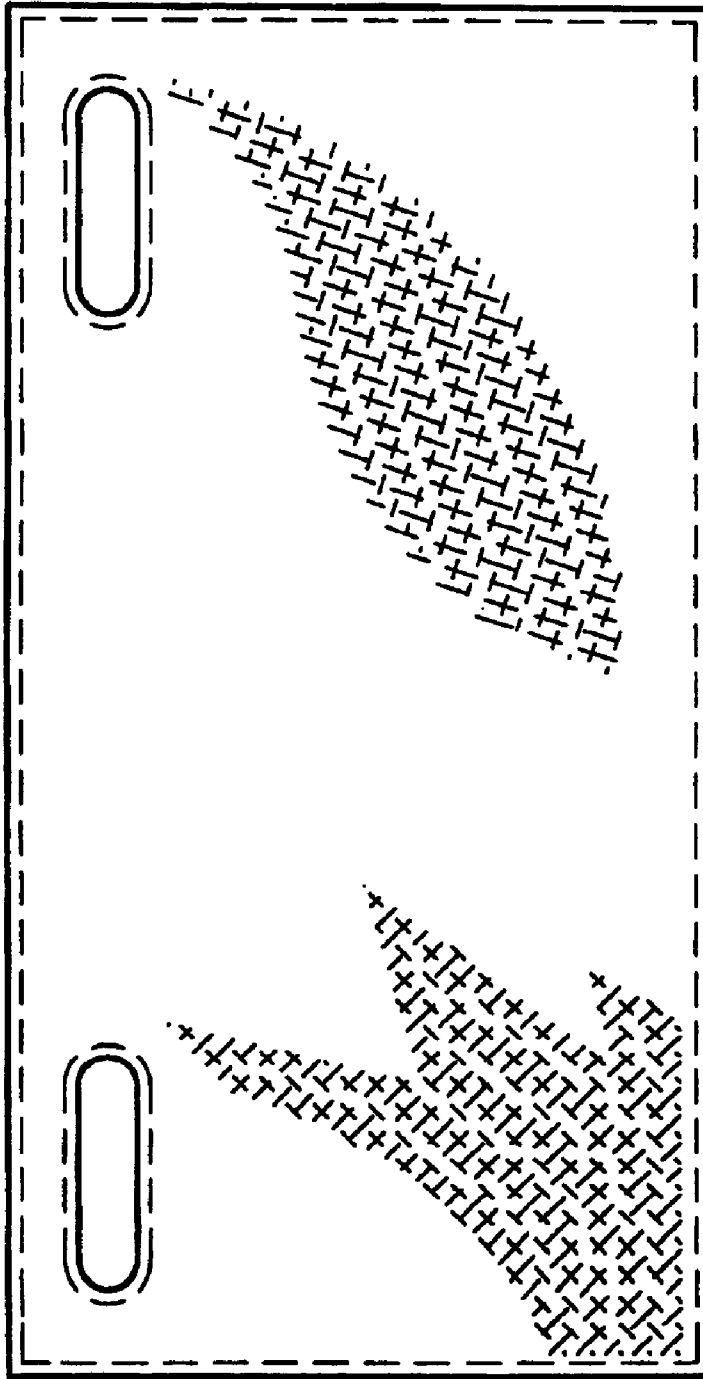
