(57) **CLAIM**

The ornamental design of a connecting device for pipe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the connecting device for pipe showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a rear perspective view thereof; FIG. 9 is a bottom-rear perspective view thereof; and, FIG. 10 is a cross-sectional view taken through line 10-10 shown in FIG. 2.

The connective device for which the design of shape and configuration is claimed is a device which fastens or fixes two pipes.





















