

FIG. 2 is a front elevation view thereof;
FIG. 3 is a left side elevation view thereof, a right side elevation view thereof being a mirror image;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines in the figures are for the purpose of showing environmental structure and form no part of the claimed design.












