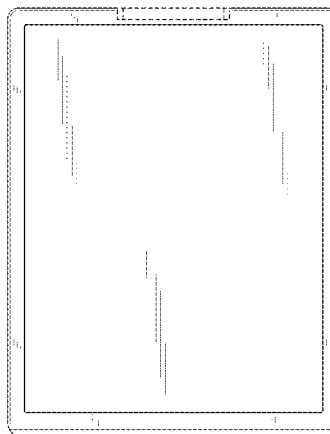
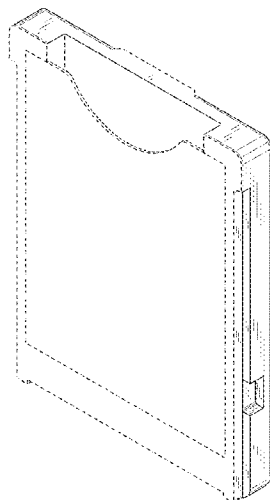
(57) **CLAIM**

The ornamental design for a memory card adapter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a memory card adapter showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. Portions in broken lines are for illustrative purposes only and form no part of claimed design. Dot-dash broken lines define boundaries of, but are not included in, the claimed design.

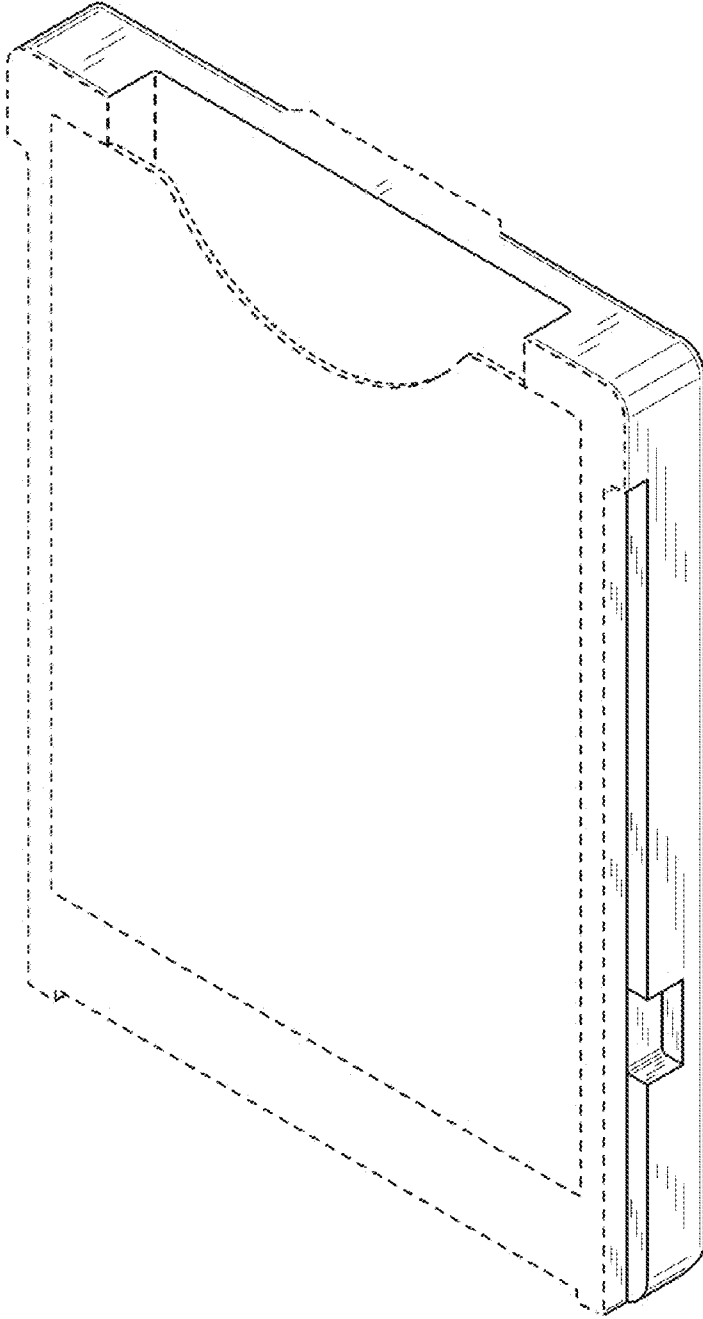

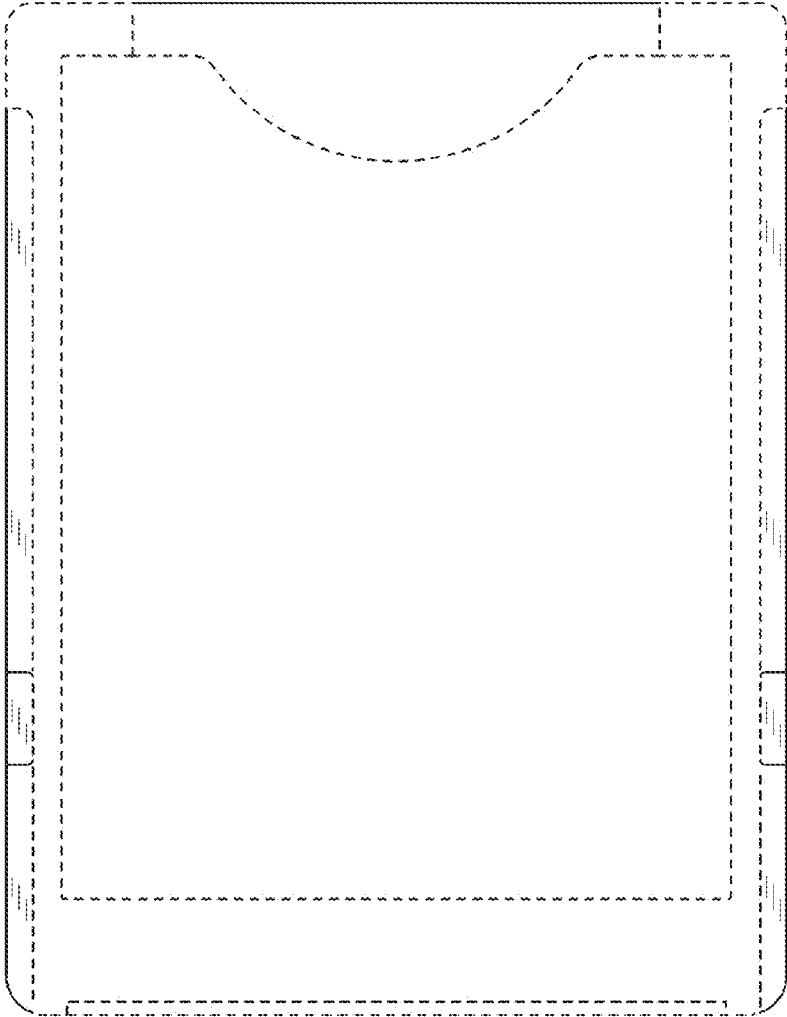

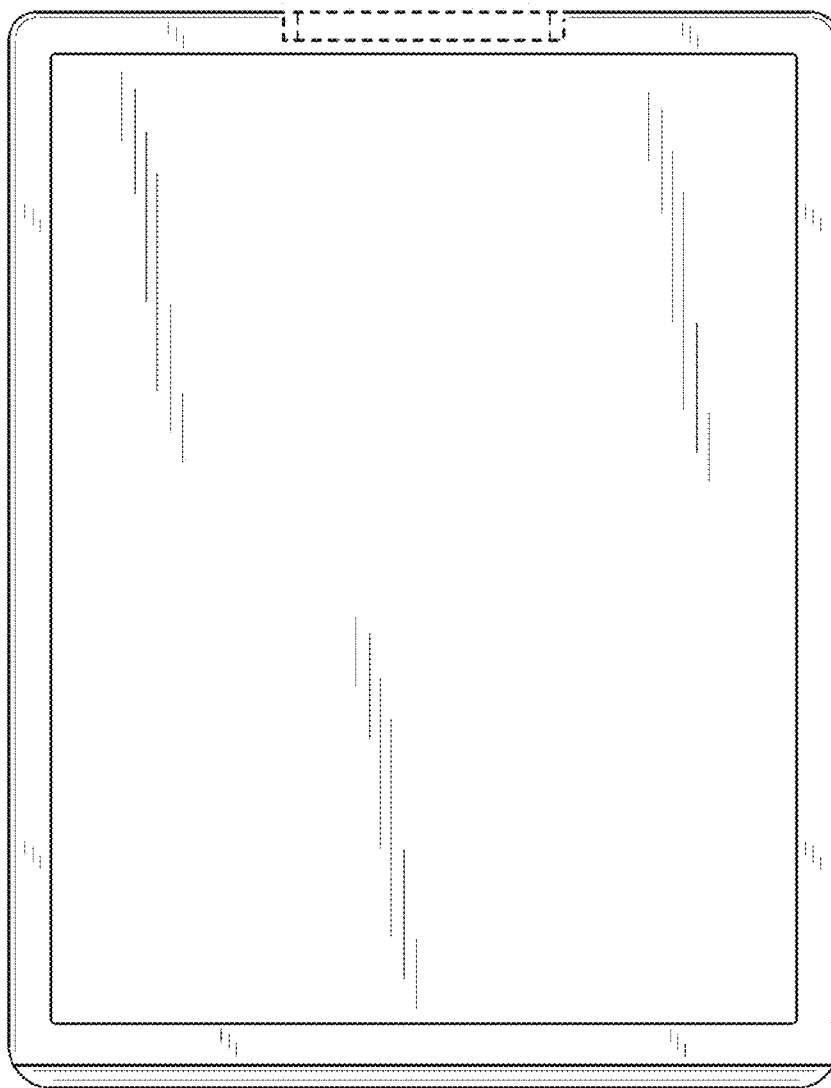

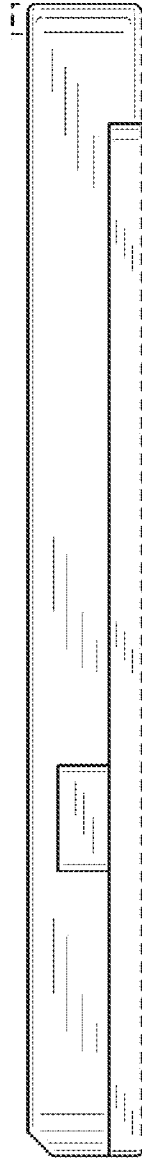

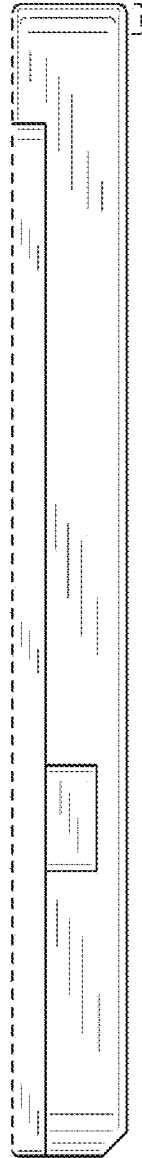

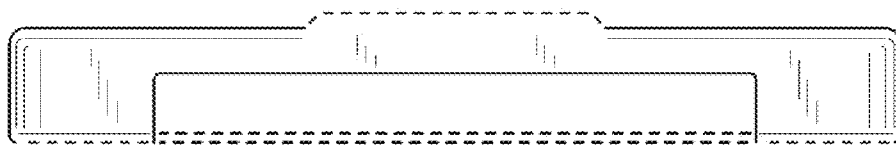
