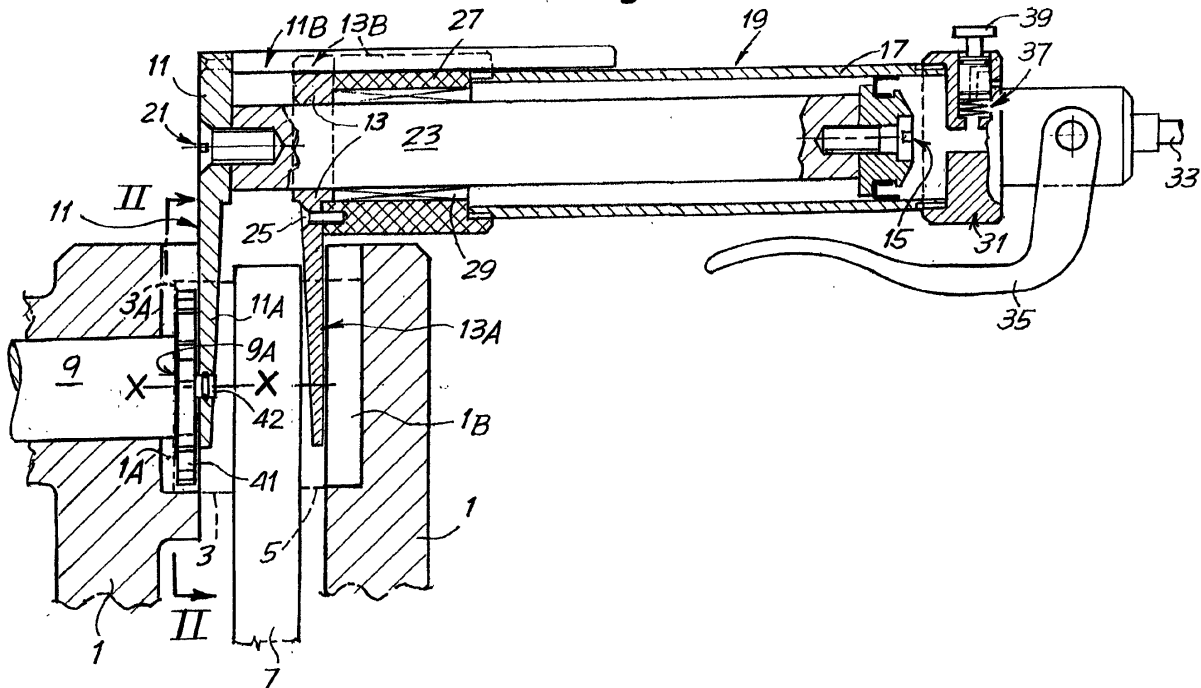

(54) **Tool for use in replacing the pads of disk brakes**

(57) The tool comprises a pair of tapered spreader elements (11, 13) which are integral, respectively, with the piston (15) and with the cylinder (17) of an air jack

(19); guide means (11B, 13B) keep the elements (11, 13) facing each other in the same angular position with respect to each other.
