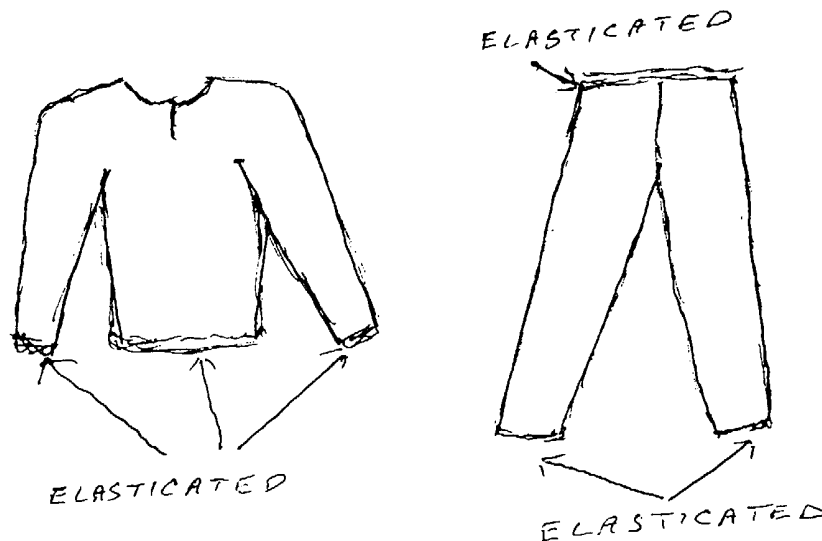

(54) Abstract Title

The garments retain body heat and circulates the warm air around the body, in doing so the garments relieves aching muscles and bones and assists arthritis sufferers and weight loss.

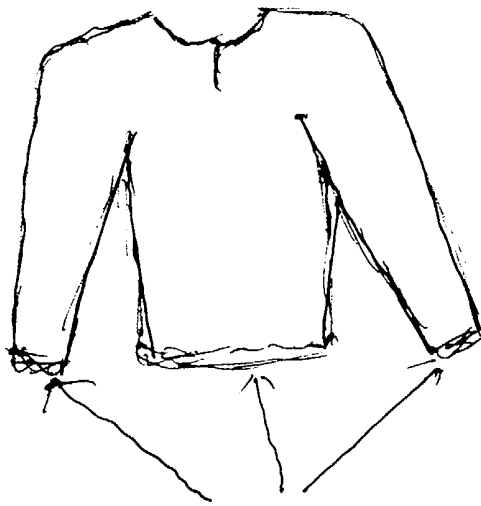

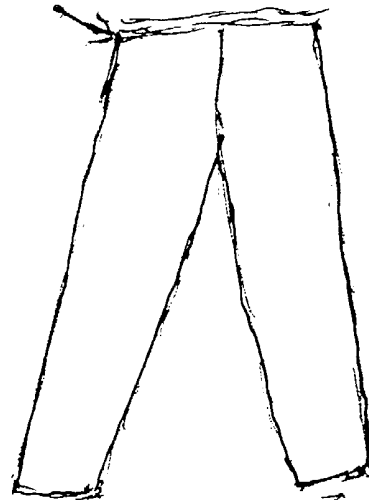
