(57) **CLAIM**

The ornamental design for a hair drier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the hair drier showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a left view thereof where the right view is a mirror image;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a back perspective view thereof.

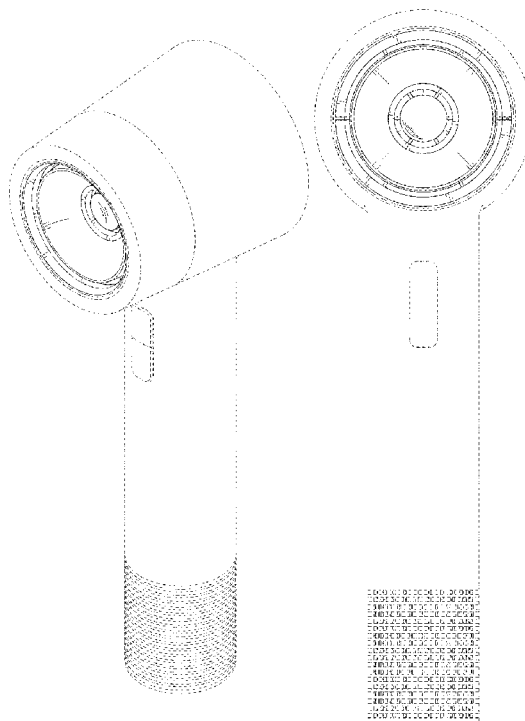

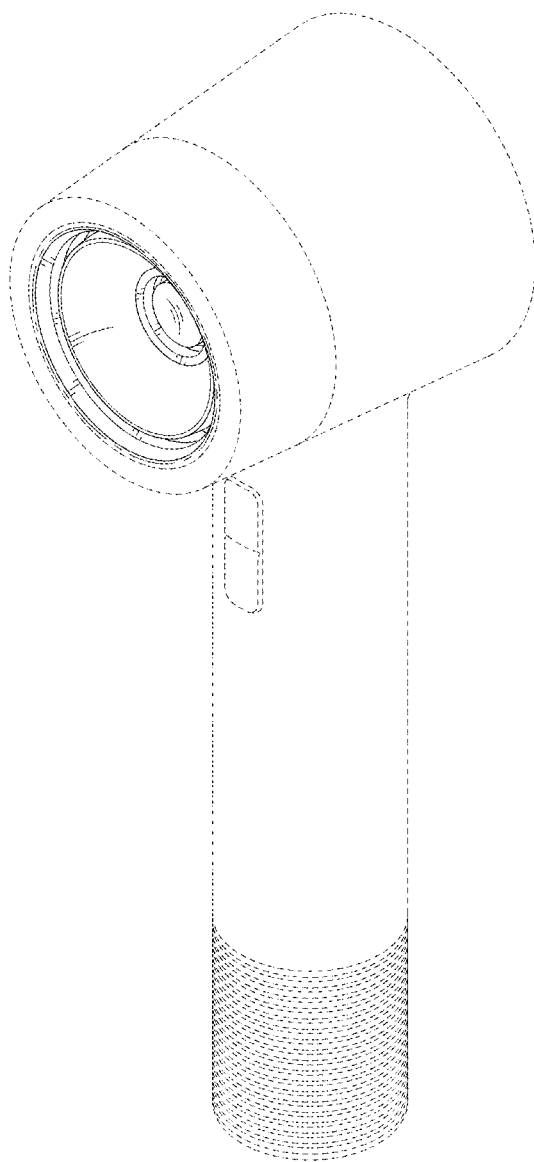

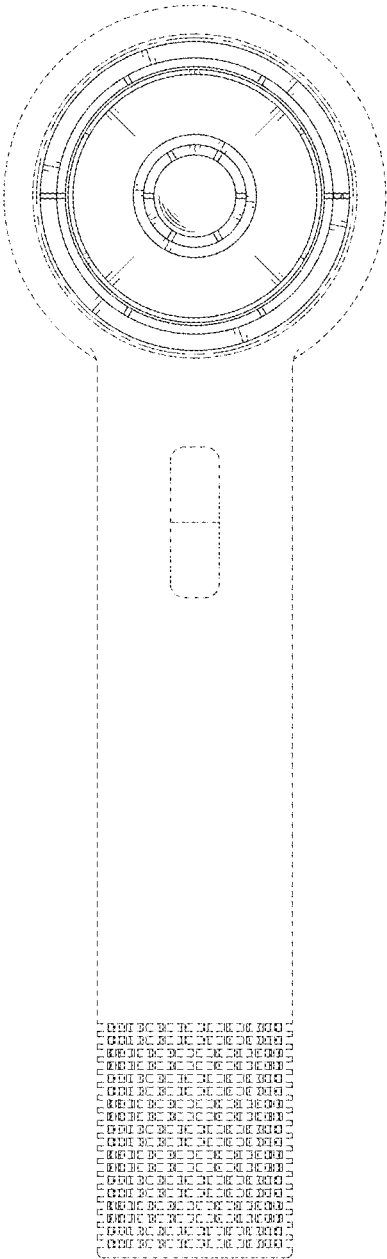

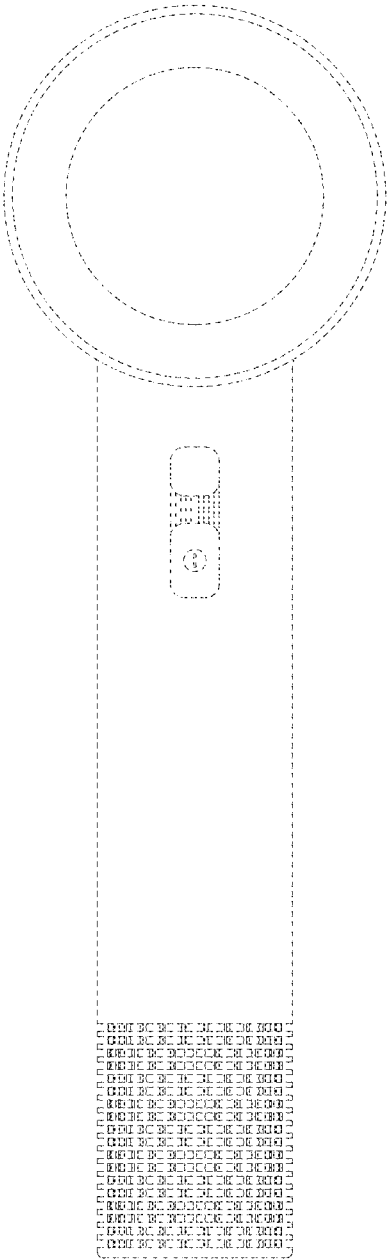

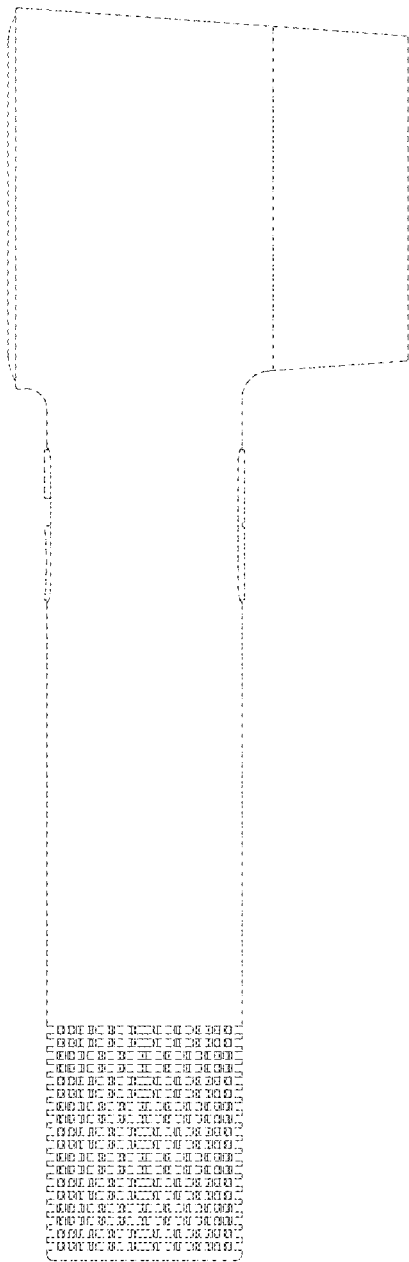

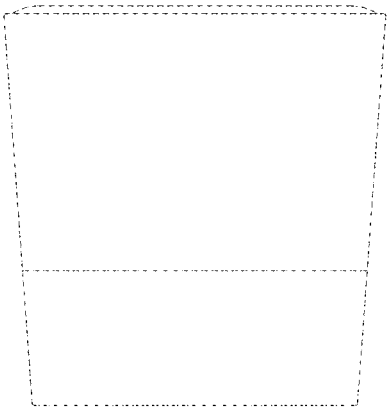

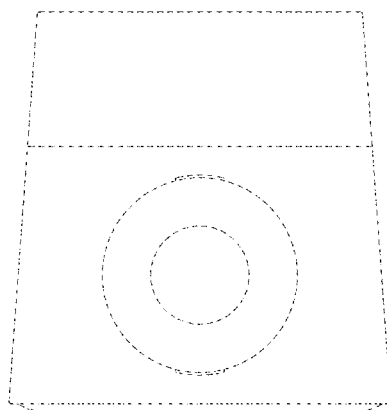
