(57) **CLAIM**

The ornamental design for a baby burp cloth, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a baby burp cloth according to our new design;

FIG. 2 is a bottom plan view of the baby burp cloth shown in FIG. 1;

FIG. 3 is a top plan view of the baby burp cloth shown in FIG. 1;

FIG. 4 is a left side elevation view of the baby burp cloth shown in FIG. 1;

FIG. 5 is a right side elevation view of the baby burp cloth shown in FIG. 1;

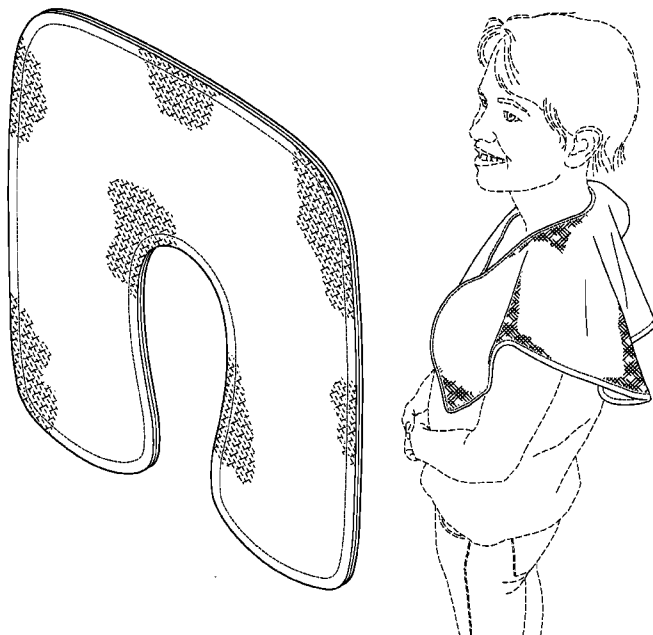
FIG. 6 is a front elevation view of the baby burp cloth shown in FIG. 1;

FIG. 7 is a rear elevation view of the baby burp cloth shown in FIG. 1; and,

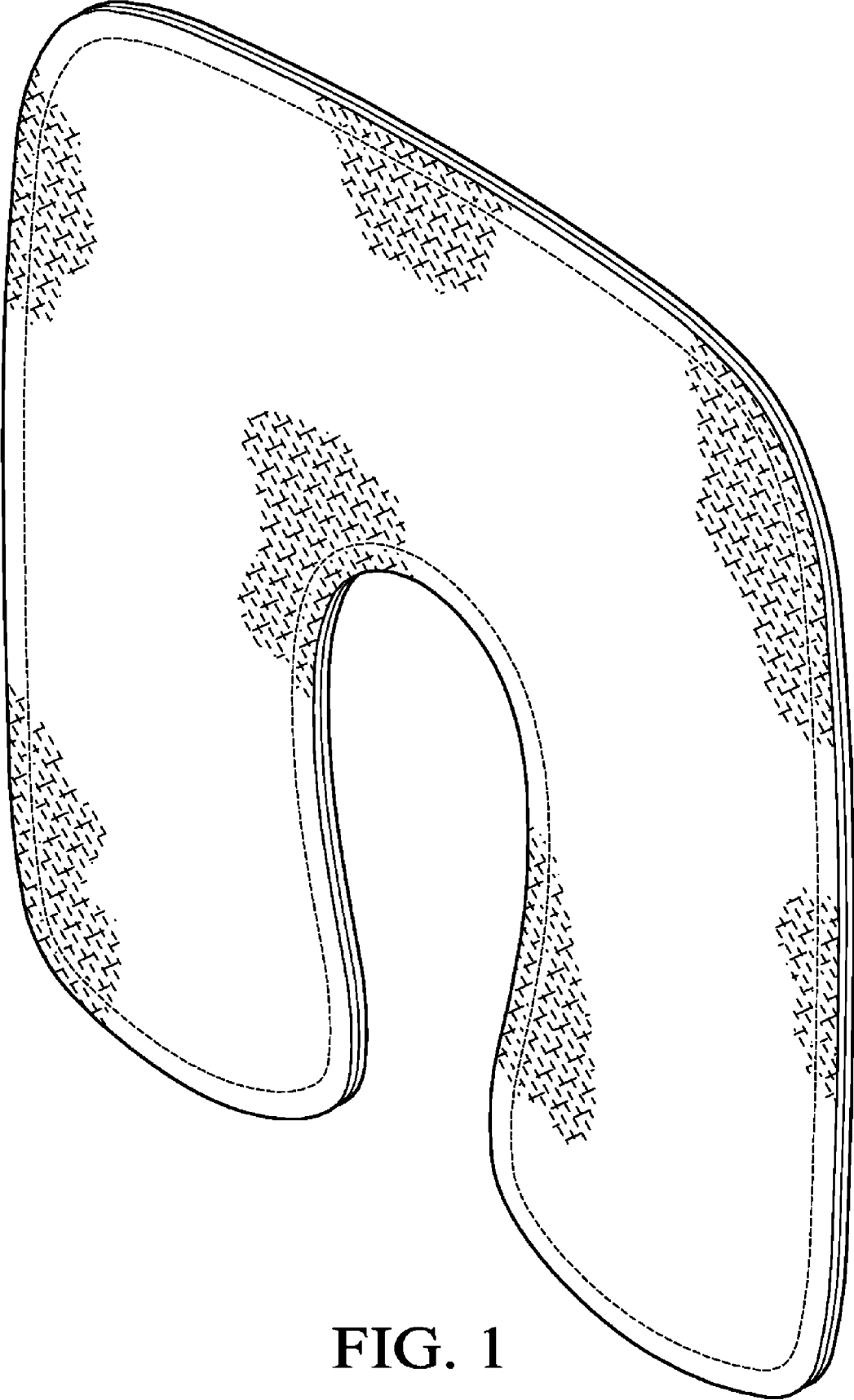

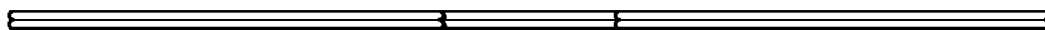

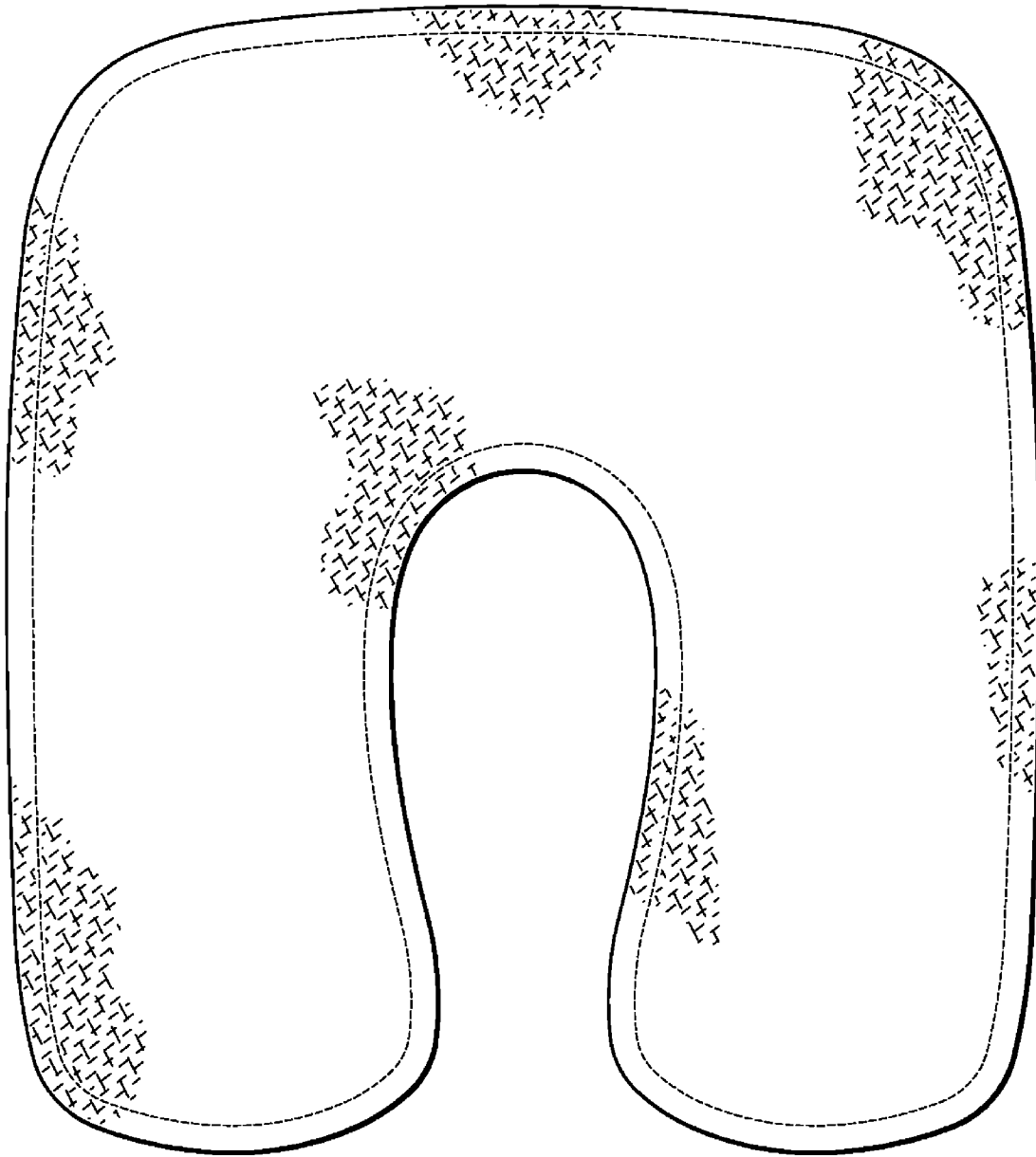

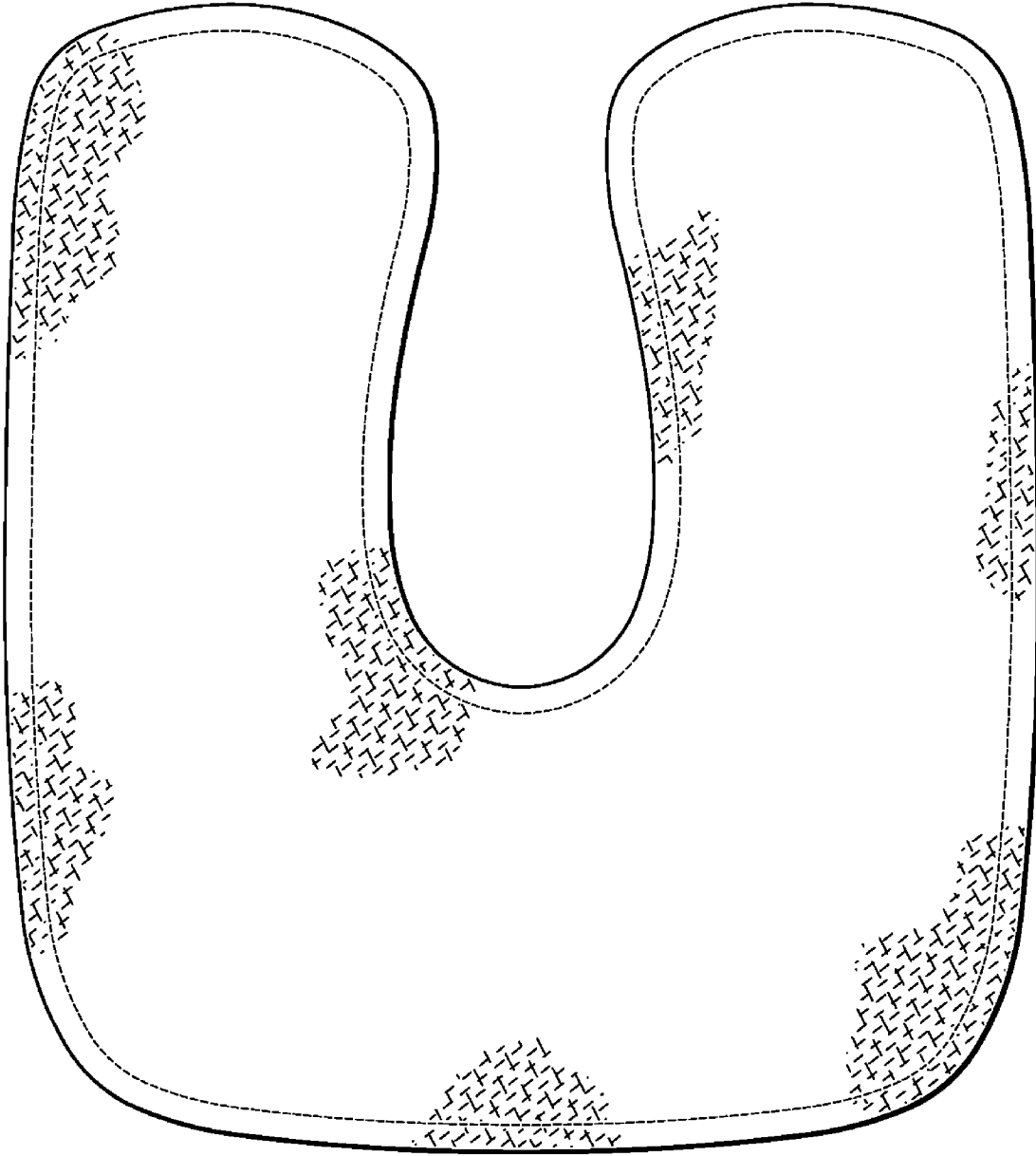

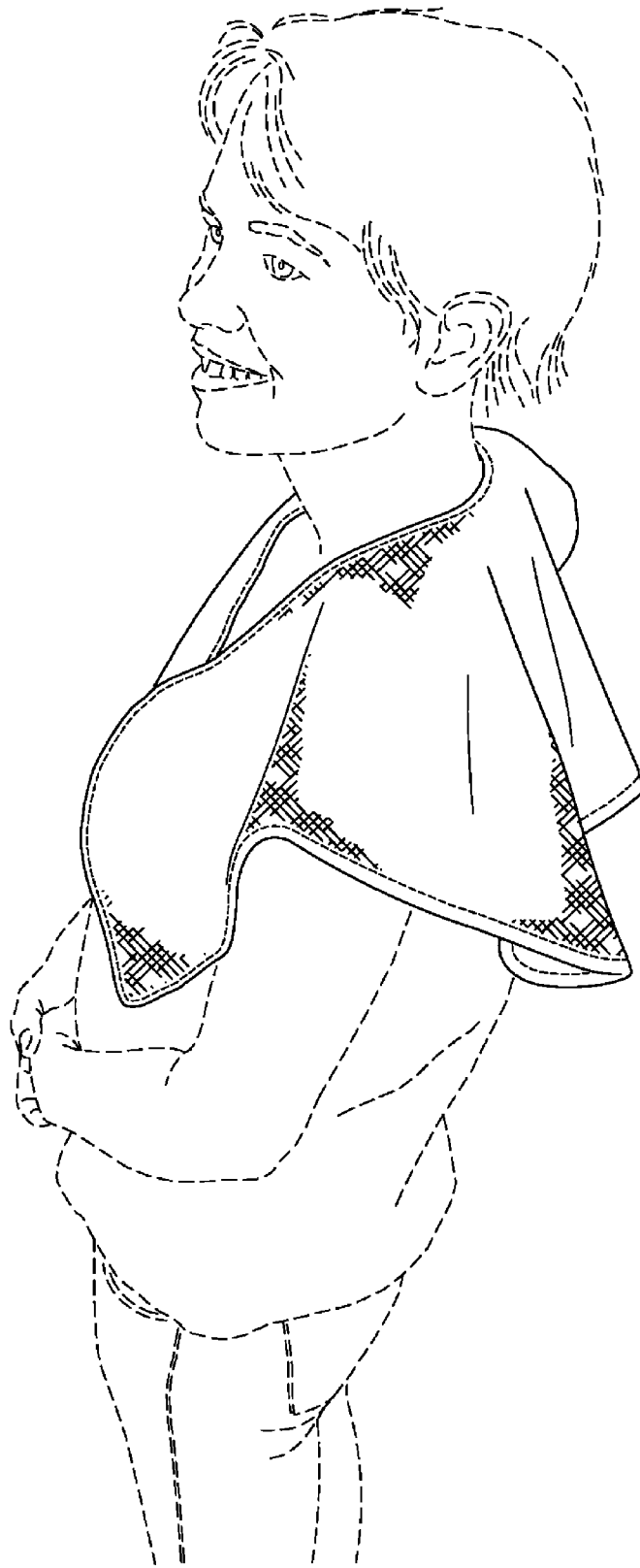
