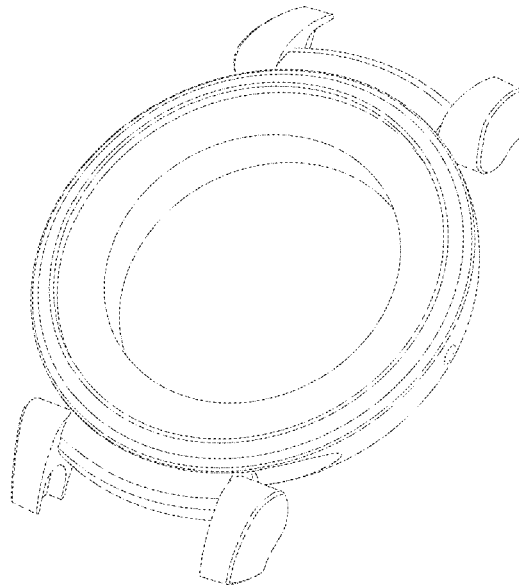
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front plan view of a watch case showing my new design;

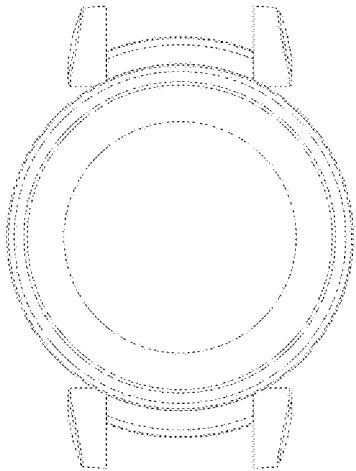

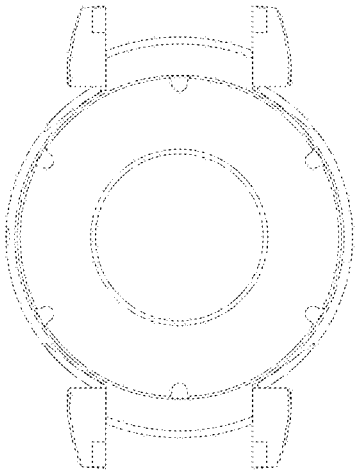

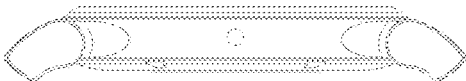

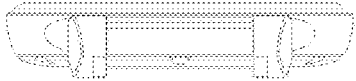

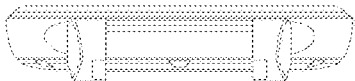

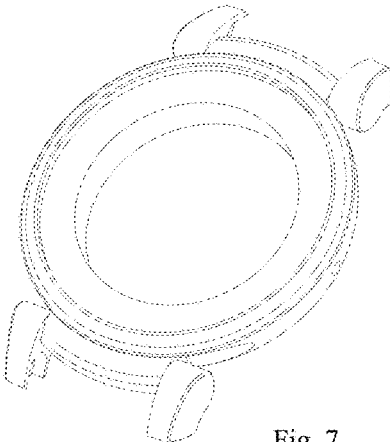
