(57) **CLAIM**

I claim the ornamental design for a cold weather glove with side elastic opening for temporary performance of task requiring exposed hand, as shown and described.

DESCRIPTION

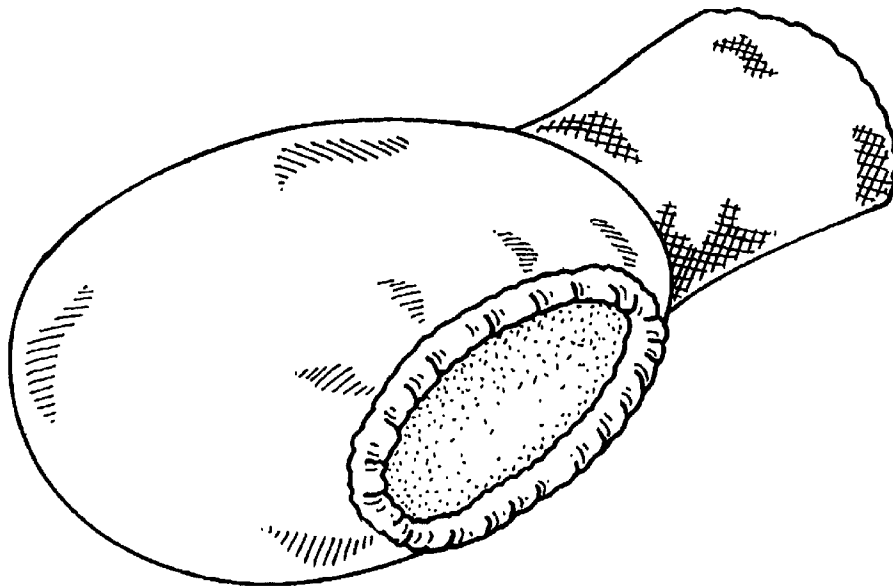
FIG. 1 is a perspective view of a cold weather glove with side elastic opening for temporary performance of task requiring exposed hand showing my new design; FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is an elevational view of the opposite side thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a reduced perspective view showing the cold weather glove with side elastic opening for temporary performance of task requiring exposed hand in use; the broken lines show environmental structure for illustrative purposes only and form no part of the claimed design.

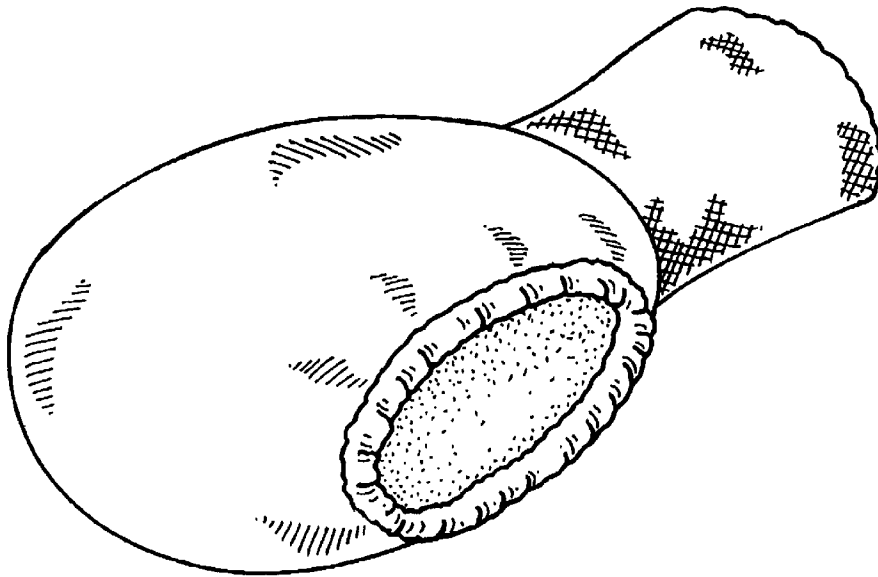

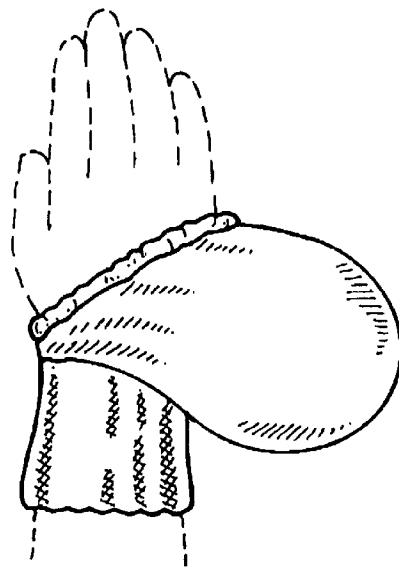

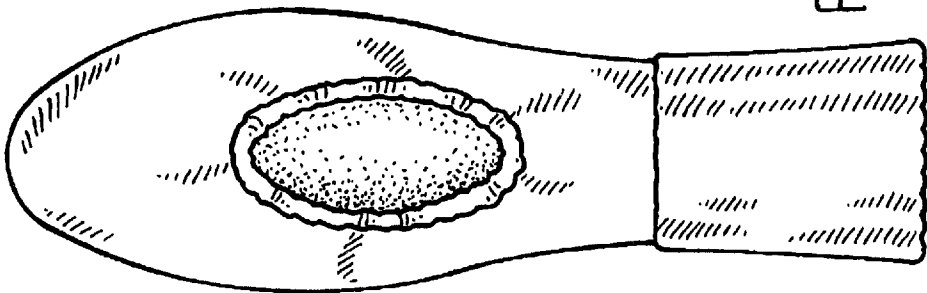

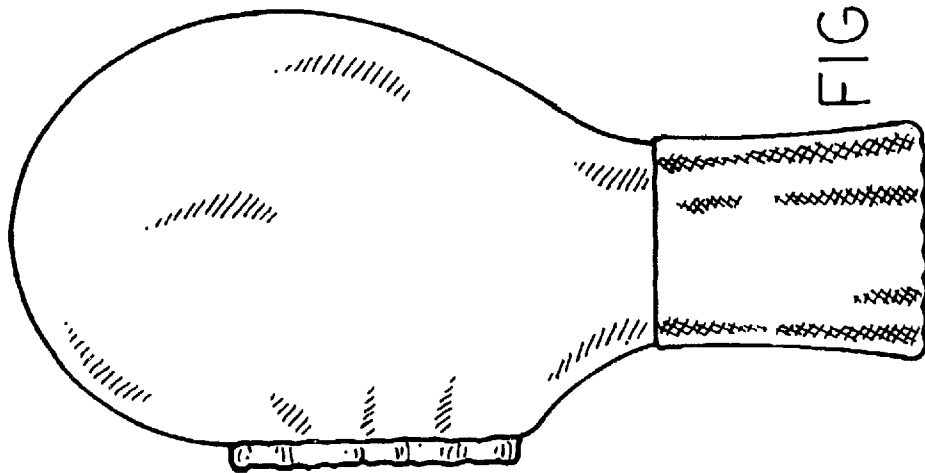

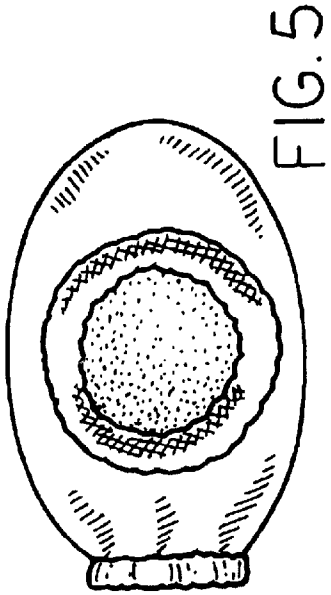

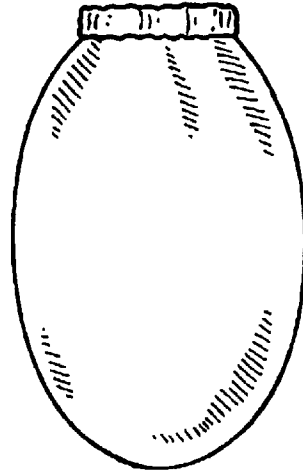

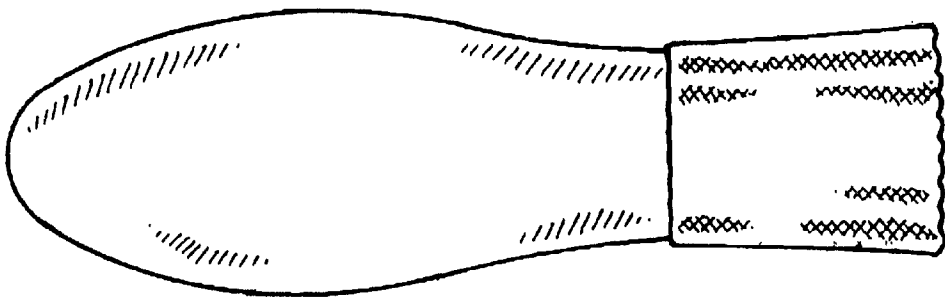
