described.

DESCRIPTION

FIG. 1 is a front, top, and right perspective view of a torque
limiter;

FIG. 2 is a front, bottom, and left perspective view thereof;

FIG. 3 is a front view thereof, a back view being a mirror
image of the front view;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

The broken lines show portions of a torque limiter that form
no part of the claimed design.

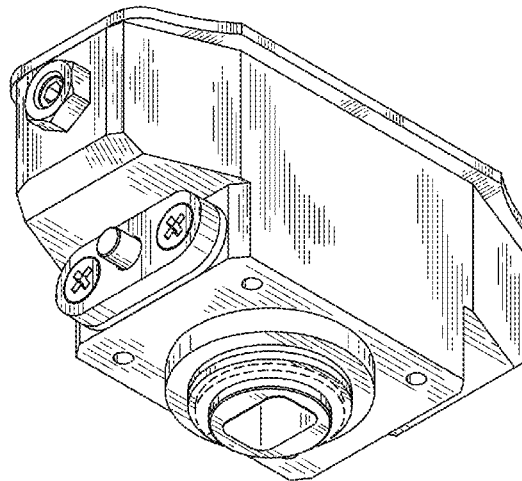
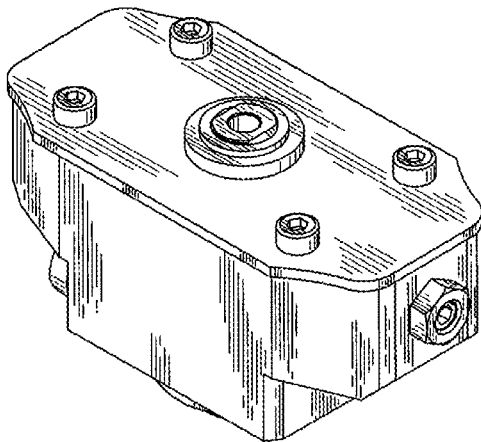

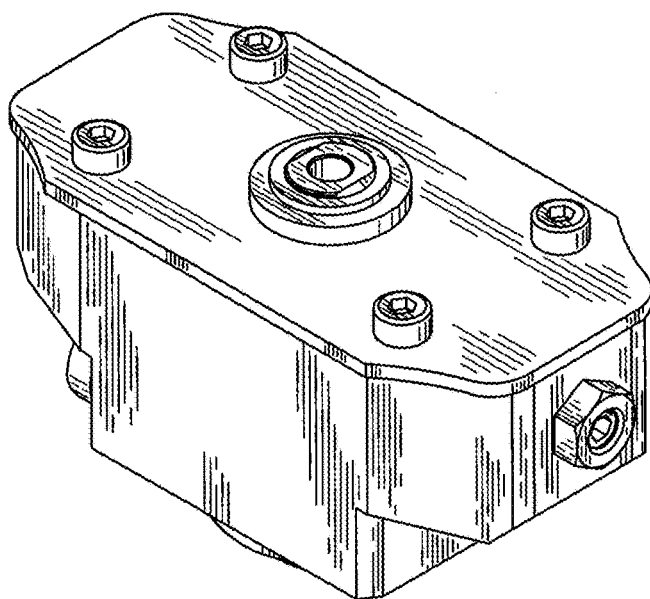

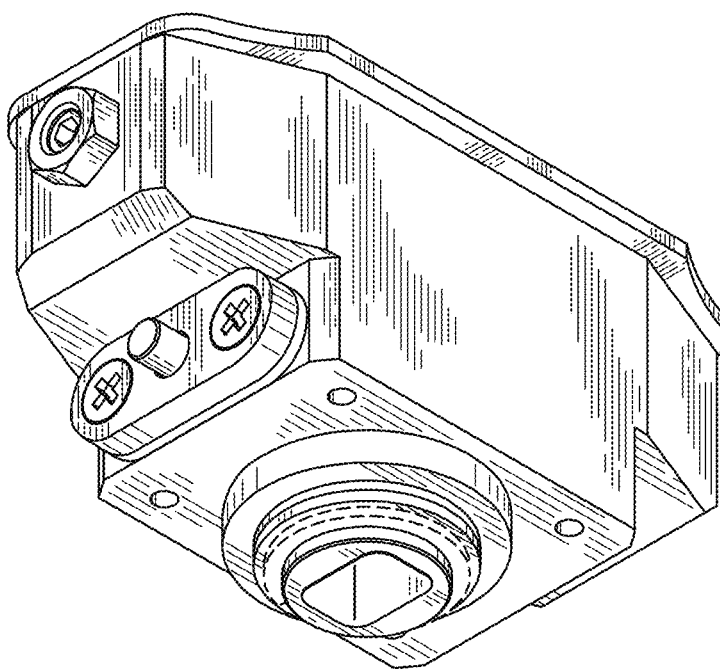

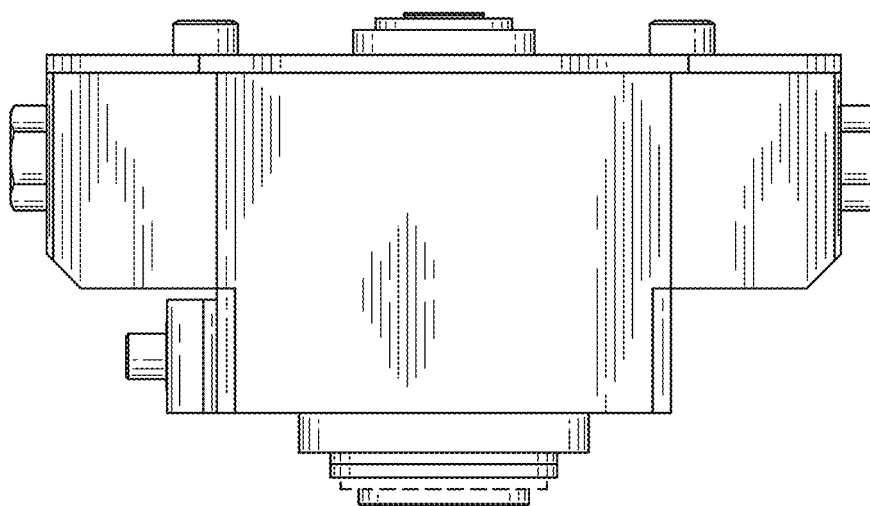

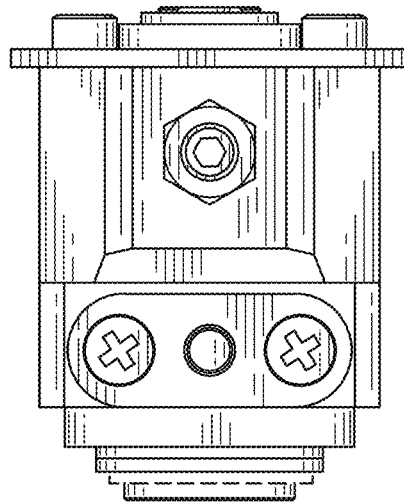

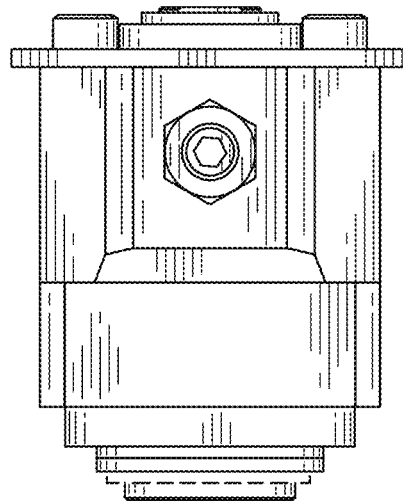

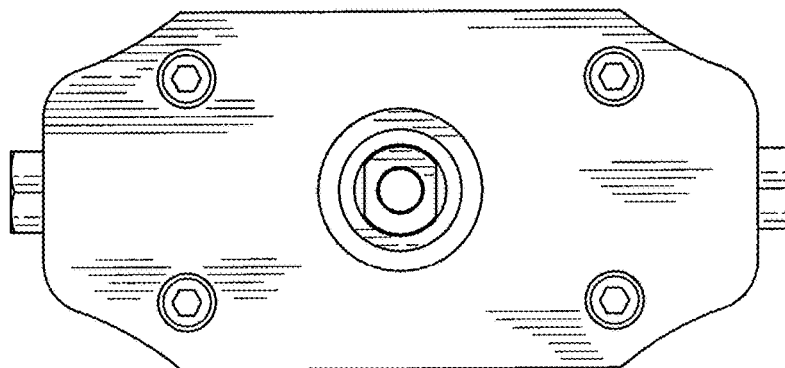
