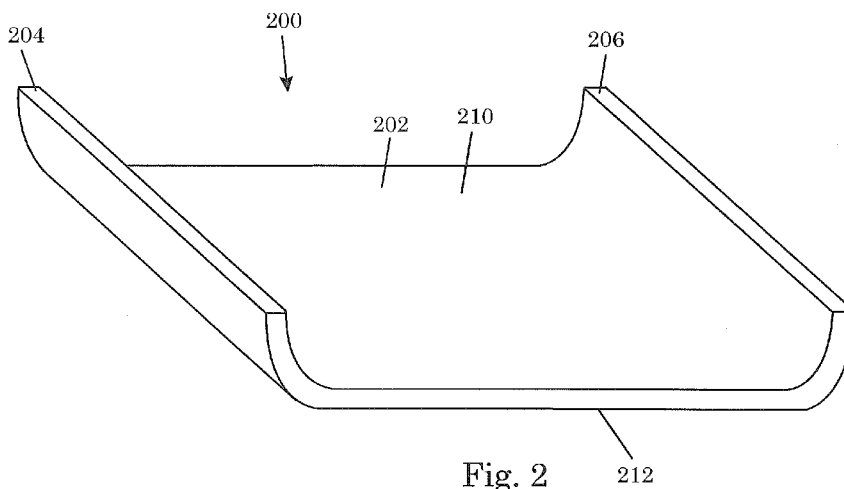

(57) Abstract: A cover glass article includes a glass body having a three-dimensional shape, an inside surface, and an outside surface. Each of the inside and outside surfaces has a surface roughness ( $R_a$ ) less than 1 nm and is free of indentations having diameters larger than 150  $\mu\text{m}$ .
