(57) **CLAIM**

The ornamental design for a hot glue gun with stand, as shown and described.

FIG. 1 is a front, left, and top perspective view of a glue gun of a hot glue gun with stand, showing my design.

FIG. 2 is a rear, right, and bottom perspective view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 3 is a front elevation view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 4 is a rear elevation view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 5 is a left side elevation view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 6 is a right side elevation view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 7 is a top plan view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 8 is a bottom plan view of the glue gun of the hot glue gun with stand of FIG. 1.

FIG. 9 is a front, right, and top perspective view of a stand of the hot glue gun with stand.

FIG. 10 is a front elevation view of the stand of the hot glue gun with stand of FIG. 9.

FIG. 11 is a left side elevation view of the stand of the hot glue gun with stand of FIG. 9.

FIG. 12 is a right side elevation view of the stand of the hot glue gun with stand of FIG. 9.

FIG. 13 is a top plan view of the stand of the hot glue gun with stand of FIG. 9.



FIG. 14 is a bottom plan view of the stand of the hot glue gun with stand of FIG. 9.
































