DESCRIPTION

FIG. 4 is a left view of the aircraft instrument panel of FIG. 1;

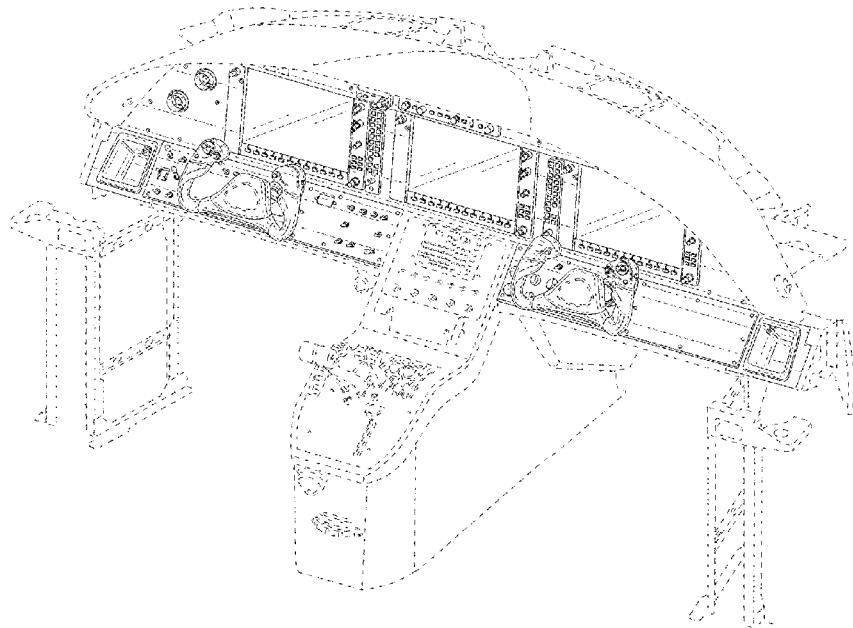
FIG. 5 is a right view of the aircraft instrument panel of FIG. 1;

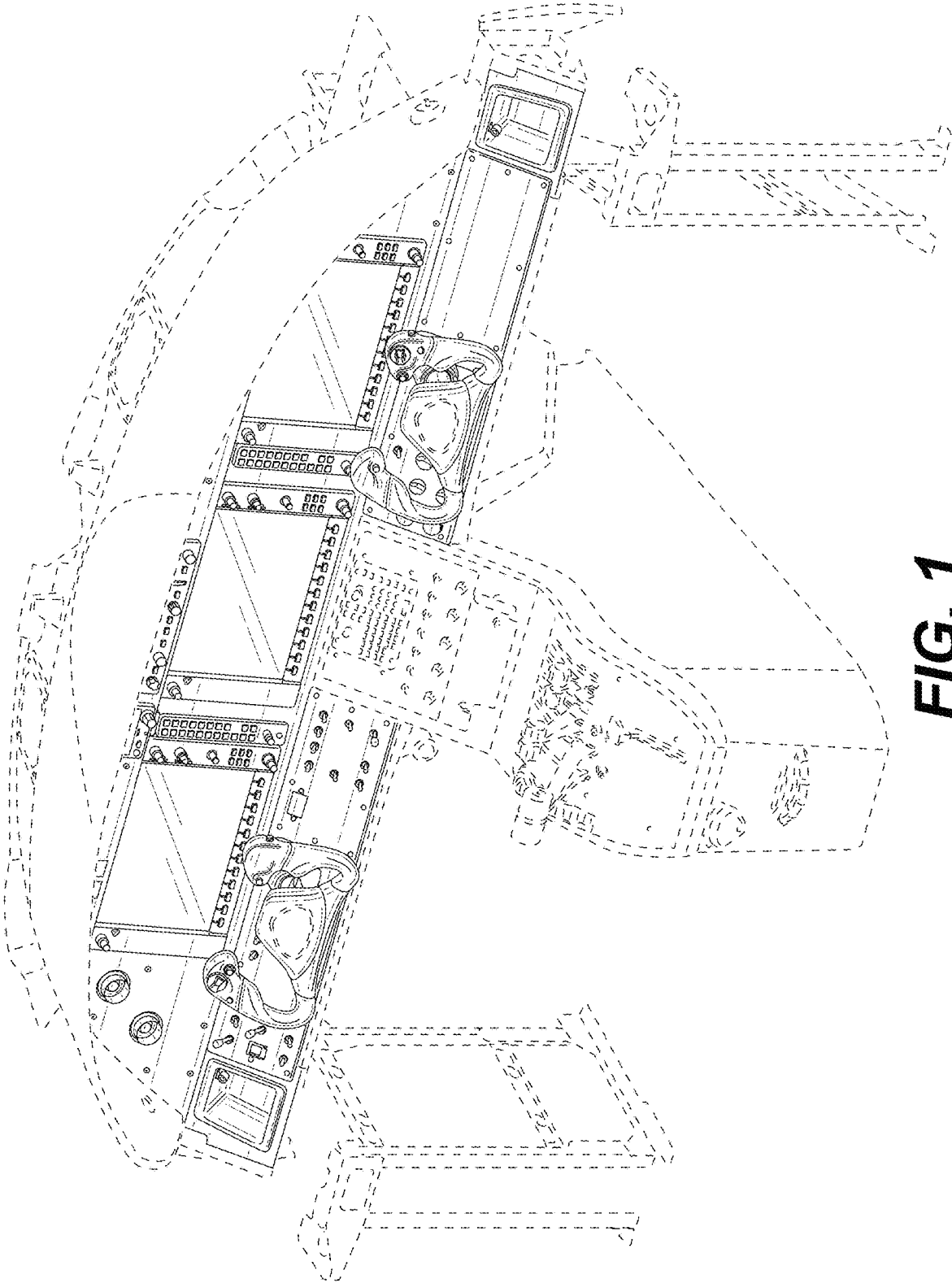

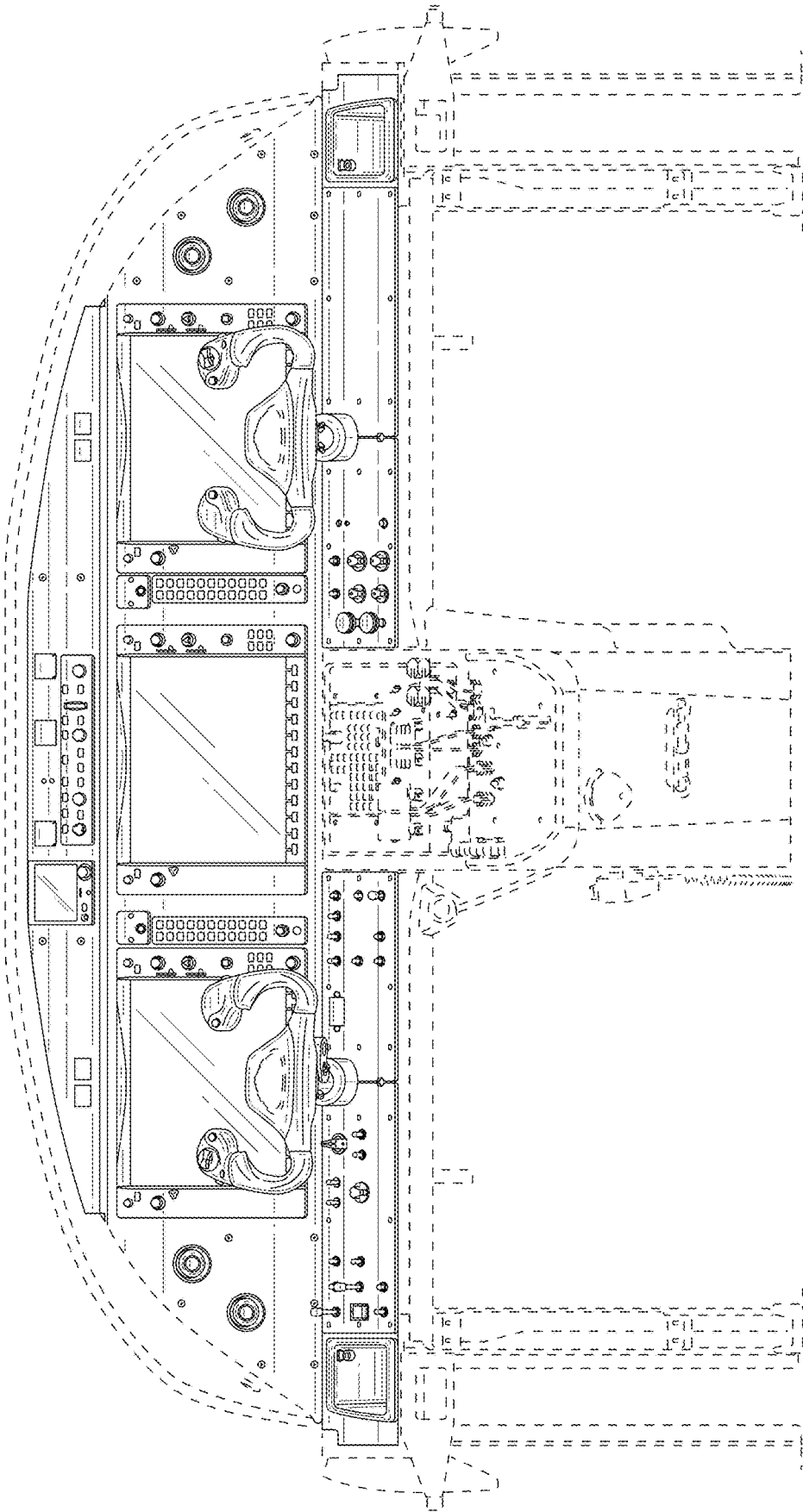

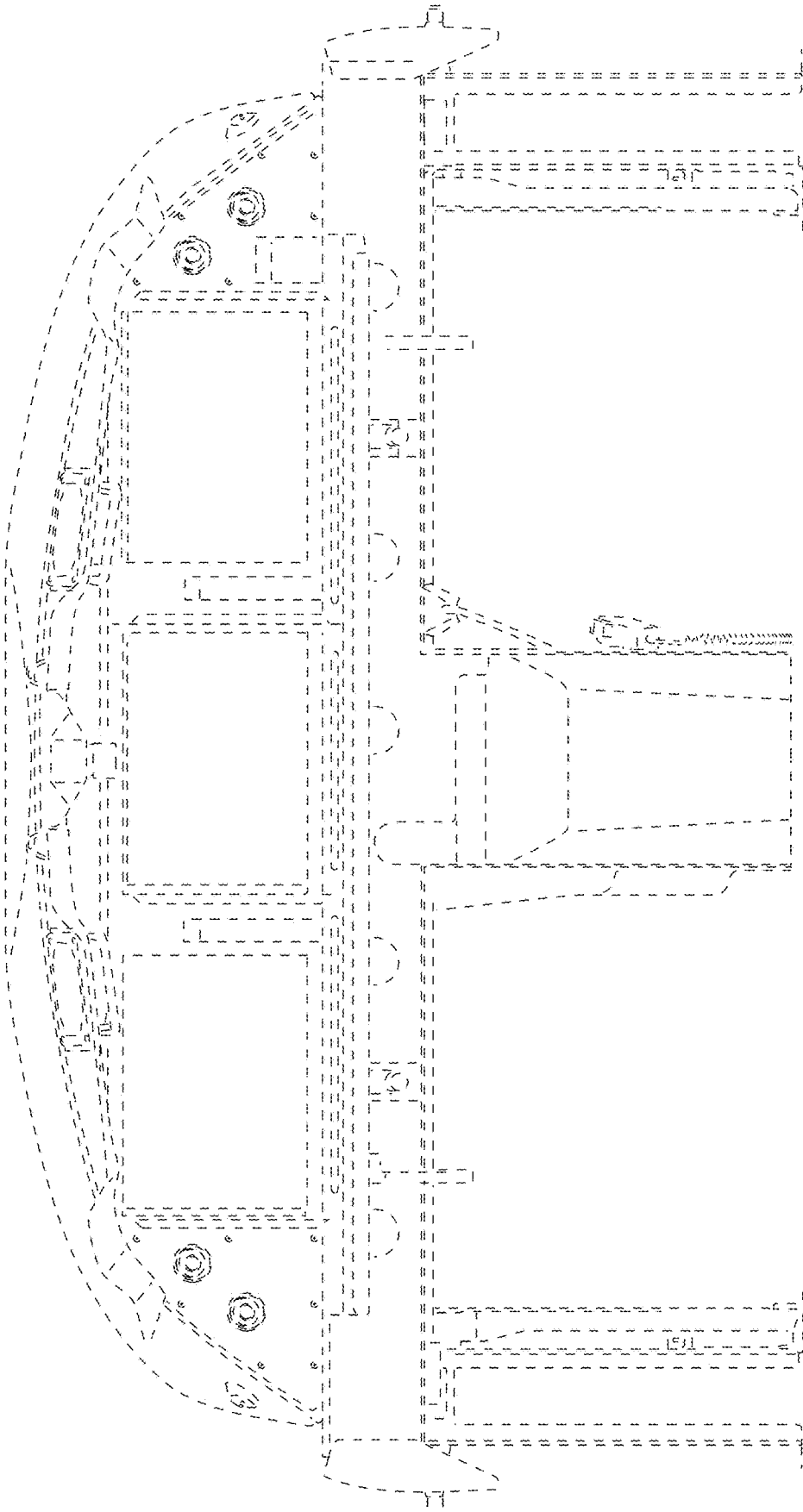

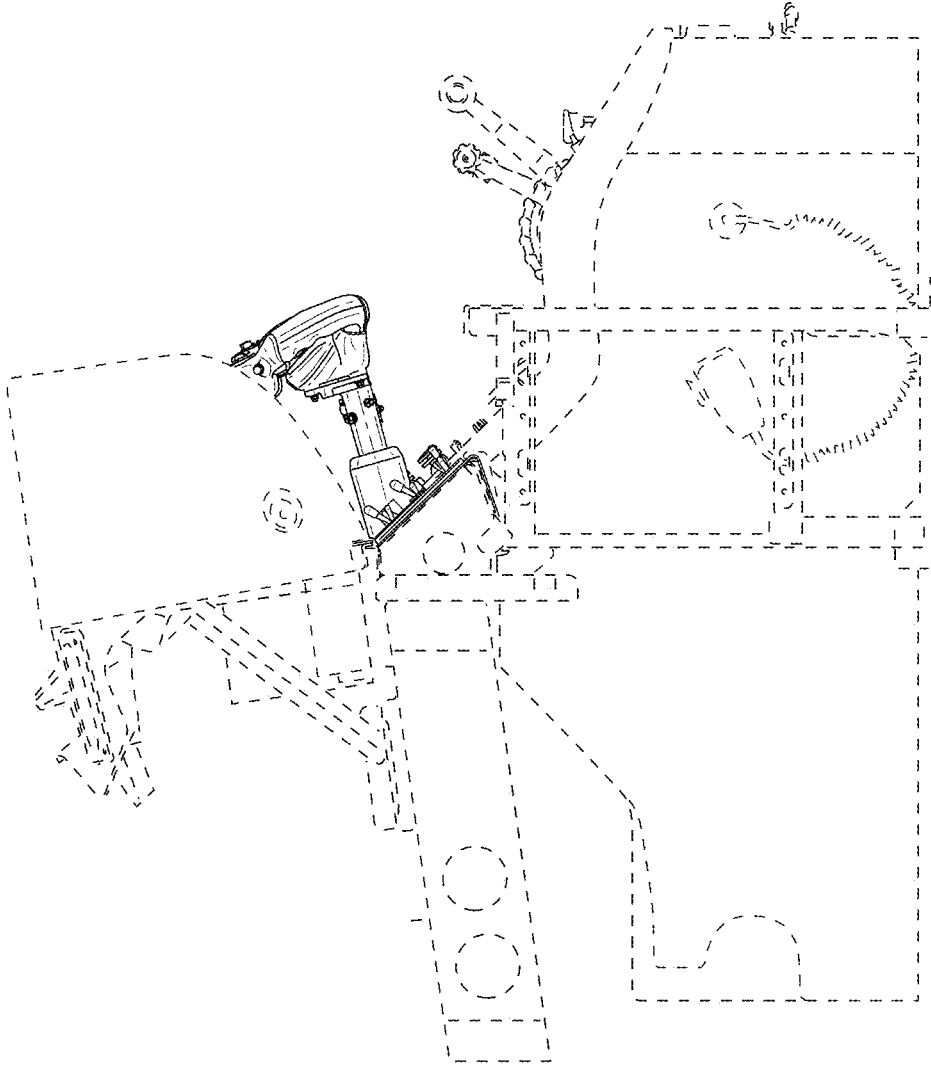

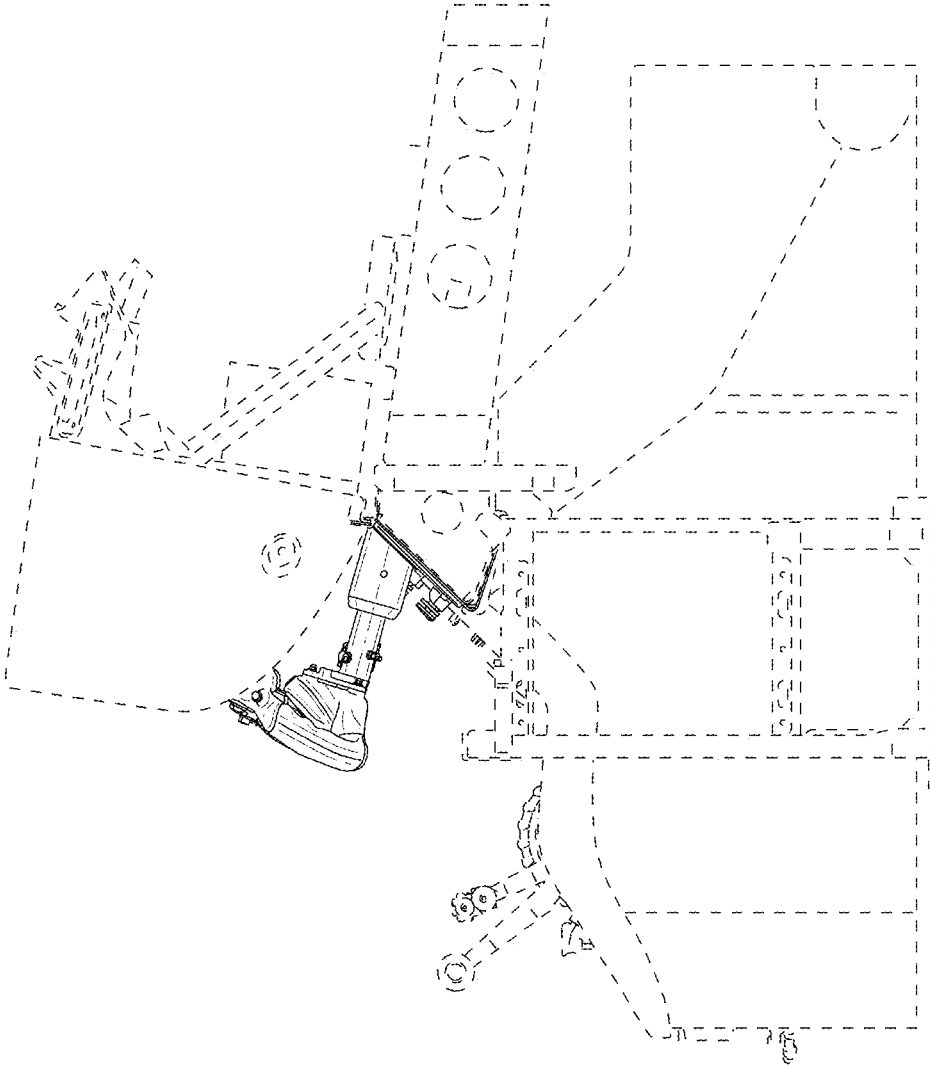

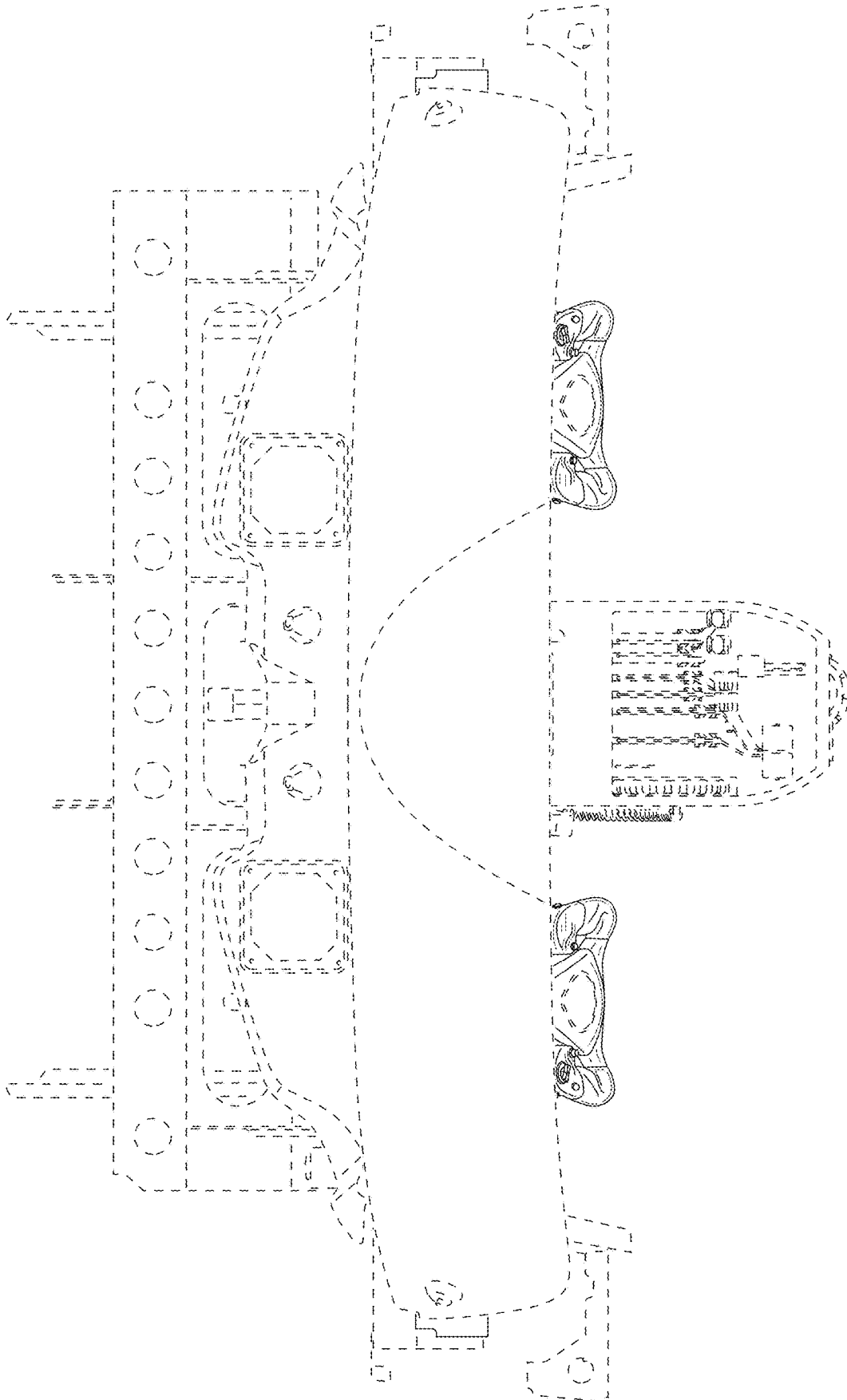

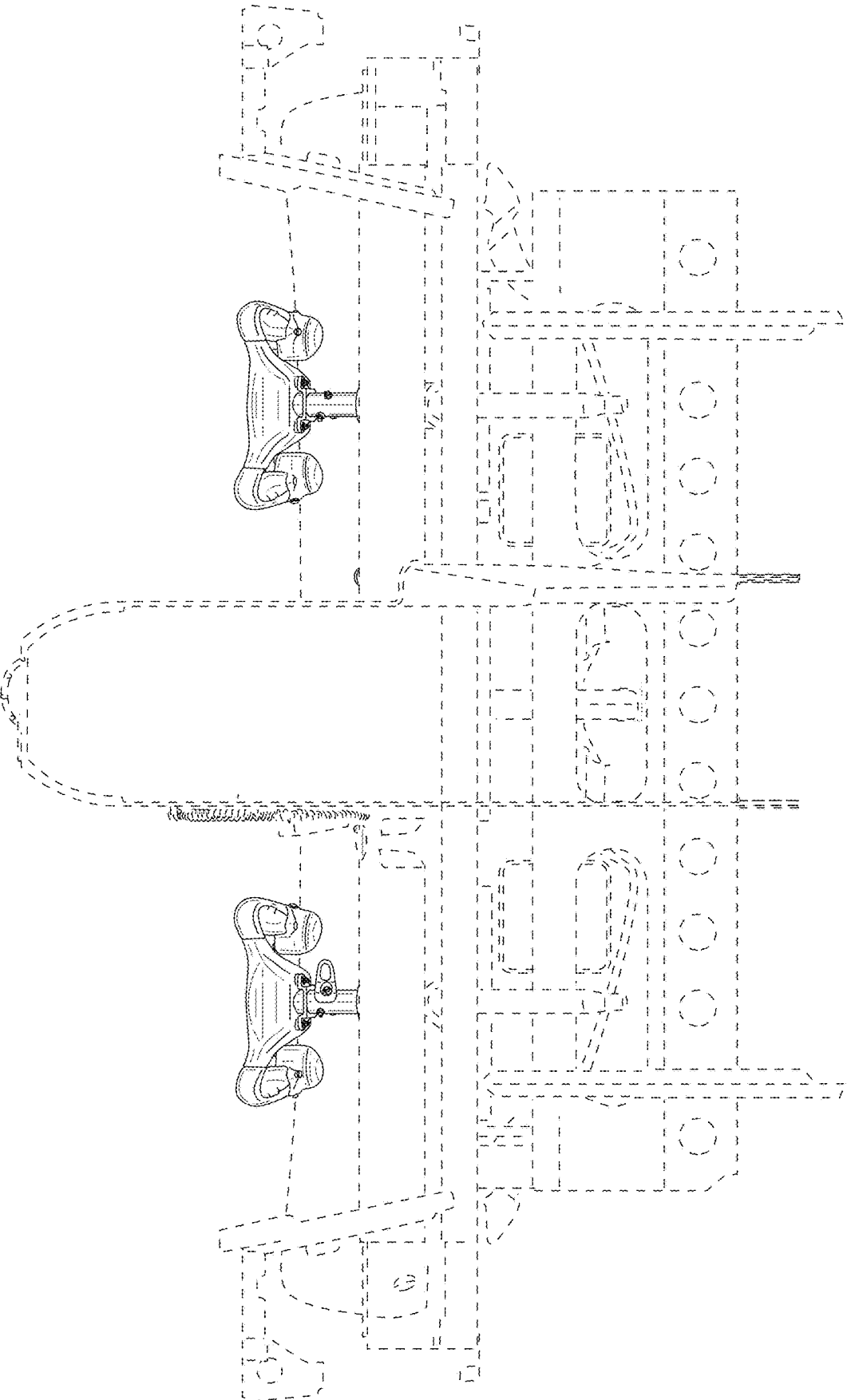
