(57) **CLAIM**

The ornamental design for a jewelry display, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front right side perspective view of the jewelry display showing my new design which is also a mirror image of the left top perspective view thereof;  
 FIG. 2 is a top front right side perspective view of a first alternative embodiment which is also a mirror image of the left top perspective view thereof;  
 FIG. 3 is a top front right side perspective view of a second alternative embodiment which is also a mirror image of the left top perspective view thereof; and,  
 FIG. 4 is a rear view of FIG. 1, the rear views of FIGS. 2 and 3 are identical to this rear view except for differences in width.







