(57) **CLAIM**

We claim the ornamental design for a washing machine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a washing machine showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged view of the encircled portion in FIG. 1; and,
FIG. 9 is an enlarged view of the encircled portion in FIG. 6.
The broken lines in the figures show portions of the washing machine which form no part of the claimed design. The dash-dot-dot broken lines encircling portions of the claimed design that are illustrated in enlargements form no part of the claimed design.


















