
(57) **CLAIM**

The ornamental design for a ballpoint pen, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of front, top and right side of a ballpoint pen showing my new design;
FIG. 2 is a front view thereof, the rear view being a mirror image thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is an exploded front view thereof; and,
FIG. 8 is an exploded top view thereof.
The broken lines shown are included for the purpose of illustrating unclaimed portions of the ballpoint pen that form no part of the claimed design.










