(57) **CLAIM**

The ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a television receiver, showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a rear perspective view thereof;

FIG. 9 is an enlarged view of the portion A encircled in FIG. 1;



FIG. 10 is an enlarged view of the portion B encircled in FIG. 2;

FIG. 11 is an enlarged view of the portion C encircled in FIG. 8;

FIG. 12 is another enlarged view of the portion C encircled in FIG. 8, in which a camera portion of the claimed design is in a retracted position to illustrate an example environment; and, FIG. 13 is an enlarged view of the portion D encircled in FIG. 7.

The broken lines are for illustrative purposes only and form no part of the claimed design. The shade lines in the figures show contour and not surface ornamentation. The dot-dash broken lines encircling portions of the claimed design that are illustrated in enlargements form no part of the claimed design. The diagonal lines in the FIGS. 1, 2, 9, and 10 represent a reflective surface.
























