(57) **CLAIM**

The ornamental design for a cylindrical camera, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a cylindrical camera;

FIG. 2 is a bottom, back and left side perspective view of the cylindrical camera shown in FIG. 1;

FIG. 3 is a front view of the cylindrical camera shown in FIG. 1;

FIG. 4 is a back view of the cylindrical camera shown in FIG. 1;

FIG. 5 is a left side view of the cylindrical camera shown in FIG. 1;

FIG. 6 is a right side view of the cylindrical camera shown in FIG. 1;

FIG. 7 is a top view of the cylindrical camera shown in FIG. 1;



FIG. 8 is a bottom view of the cylindrical camera shown in FIG. 1;




















