FIG. 10 is an additional top perspective view of a front cover for an engine.

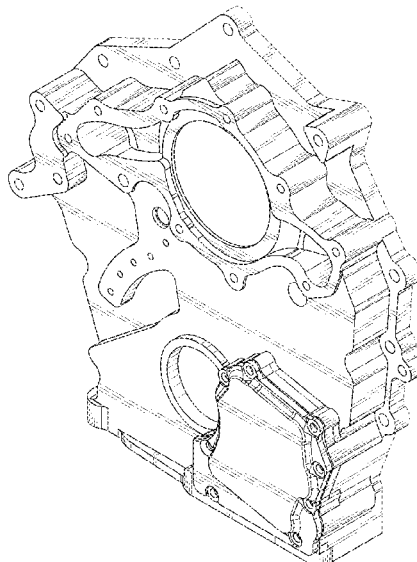

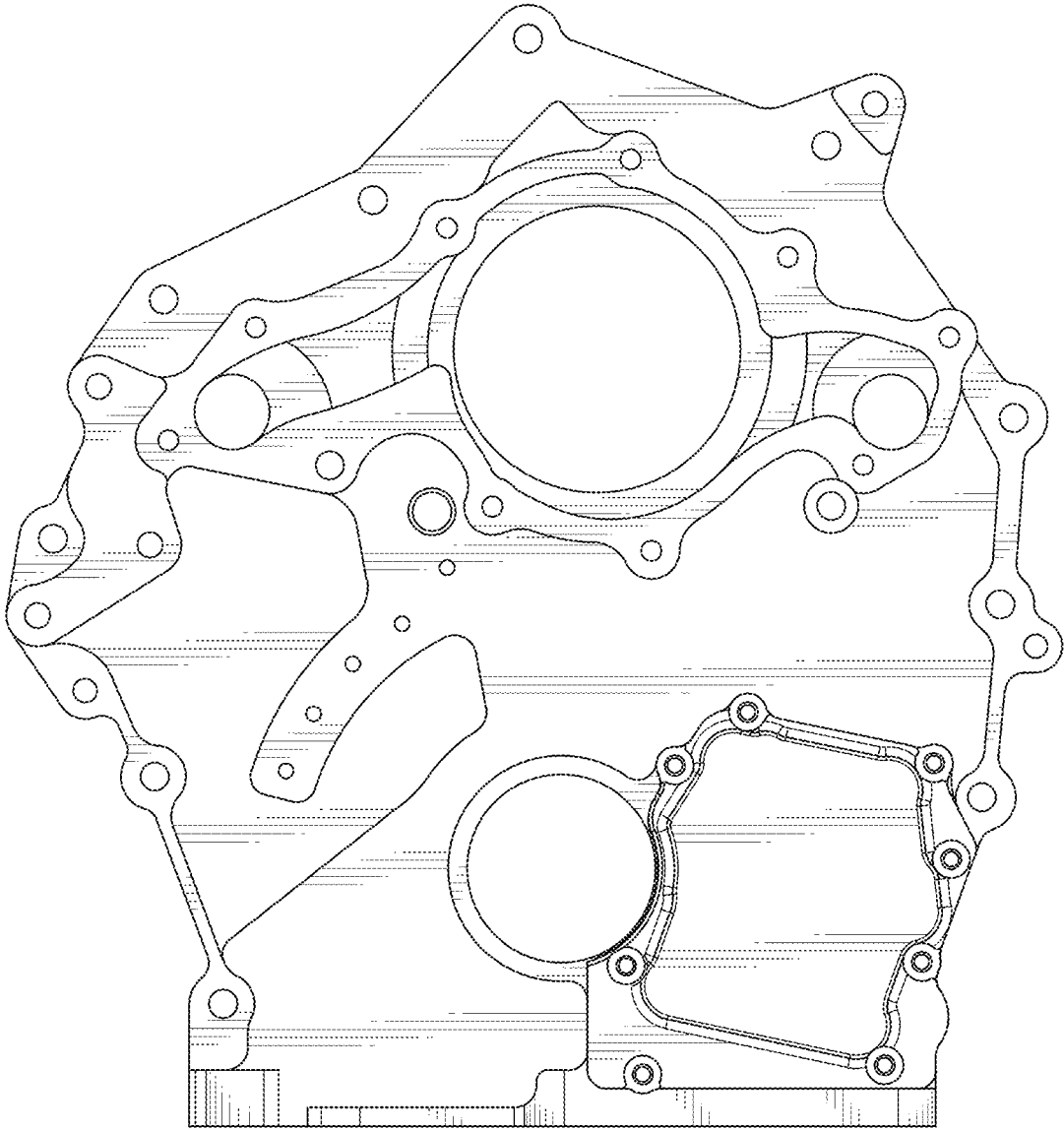

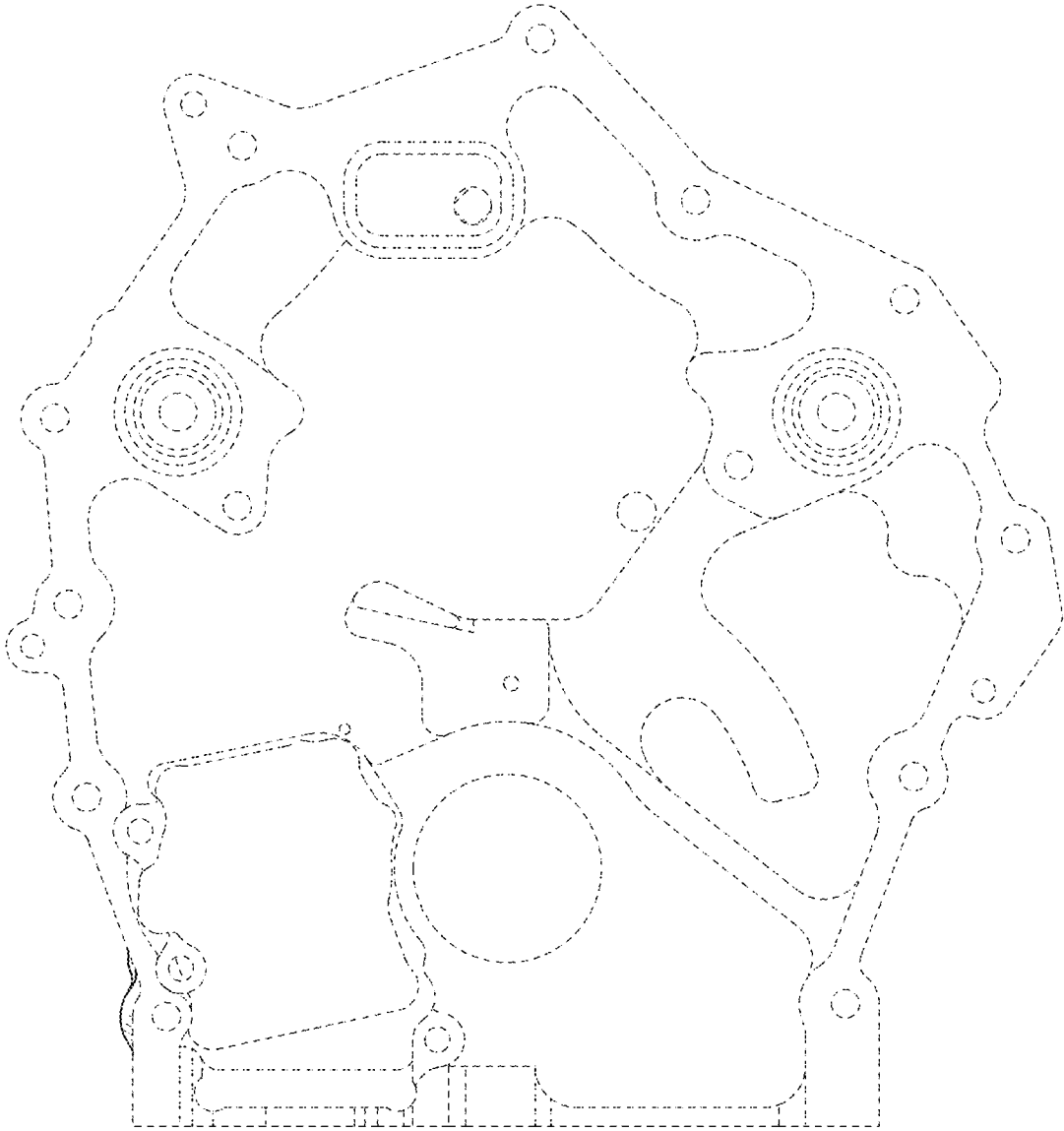

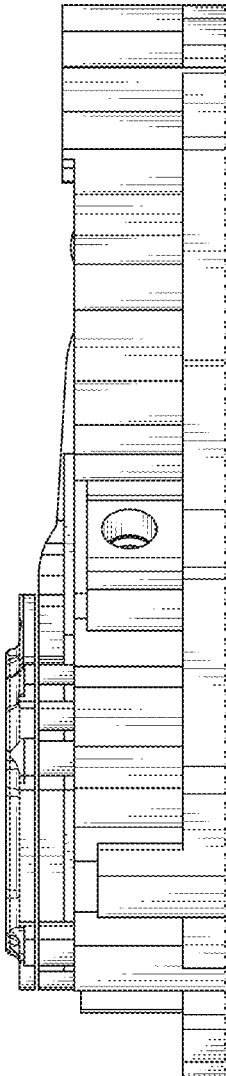

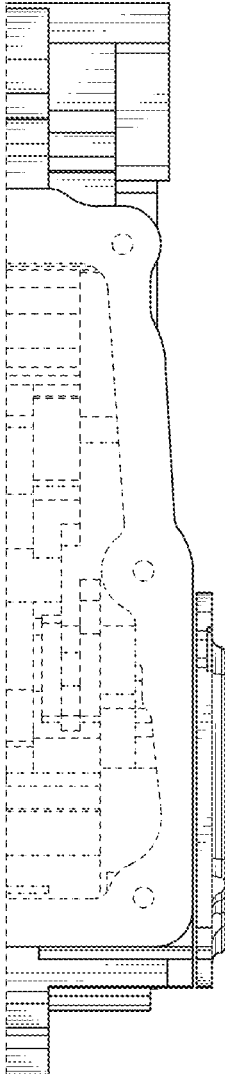

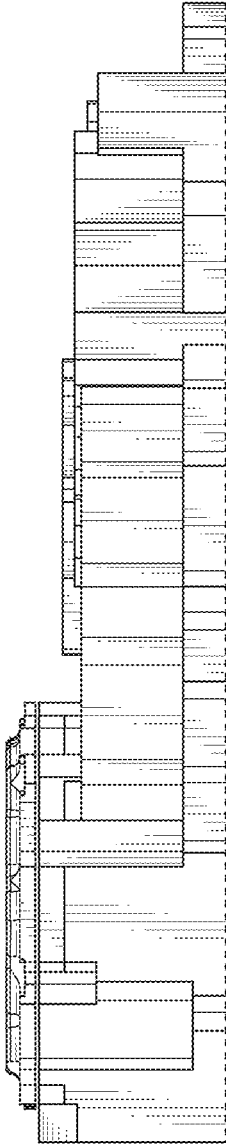

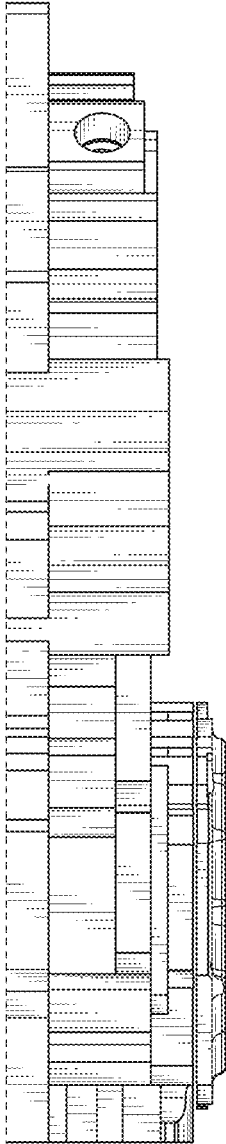

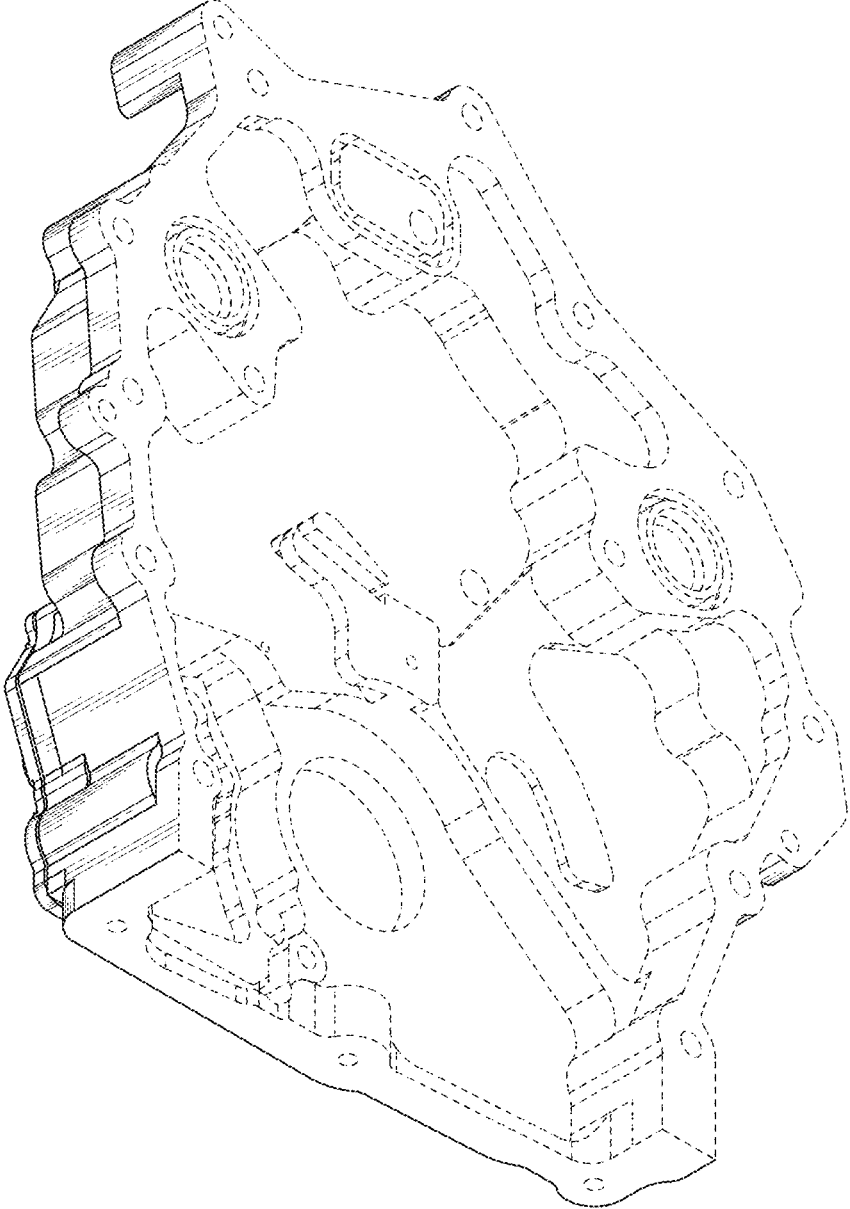

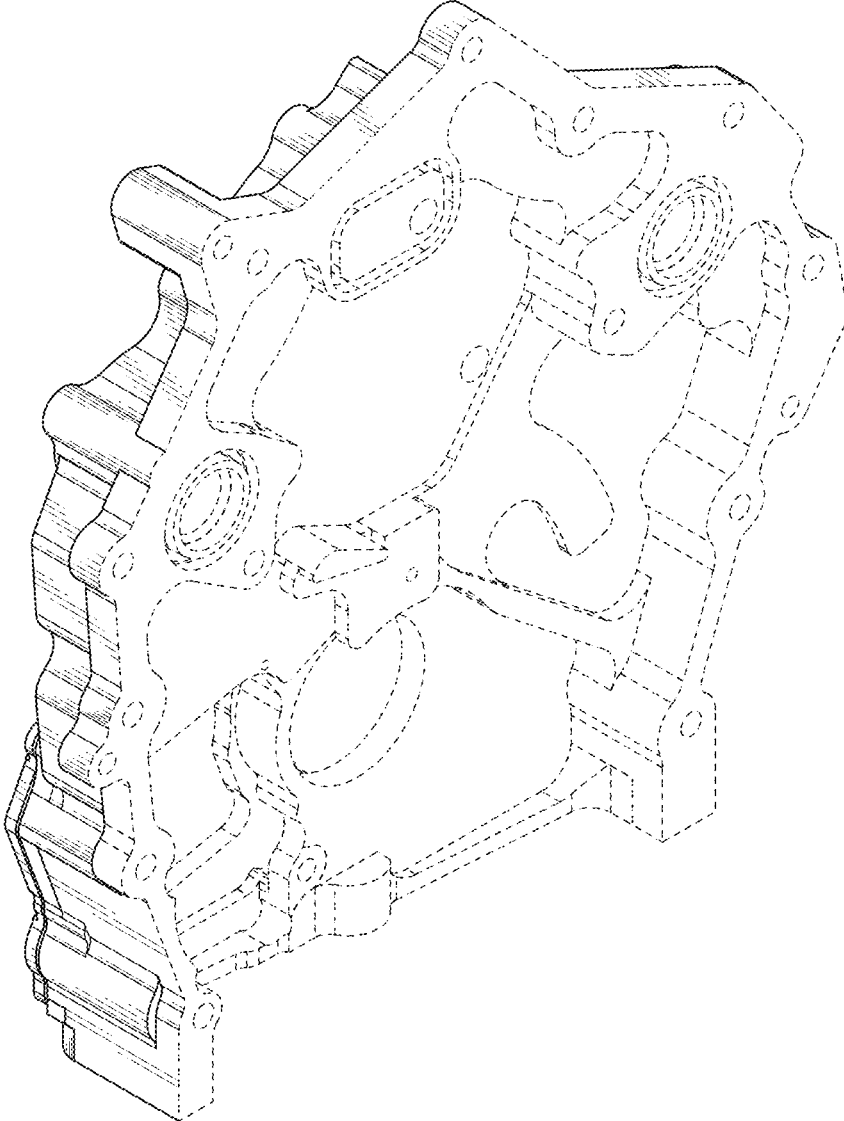

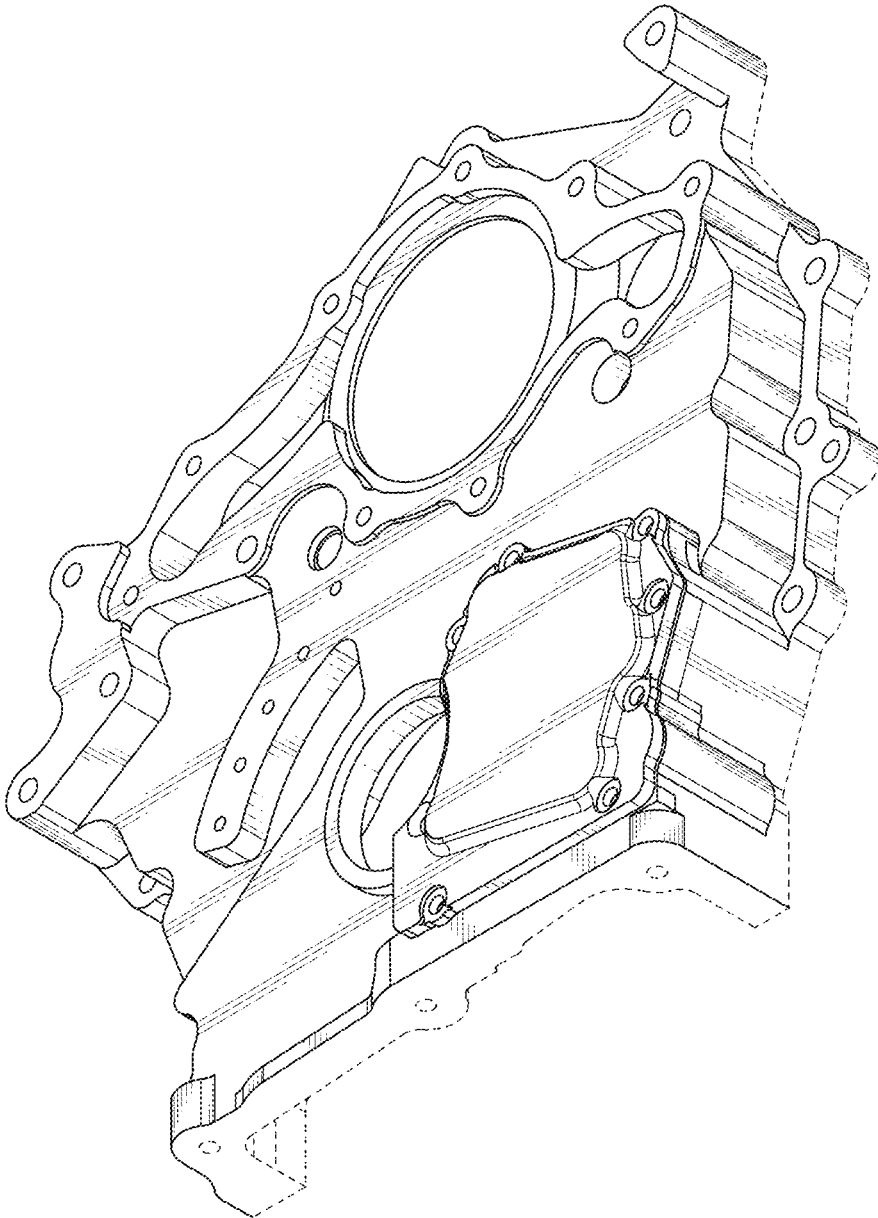

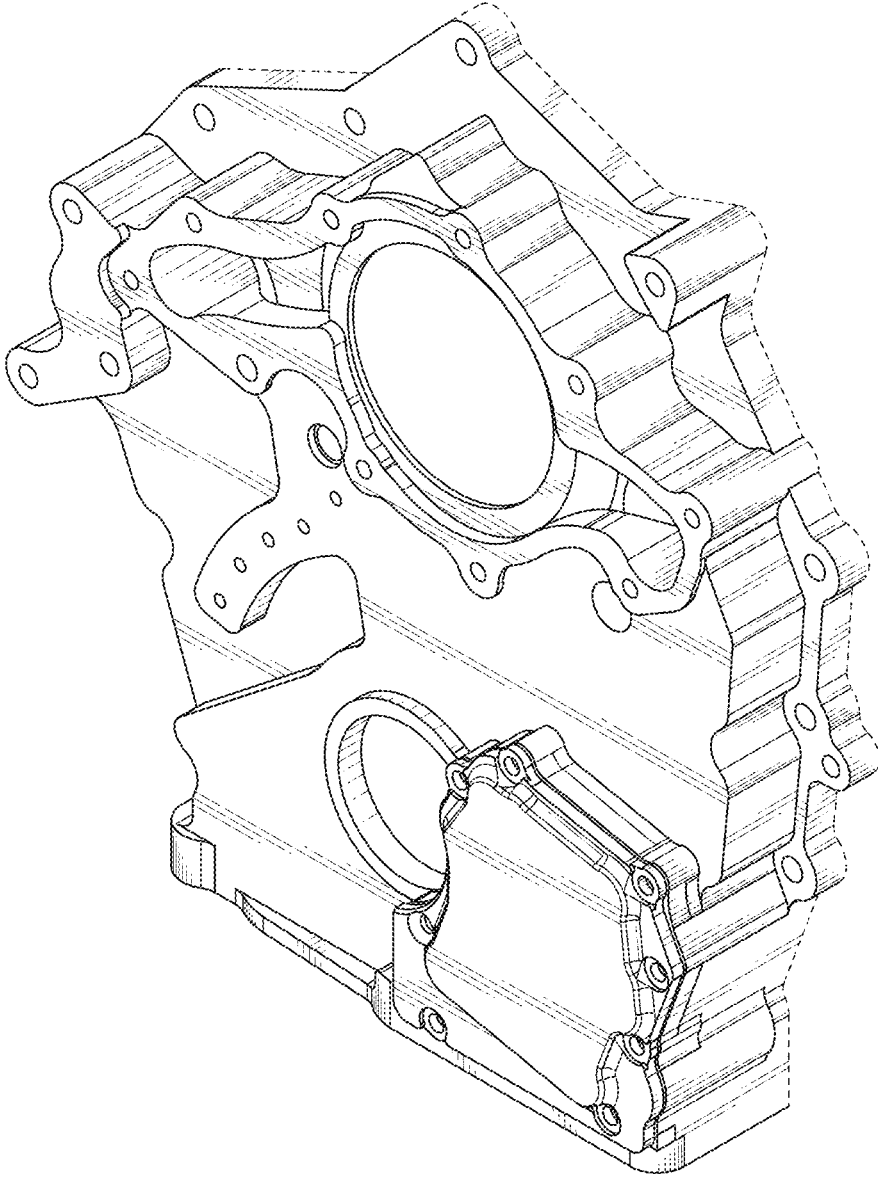
