The ornamental design for “bristles for hairbrush,” as shown and described.

DESCRIPTION

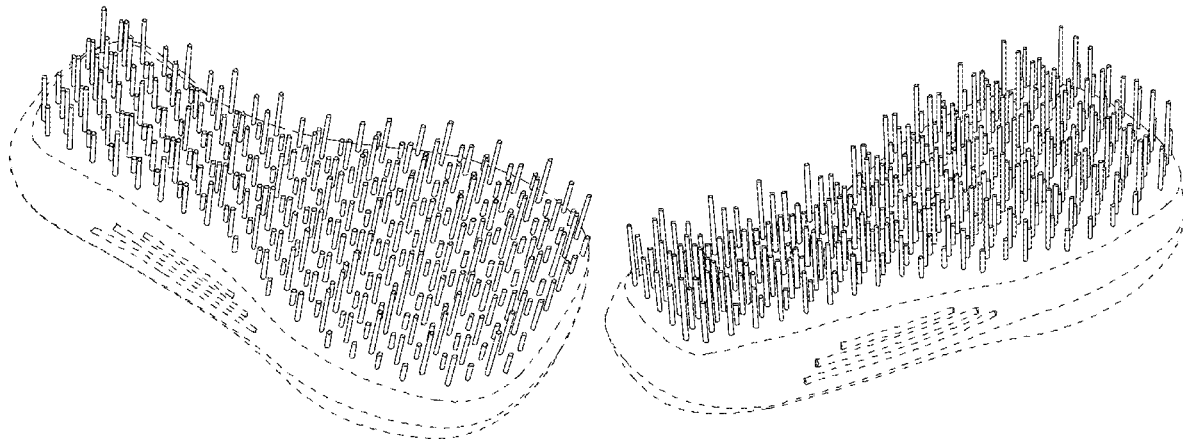
FIG. 1 is a first side perspective view of the bristles for hairbrush in accordance with the present design; FIG. 2 is a second side perspective view thereof; FIG. 3 is a first top perspective view thereof; FIG. 4 is a second top perspective view thereof; FIG. 5 is an end elevation view thereof; FIG. 6 is a side elevation view thereof; FIG. 7 is a third top perspective view thereof; and, FIG. 8 is a top plan view thereof.
Novelty resides in the particular configuration of the bristle arrangement.

Broken lines and unshaded portions contained within broken lines illustrate elements of the bristles for hairbrush that form no part of the claimed design.

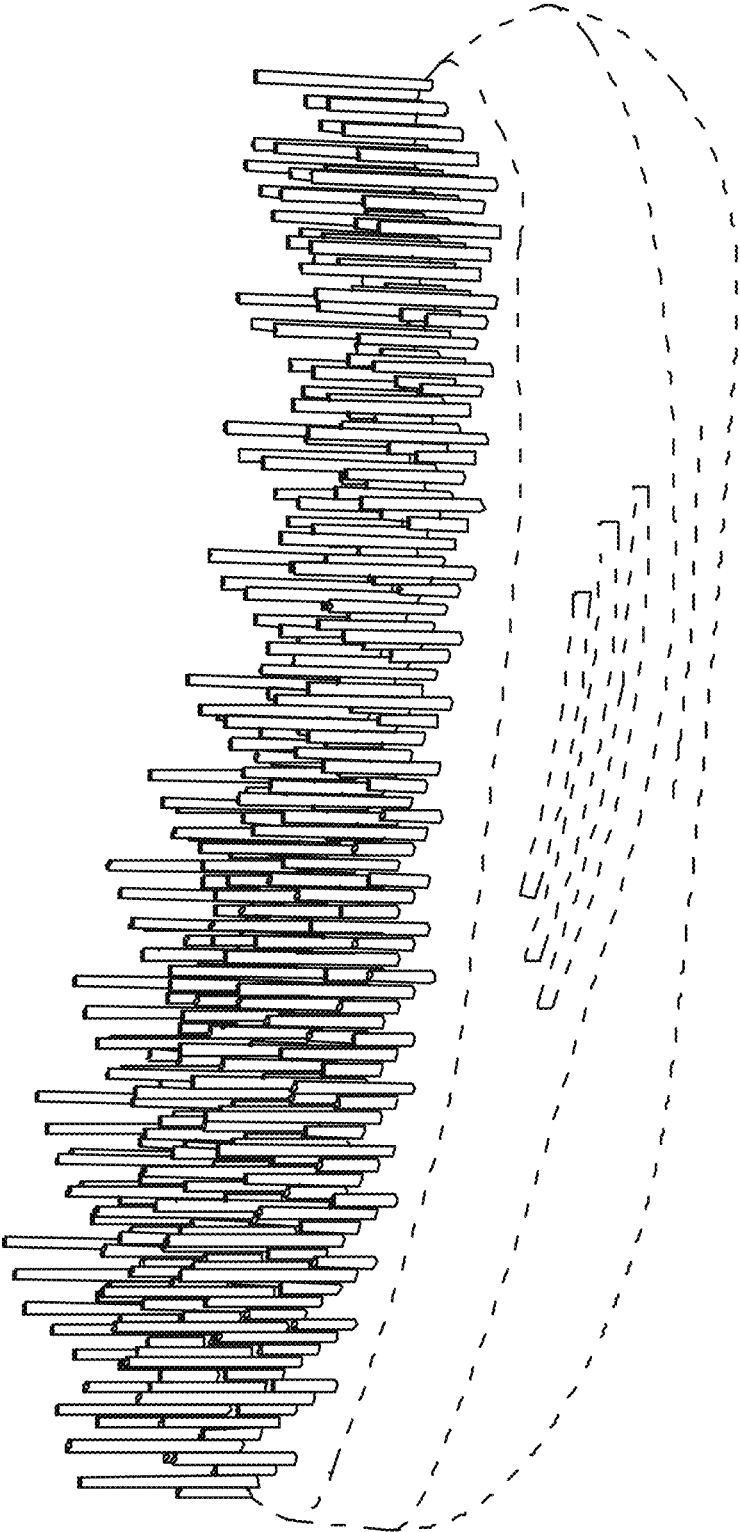

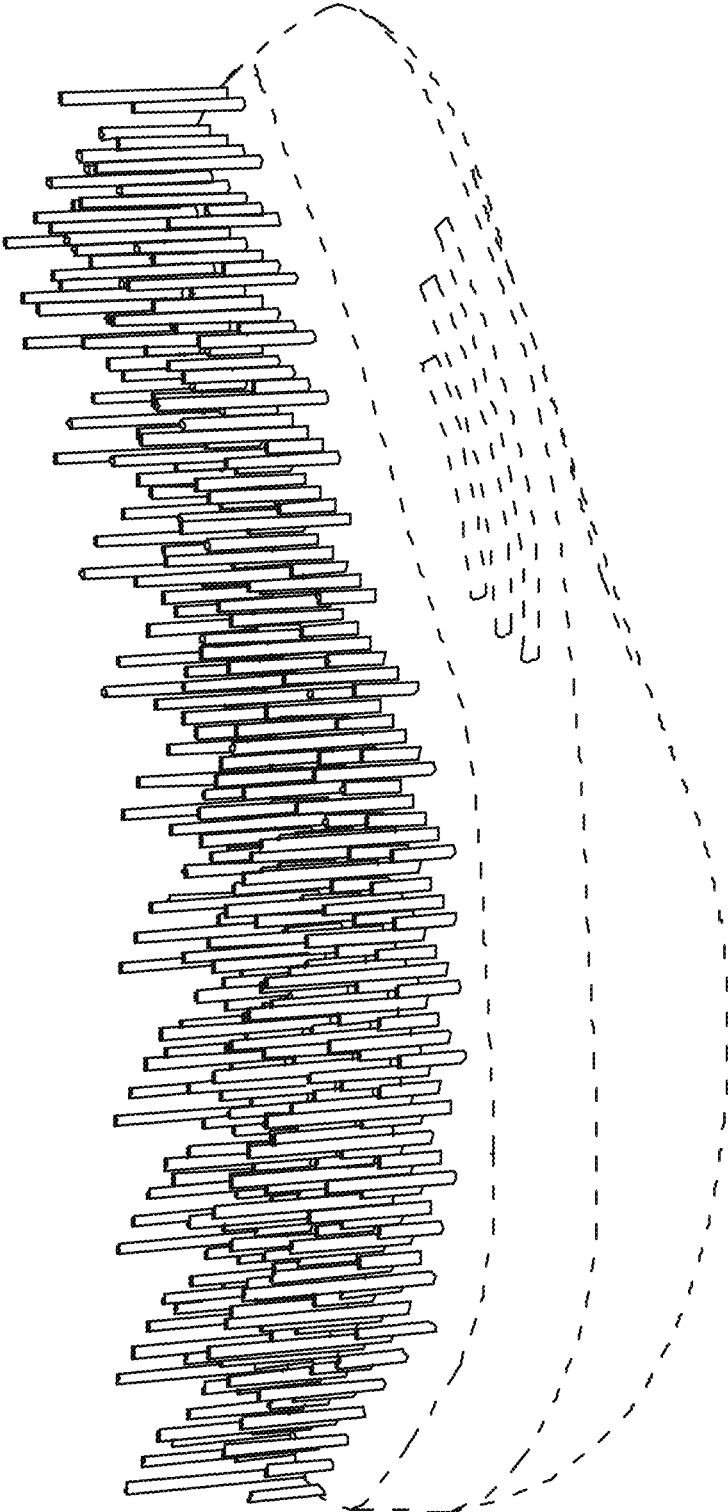

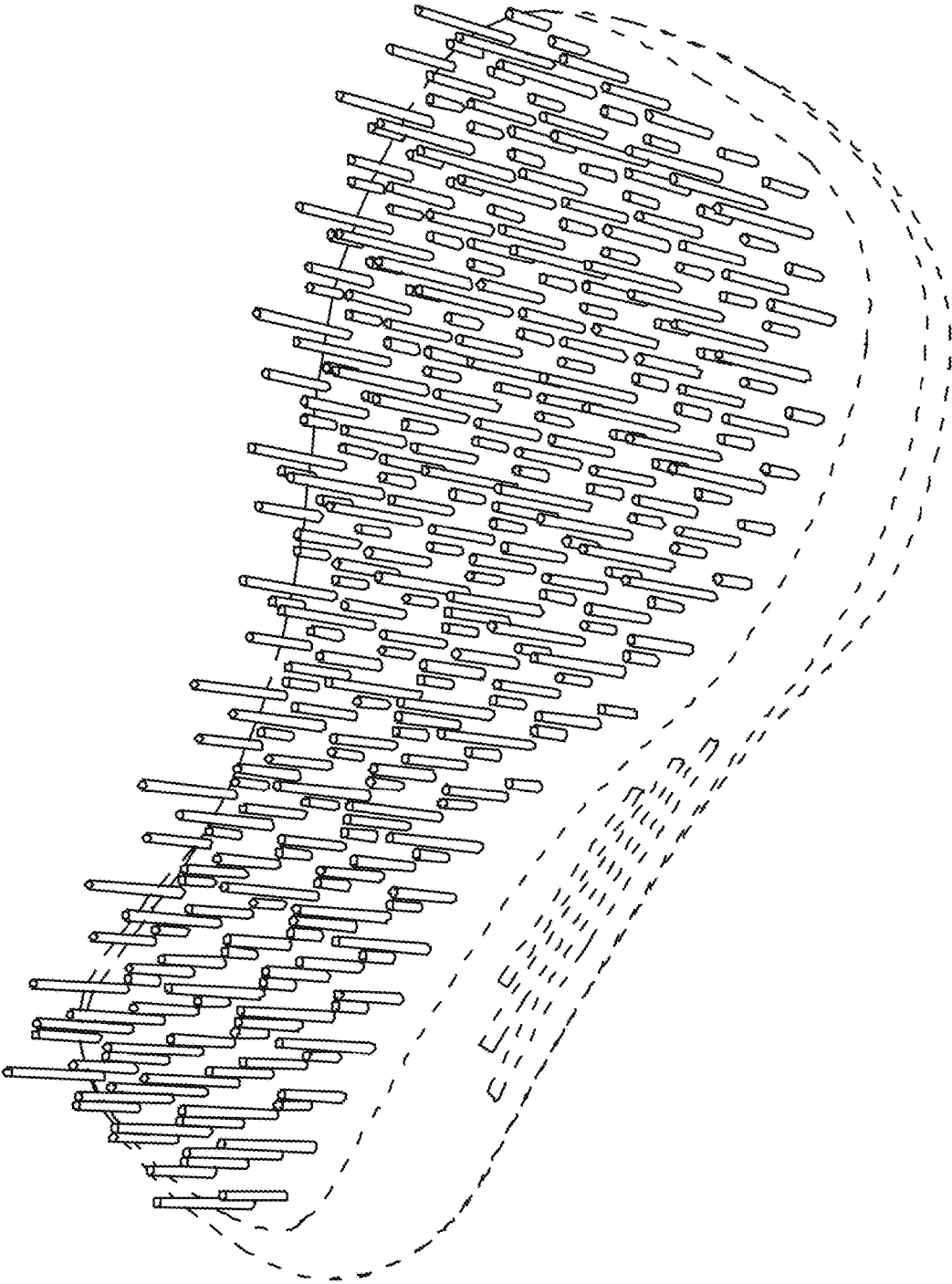

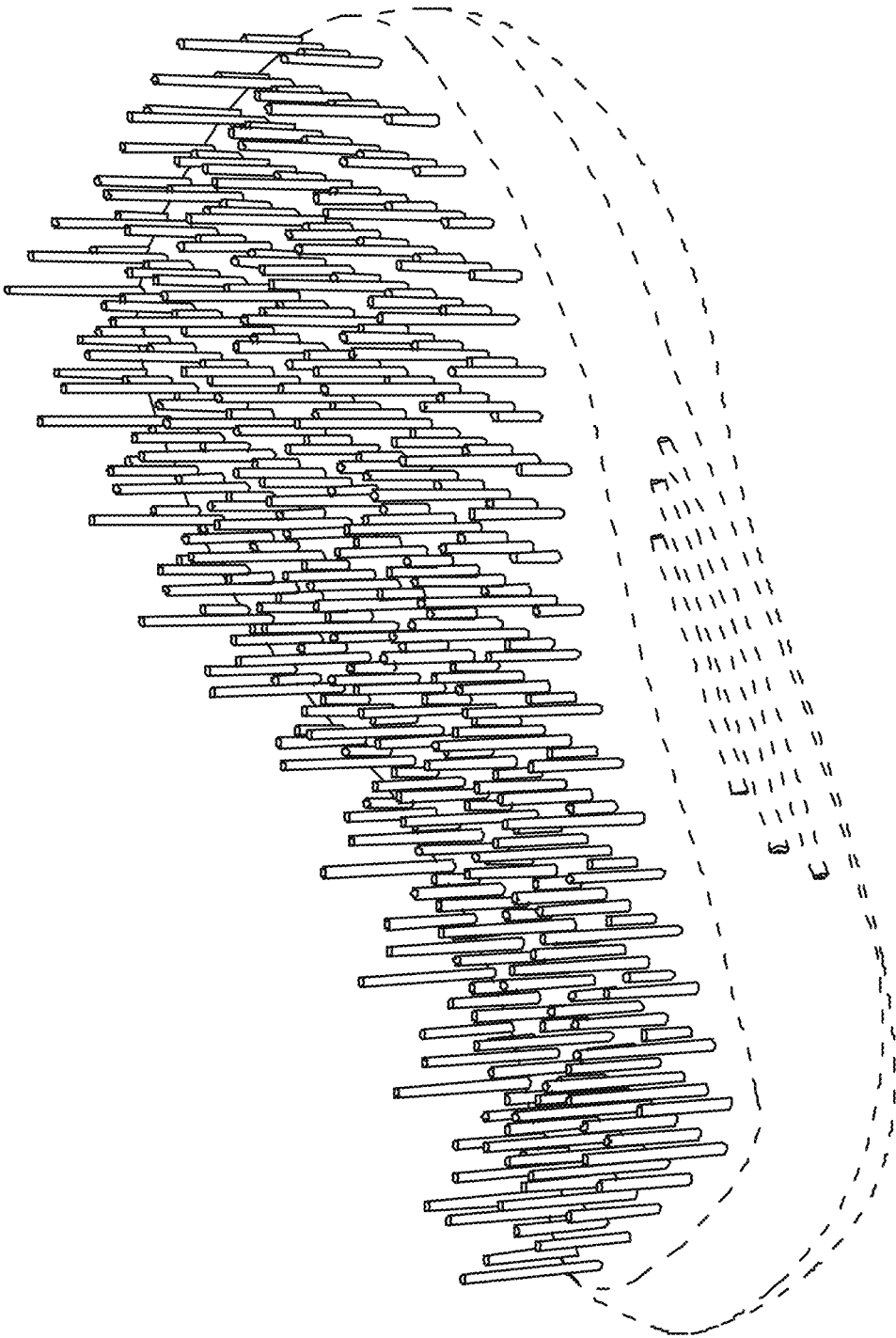

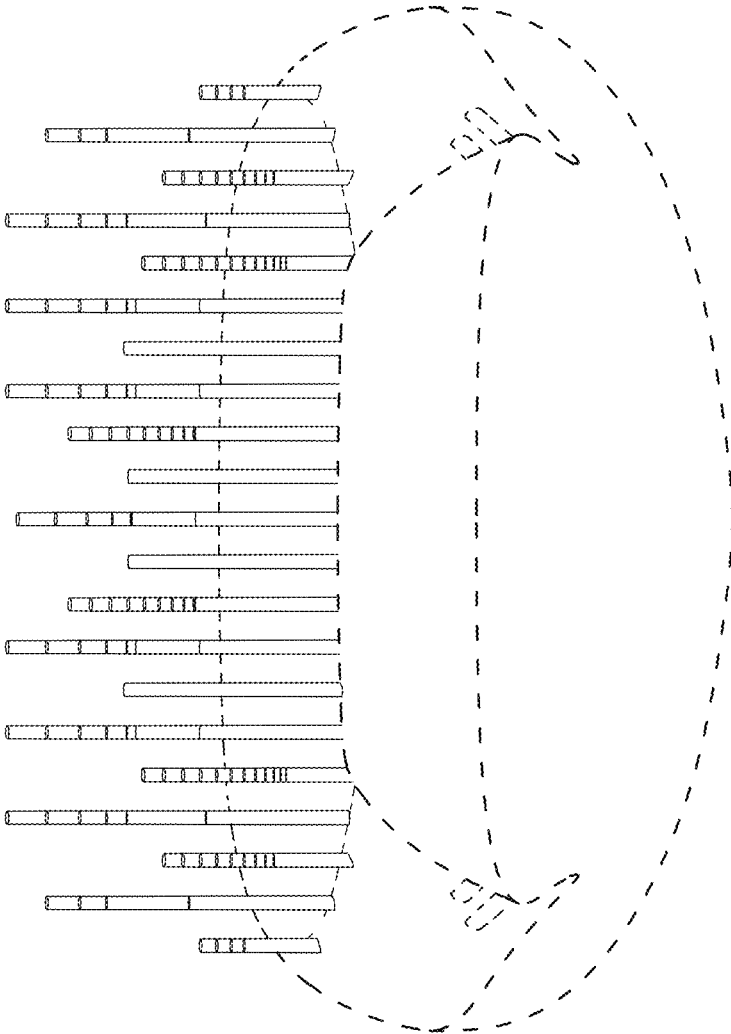

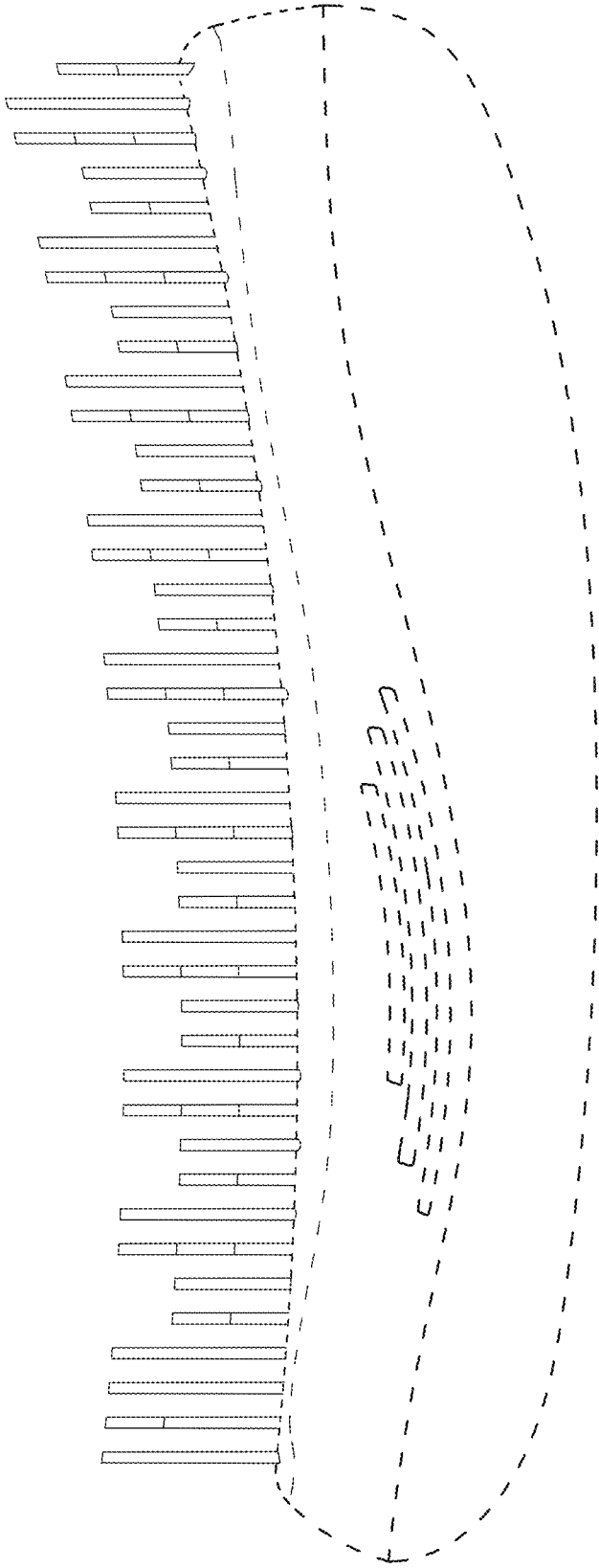

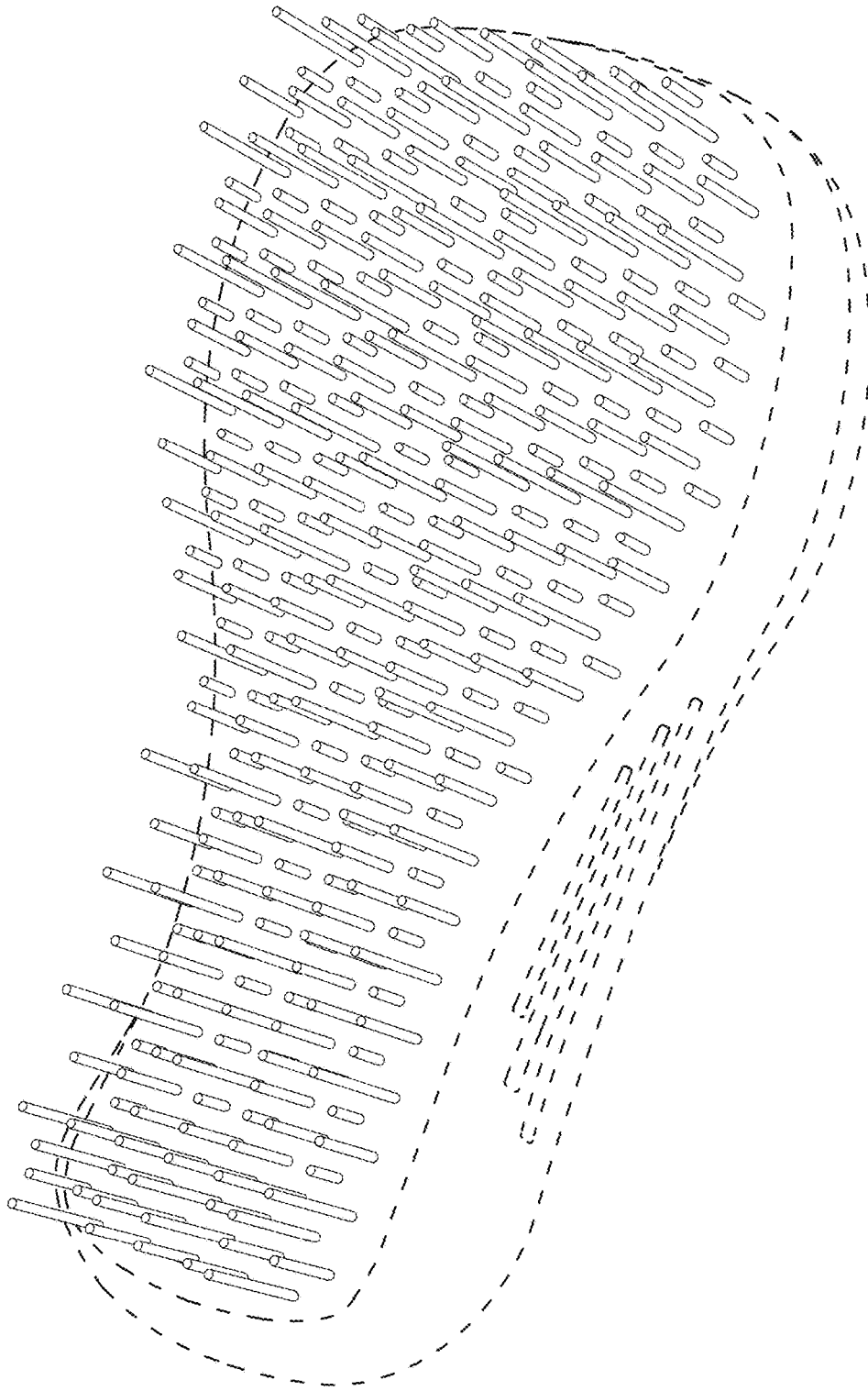

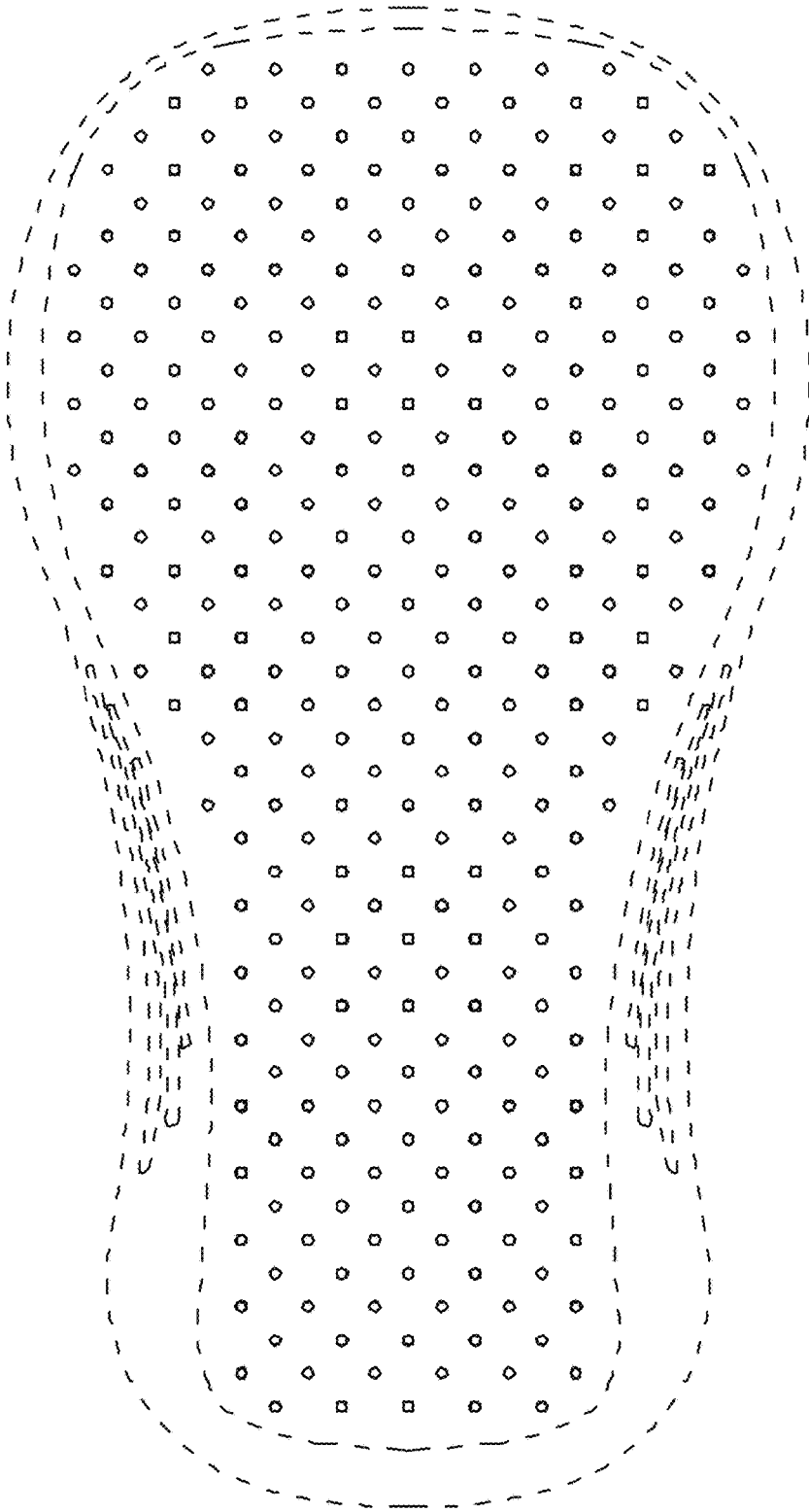
