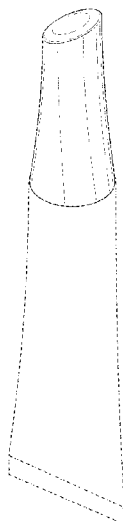
(57) **CLAIM**

The ornamental design for a cap for cosmetic container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the cap for cosmetic container showing my new design; FIG. 2 is front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; and, FIG. 6 is a top view thereof. The dashed lines in FIGS. 1-6 represent environmental structure and form no part of the claimed design. 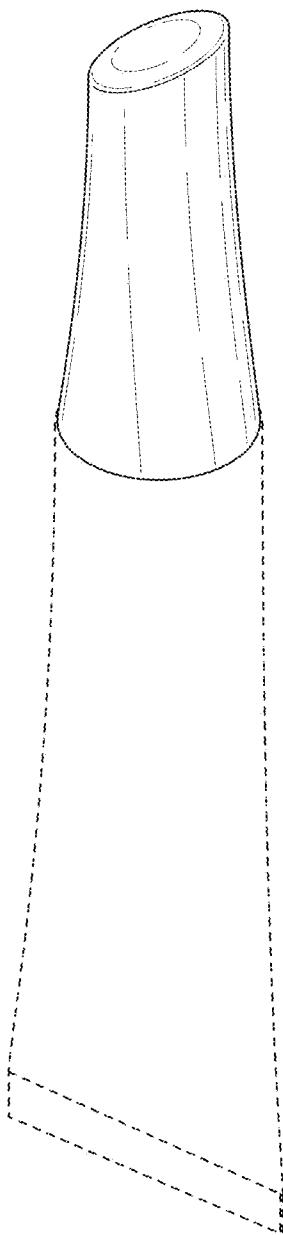

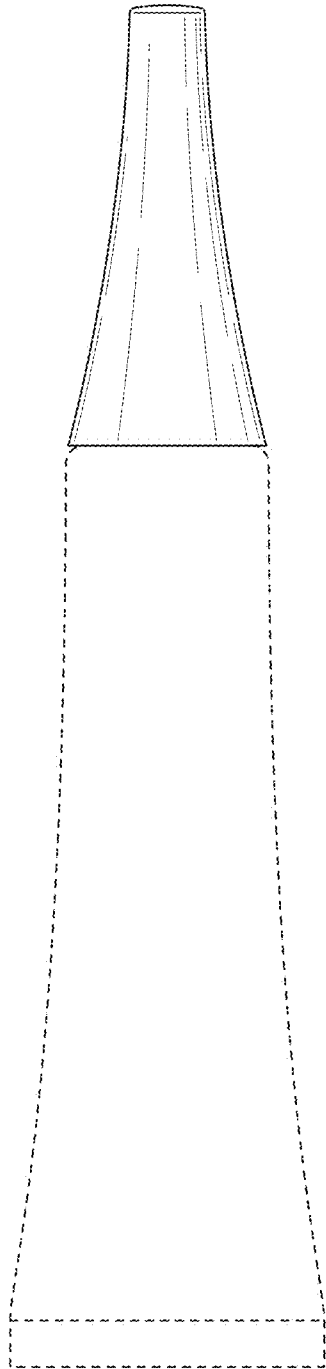

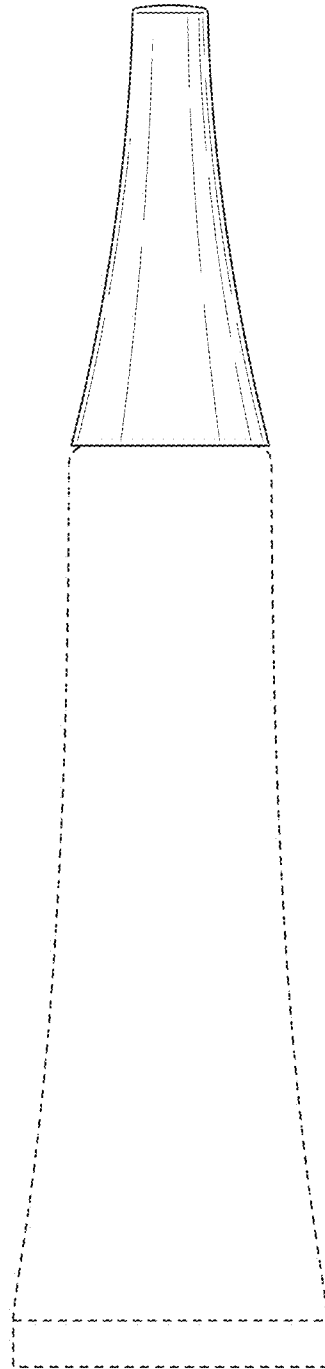

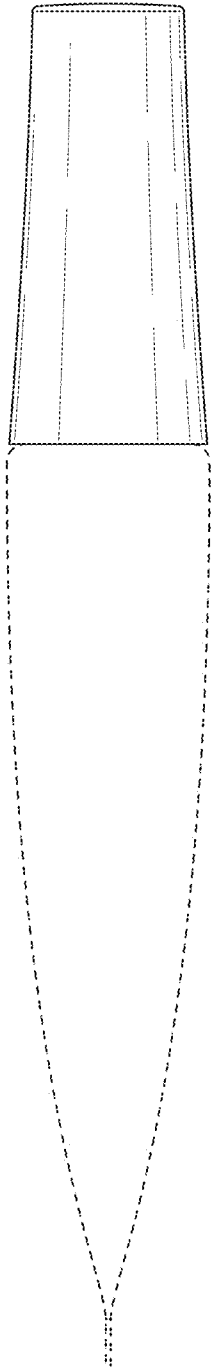

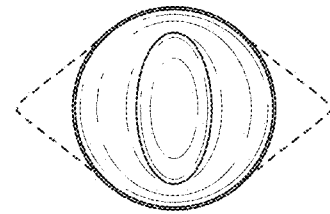
